ADOPTED AT THE MEETING OF THE GENERAL COUNCIL OF MFUCTO held in Mumbai on Sunday, the 24 th January 2010

१. "मानव संसाधन विकास विभाग (एच.आर.डी.) मंत्रालय आणि विद्यापीठ अनुदान आयोग (यु.जी.सी.) जे आदेश काढील त्याचे महाराष्ट्र शासन पालन करील." "विद्यापीठ अनुदान आयोगाकडून शिफारस आल्यानंतर, केंद्र सरकारकडून आदेश दिले जातील त्या आदेशांचे पालन केले जाईल." अशी सुस्पष्ट आश्वासने⁹ दिनांक २९ डिसेंबर, २००८ रोजी विधानपरिषद सभागृहात देण्यात आलीत व त्याप्रमाणे "दि. २३ जुलै २००९ च्या मंत्रिमंडळाच्या बैठकीत निर्णय घेण्यात आला. मंत्रिमंडळाच्या सदर निर्णयानुसार सुधारित वेतन संरचनेबाबत दिनांक 9२ ऑगस्ट २००९ रोजी शासननिर्णय^र निर्गमित करण्यात आला आहे." असे आता मा. उच्च शिक्षण मंत्र्यांनी दिनांक २२ डिसेंबर २००९ रोजी विधानपरिषदेत केलेल्या निवेदनात नमूद केलेले आहे. १२ ऑगस्ट २००९ च्या या शासननिर्णयाप्रमाणे विद्यापीठ अनुदान आयोगाच्या सर्व वेतनश्रेण्या आश्वासित प्रगतीयोजनेसह (CAS) राज्यात महाराष्ट्र शासनाने जशाच्या तशा लागू केल्या, असे असतांना एका बेजबाबदार अधिकाऱ्याने दिनांक २४ जुलै २००९ रोजी आंदोलनकर्त्या महाराष्ट्र प्राध्यापक महासंघाच्या अध्यक्षांना एक पत्र लिहन असे कळविले की, "राज्य मंत्रिमंडळाने २३ जुलै २००९ रोजी विचार करुन राज्य शासकीय कर्मचाऱ्यांप्रमाणे दिनांक १ जानेवारी २००६ पासून सहावा वेतन आयोग लागू करण्याबाबत निर्णय घेतला आहे." राज्य शासकीय कर्मचाऱ्यांच्या बाबतचा सहावा वेतन आयोग वेगळा आहे आणि यु.जी.सी.चा सहावा वेतन आयोग वेगळा आहे. ही वस्तस्थिती आहे. राज्य शासकीय कर्मचाऱ्यांना ग्रेड पे आहे आणि य.जी.सी. मध्ये ॲकॅडिमक ग्रेड पे आहे. ग्रेड पे आणि ॲकॅडिमक ग्रेड पे सर्व ठिकाणी वेगवेगळे आहेत." पे बॅण्डसुध्दा काही ठिकाणी वेगवेगळे आहेत. सभागृहातील आश्वासनांच्या विरोधात व मंत्रिमंडळाच्या निर्णयाच्या विरोधात दिनांक २४ जुलै २००९ रोजी महाराष्ट्र प्राध्यापक महासंघाच्या अध्यक्षांना पाठविलेल्या पत्रातील उपरोक्त उल्लेख *सभागृहात दिलेल्या आश्वासनाची* पायमल्ली करणारा, मंत्रिमंडळाने घेतलेल्या निर्णयाची अवहेलना करणारा, शासननिर्णयात स्पष्टपणे नमूद असलेल्या निर्णयांचा अधिक्षेप करणारा व एकुणच उच्च शिक्षणक्षेत्रामध्ये विशेषतः आंदोलनकर्त्या शिक्षकांच्या मनामध्ये कोणतेही वाजवी कारण नसतांना अकारण प्रक्षोभ निर्माण करण्यास कारणीभृत ठरलेला आहे.

२. याच वेजवावदार अधिकाऱ्याने दिनांक ३१ जुलै २००९ रोजी दुसरे पत्र' लिहून आंदोलनकर्त्या महाराष्ट्र प्राध्यापक महासंघाच्या अध्यक्षांना राज्य शासनाने "राज्यातील विद्यापीठे व महाविद्यालये/संस्था यामधील शिक्षक व इतर समकक्ष पदांना केंद्र शासनाप्रमाणे (यु.जी.सी. योजना) वेतनश्रेणी १.१.२००६ पासून लागू करण्याचा निर्णय घेतला" असे कळविले. मंत्रिमडळाने घेतलेल्या निर्णयानुसार व शासनिर्णयानुसार आधासित प्रगति योजना (CAS) केंद्राप्रमाणे महाराष्ट्रात २३ जुलै रोजी निर्णय घेऊन मंत्रिमंडळाने जशीच्या तशी लागू केली असतांना २४ जुलै २००९ च्या किंवा ३१ जुलै २००९ च्या उपरोक्त पत्रांमध्ये एका अक्षराने त्यावावतचा उल्लेख या अधिकाऱ्याने केलेला नाही.

२.९ चौथ्या वेतन आयोगाच्या वेळी मा. श्री.शरदराव पवार हे राज्याचे मुख्यमंत्री असतांना त्यांनी महासंघाच्या कार्यकारी मंडळाशी सतत ५ दिवस चर्चा करुन दिनांक १८ जानेवारी १९८९ रोजी नोंदलेले मतैक्यपत्र^८ तयार केले. त्याच्या पहिल्याच परिच्छेदात पृढील प्रमाणे उल्लेख आहे. :-

२.२ पाचव्या वेतन आयोगाच्या वेळी तत्कालीन उच्च शिक्षणमंत्री श्री. दिलीपराव वळसे पाटील यांची महाराष्ट्र प्राध्यापक महासंघाशी चर्चा करून दिनांक ७ डिसेंबर १९९९ रोजी जे मतैक्यपत्र^९ नोंदविले त्यामध्ये पुढील प्रमाणे स्पष्ट उल्लेख आहे.:-

"The Government of India's suggestions on "Revision of payscales of teachers in Universities and Colleges following the revision of payscales of Central Government employees on the recommendations of 5th Central Pay Commission" dated the 27th July, 1998 amended vide a letter dated 6th November, 1998 including UGC's notification dated 24th December, 1998 would be implemented by the State Government with recommended scales of pay, as a composite scheme with effect from 1.1.1996" मतैक्य पत्रात समग्र योजनेचा असा स्पष्ट उल्लेख असल्याने आश्वासित प्रगती योजना त्यावेळी महाराष्ट्रात जशीच्या तशी लागू झाली होती.

२.३ वस्तुतः २४ जुलै २००९ च्या पत्रावर प्रतिक्रिया व्यक्त करणारा ३२ परिच्छेदांचा एक तपशिलवार ठराव या महासंघाच्या कार्यकारी मंडळाने दिनांक २६ जूलै २००९ च्या बैठकीत सम्मत केला होता व त्याची प्रत⁹⁰ शासनाला

तातडीने देण्यात आली होती. या ठरावाच्या परिच्छेद १६ व १७ मध्ये आश्वासित प्रगती (CAS) योजनेबाबतची उपरोक्त परिच्छेद २.९ व २.२ मधील माहिती तपशिलाने नमुद करण्यात आली होती. या सर्व बाबी लक्षात आणून दिल्यानंतरसुद्धा व मंत्रिमंडळाने २३ जुलै २००९ रोजी तसा निर्णय घेतलेला असतांना सुद्धा ३१ जुलै २००९ च्या पत्रामध्ये आश्वासित प्रगती योजनेबाबत (CAS) एका ओळीचासब्दा उल्लेख नव्हता हे संबंधित अधिकाऱ्यांचे अत्यंत बेजबाबदारपणाचे कृत्य होते. असा अनुल्लेख *सभागृहात दिलेल्या* आश्वासनाची पायमल्ली करणारा, मंत्रिमंडळाने घेतलेल्या निर्णयाची अवहेलना करणारा. शासननिर्णयात स्पष्टपणे नमुद असलेल्या निर्णयांचा अधिक्षेप करणारा व एकुणच उच्च शिक्षणक्षेत्रामध्ये विशेषतः आंदोलनकर्त्या शिक्षकांच्या मनामध्ये कोणतेही वाजवी कारण नसतांना अकारण प्रक्षोभ निर्माण करण्यास कारणीभृत ठरलेला आहे.

३. मंत्रिमंडळाने २३ जुलै २००९ रोजी जो निर्णय घेतला. त्या निर्णयाप्रमाणे अनुषंगिक लाभाबाबत "विद्यापीठीय व महाविद्यालयीन शिक्षकांना सध्या जे चालु आहेत ते किंवा शासकीय कर्मचाऱ्यांप्रमाणे यापैकी जे फायदेशीर असतील ते अनुषंगिक लाभ चालु रहातील" असे ठरले होते. हा निर्णय पुढे १२ ऑगस्ट २००९ च्या शासननिर्णयाच्या परिच्छेद ८ ब मध्ये नमुद आहे.^{११} मंत्रिमंडळाने २३ जुलैला घेतलेल्या या निर्णयाच्या विरोधात महाराष्ट्र प्राध्यापक महासंघाच्या अध्यक्षांना दिलेल्या ३१ जुलै २००९ च्या पत्रातील^५ "**अनुषंगिक लाभ राज्य** शासकीय कर्मचाऱ्यांप्रमाणे लागू करण्याचा निर्णय घेतला आहे." असा उल्लेख अधिकाऱ्यांच्या बेजबाबदारपणाचा एक फार मोठा नमुना होय. *हा उल्लेख* सभागृहात दिलेल्या आश्वासनाची पायमल्ली करणारा, मंत्रिमंडळाने घेतलेल्या निर्णयाची अवहेलना करणारा. शासननिर्णयात स्पष्टपणे नमद असलेल्या निर्णयांचा अधिक्षेप करणारा व एकणच उच्च शिक्षणक्षेत्रामध्ये विशेषतः आंदोलनकर्त्या शिक्षकांच्या मनामध्ये कोणतेही वाजवी कारण नसतांना अकारण प्रक्षोभ निर्माण करण्यास कारणीभृत ठरलेला आहे.

- ४. मंत्रिमंडळाने २३ जुलै २००९ रोजी घेतलेल्या निर्णयाप्रमाणे निघालेल्या १२ ऑगस्ट २००९ च्या शासननिर्णयाच्या परिच्छेद ८ व मध्ये स्पष्टपणे पुढील प्रमाणे तरतुद आहे.:-
- "8 (B) Following allowances and benefits shall be at par with the state government employees. However for those areas where the teachers are already drawing more allowances or enjoying more benefits than the state government employee (even after the 6th pay commission) the higher rates and/or benefits shall continue i.e. the teachers shall continue to get whichever is higher (existing rates and benefits or as per state government employees after 6th pay commission.)"

Sub: Revision of Pension of Pre-2006 Pensioners/ Family Pensioners who retired as Readers/Lecturers (Selection Grade) & equivalent cadres, and Deputy Registrars/equivalent cadres in Central Universities and Colleges.

Sir,

I am directed to refer to the Government's decision regarding pension/family pension of all the pre-2006 pensioners/family pensioners issued vide Department of Pension and Pensioner's Welfare O.M.No. 38/37/08- P&PW (A) dated 1.9.2008. In this connection a question has arisen about the Pay Band applicable to pre-2006 pensioners in Central Universities/colleges, who had retired from the posts in the pre-revised scale of pay of Rs. 12000-420-18300 (or the corresponding pay scales applicable prior to 1.1.1996) mentioned below to determine their pension/family pension in terms of para 4.2 of Ministry of Personnel, Public Grievances and Pensions (Department of Pension and Pensioners' Welfare) O.M. No. 38/37/08-P&PW(A) dated 1.9.2008.

Category (A)

Readers/Lecturers (Selection Grade)

Category (B)

- (i) Deputy Librarian/Assistant Librarian (Selection Grade)/College Librarian (Selection Grade)
- (ii) Deputy Director of Physical Education/Assistant Director of Physical Education (Selection Grade), College Director of Physical Education (Selection Grade)

Category (C)

- (i) Deputy Registrar,
- (ii) Deputy Finance Officer,
- (iii) Deputy Controller of Examinations.

- 2. According to the revised pay scales applicable to Teachers/Equivalents Cadres in Central Universities/ Colleges as notified vide Ministry's letter No. 1-32/2006-U.II/U.I(i) dated 31.12.2008, incumbents of the posts mentioned at categories (A) and (B) above who had completed 3 years of service in the pay scale of Rs. 12000-420-18300 on 1.1.2006 have been placed in pay Band of Rs. 37400-67000 with Academic Grade Pay (AGP) of Rs. 9000. Similarly in terms of this Ministry's letter No. 1-32/2006-U.II/U.I(ii) dated 31.12.2008, incumbents of the posts of Deputy Registrars / Deputy Finance Officers/Deputy Controllers of Examinations who had completed 5 years of service in pre-revised pay scale of Rs. 12000-420-18300 on 1.1.2006 were placed in the Pay Band of Rs. 37400-67000 with Grade Pay (GP) of Rs. 8700.
- 3. Accordingly, the Government has decided that in the case of teachers and equivalent cadres, the pre-1.1.2006 pensioners mentioned at categories (A) and (B) above who had completed 3 years of service in the pre-revised pay scale of Rs. 12000-420-18300 (and/or the corresponding pay scale(s) applicable prior to 1.1.1996) shall be placed at the minimum of the Pay Band of Rs. 37400-67000 with AGP of Rs. 9000 for revision of their pension/family pension with effect from 1.1.2006. Similarly, in the case of non-teaching posts/cadres, the pre-1.1.2006 pensioners mentioned at category (C) above who had completed 5 years of service in the pre-revised pay scale of Rs. 12000-420-18300 (and the corresponding pay scale(s) applicable prior to 1.11.1996) Shall be placed at the minimum of the pay Band of Rs. 37400-67000 with GP of Rs. 8700 for revision of their pension/family pension with effect from 1.1.2006. The pension/family pension of these pre 2006 pensioners may be revised accordingly.
- 4. these orders shall apply to only those pensioners/family pensioners who were drawing pension/family pension on 1.1.2006 under the Central Civil Services (Pension) Rules 1972.
- 5. This issues with the approval of the competent authority.

view that since no NET qualified/NET exempted candidate was available at the time of interview and had continued service of 5 or more years the NET / SLET qualification is relaxed in respect of the following candidates for appointment as Lecturer with the following conditions:- (i) That the recommended exempted candidate should have been selected by a duly constituted Selection Committee. (ii) The constitutional provisions of reservation for SC/ST etc. are followed in these selections."

- ५.२ विद्यापीठ अनुदान आयोगाचा हा धोरणात्मक निर्णय मा. उच्च शिक्षणमंत्र्यांनी स्वतः पुढील शब्दात १७ डिसेंबर २००८ रोजी विधानपरिषद सभागृहात सांगितला :-"विद्यापीठ अनुदान आयोगाच्या दिनांक ५ नोव्हेंबर, २००८ च्या पत्रात नमूद केलेल्या खालील अटीनुसार एकूण ८३७ शिक्षकांना नेट/सेट पात्रतेपासुन सुट देण्यात येत असल्याचे विद्यापीठास कळविले आहे." १५
- ५.३ विद्यापीठ अनुदान आयोगाने ५ नोव्हेंबर २००८ च्या आदेशाने जो धोरणात्मक निर्णय कळविला, त्याबावतीत मा. उच्च न्यायालयाच्या नागपूर खंडपीठाने Writ Petition Nos. 4266/2006, 5037/08,4486/2007, 4386/07, 4500/07 and 462/2008 या प्रकरणात दिनांक २७ नोव्हेंबर, २००८ रोजी पुढील धोरणात्मक निर्णय दिला :-

"So far as the lecturers, who were in service, from 1991 onwards, the issue of exemption to them is claimed to be covered by the orders passed by the UGC on 5.11.2008 based on the Commission's decision in its meeting dated 7th and 8th October 2008. If any of the petitioners are governed by this communication dated 5.11.2008 addressed by the UGC to the Registrar of the University concerned, undoubtedly, their proposals

will have to be considered and approved, as per the said decision of UGC."56

- ५.४ मा.उच्च शिक्षणमंत्र्यांनी सभागृहात १७ डिसेंबर २००८ रोजी शासनाच्या वतीने पुढील प्रमाणे आश्वासने दिलीत:-
- (i) "सन्माननीय सदस्य प्रा. बी.टी.देशमुख यांनी जे तीन प्रश्न विचारलेले आहे त्याबाबत मी शासनाच्या वतीने सांगू इच्छितो की, या सदंर्भात एक जी.आर. काढणे आवश्यक आहे. तेव्हा या अधिवेशनाचा कालावधी संपण्याच्या अगोदर हा जी.आर. काढण्यात येईल, जर २४ तारखेला अधिवेशन संपणार असेल तर त्या अगोदर जी. आर. काढण्यात येईल.... तसेच हे काम एक महिन्याच्या आत पूर्ण करण्यात यावे अशी सूचना विद्यापीठाला देण्यात येईल."
- (ii) "हे करिअर ॲडव्हान्समेंट स्कीमच्या संदर्भात हे कॅसचे काम पूर्ण करावयाचे आहे त्यासाठीदेखील कॅम्प्स घेऊन येत्या दोन महिन्यात पूर्ण करावयाचे आहे. अशा प्रकारे हे एकूण सर्वच काम म्हणजे नियमित करण्याचे काम एक महिन्यात आणि त्यापुढे कॅसचे काम दोन महिन्यात असे तीन महिन्यात पूर्ण करून या सगळ्या प्रश्नांना पूर्णिवराम दिला जाईल."⁹⁹

- Subsequently, the AICTE has issued Notification F.No. 37-3/Legal/2010 dt. 22 nd January, 2010 for

implementation of pay scales, service conditions and qualifications for the Teachers and other academic staff in Technical institutions (Degree)

- Clause 9 of Minutes of the Agreement between the Government of Maharashtra and MFUCTO dated 26 th August, 2009 reads as
- "AICTE व केंद्रीय मानव संसाधन मंत्रालय यांच्याकडून सहाव्या वेतन आयोगावहल आदेश प्राप्त झाल्यानंतर अभियांत्रिकी महाविद्यालयातील शिक्षकांना सहावा वेतन आयोग लागू करण्यासाठी योग्य ती कार्यवाही विभागाकडून करण्यात गेर्नेल "
- In the light of above, this General council of MFUCTO requests the State Government to immediately issue the GR bringing in to effect the AICTE notification on pay revision for Teachers in Technical institutions

- (१) राज्य शासन विद्यापीठ अनुदान आयोगाला व केंद्र शासनाला प्रलंबित प्रकरणे त्यरीत निकाली काढण्यासाठी विनंती करील. आवश्यकता पडल्यास याचा पाठपुरावा करण्यासाठी वरिष्ठ अधिकाऱ्यांकडे जबाबदारी देऊन सदर प्रलंबित कामे त्यरीत पूर्ण करुन घेण्यात येतील.
- (२) विद्यापीठ अनुदान आयोगाकडून सुट मिळाल्याचे पत्र विद्यापीठास प्राप्त झाल्याच्या दिनांकापासून शक्यतो ३० दिवसांच्या आत ती प्रकरणे निकाली काढण्यासाठी आवश्यकतेप्रमाणे शिबीर आयोजित करुन कार्यवाही पूर्ण करण्यात येईल.

- ५.६ मंत्रिमहोदयांनी सभागृहात घेतलेल्या भूमिकेच्या विरुद्ध तसेच पत्रातून शासनाने महासंघाला कळविलेल्या भूमिकेच्या विरुद्ध प्रधान सचिव विद्यापीठ अनुदान आयोगाच्या कार्यालयात जावून कारस्थाने करीत होते असे स्पष्टपणे विसून येते. "१८ ऑगस्ट २००९ या तारखेला राज्य शासनाचे आम्ही तीन अधिकारी विद्यापीठ अनुदान आयोगाच्या कार्यालयात येवून गेलो व तेथे आपणास काय सांगितले?" हे २४ ऑगस्ट २००९ रोजी पत्र^{१९} लिहून विद्यापीठ अनुदान आयोगाला त्यापैकी एका अधिकान्याने कळविले आहे. २४ ऑगस्ट २००९ च्या या पत्रामध्ये (No. UGC 2009(332/09)UNI-I, Higher & Technical Education Department, Mantralaya, Mumbai-400 032.) या अधिकान्यांनी मांडलेली भूमिका ही पूर्णपणे मा. मंत्रिमहोदयांच्या भूमिकेच्या विरोधात आहे. या पत्रातील बहुतांशी मजकुर सभागृहात विलेल्या आधासनाची पायमल्ली करणारा, मंत्रिमहोदयांनी घेतलेल्या निर्णयांचा अधिक्षेप करणारा व एकूणच उच्च शिक्षणक्षेत्रामध्ये विशेषतः आंदोलनकर्त्या शिक्षकांच्या मनामध्ये कोणतेही वाजवी कारण नसतांना अकारण प्रक्षोभ निर्माण करण्यास कारणीभूत ठरलेला आहे.
- ६. मंत्रिमंडळाने निर्णय घेतल्यानंतर १२ ऑगस्ट २००९ चा शासननिर्णय निर्गमित करतांना मुद्दाम उच्च शिक्षण क्षेत्रामध्ये गोंधळाचे वातावरण निर्माण होईल अशा प्रकारची शब्दरचना प्रधान सचिवांनी हेतूपूर्वक वापरलेली दिसते. उदाहरणार्थ शासननिर्णयातील^{२०} परिच्छेद १४ पुढील प्रमाणे आहे.:-
- "(14) This Government Resolution is <u>subject to</u> the decision taken by the State Government on the scheme forwarded by Government of India by its letter dated 31/12/2008. Therefore, anomalies, if any may be brought to the notice of the Department of Higher and Technical Education, Government of Maharashtra through proper channel."

"मंत्रिमंडळाचा निर्णय काहीतरी वेगळा आहे व त्याप्रमाणे या शासननिर्णयात पुढे बदल होवू शकतात, आजचा हा शासनिर्णय अंतिम नाही" असा स्पष्ट अर्थ "subject to" या शब्दाच्या वापराने विदित होतो. "according to" असा शब्द वापरल्यावरोवर "हा शासनिर्णय मंत्रिमंडळाच्या निर्णयाप्रमाणेच काढण्यात आलेला आहे." असा स्पष्ट अर्थ ध्वनित होतो. १२ ऑगस्ट, २००९ चा शासन निर्णय हा राज्य शासनाचा शासनिर्णय आहे, त्यात निश्चितता ही ओघानेच आली, त्यात "subject to" मुळे येणारी अनिश्चितता घुसविण्याचे कारणच काय? या शासन निर्णयात, एक तर जाणिवपूर्वक ही "subject to" अशी शब्दयोजना करुन, संभ्रम निर्माण करण्याचा प्रयत्न करण्यात आला असे म्हणावे लागते अथवा आंग्ल भाषेची अपुरी जाण असणे, हे दुसरे कारण असु शकते. ह्यात बहुधा पहिली शंका अधिक संभवते. त्यामुळेच वापरलेल्या "subject to" च्या जागी "according to" अशी शब्दरचना दि. २६ ऑगस्ट, २००९ रोजीच्या इतिवृत्तात⁹⁶ करावी लागली. शासनिर्णयातील "subject to" हा उल्लेख सभागृहात विलेल्या आधासनाची पायमल्ली करणारा, मंत्रिमंडळाने घेतलेल्या निर्णयाची अवहेलना करणारा, अशा निर्णयात स्पष्टपणे

नमूद असलेल्या निर्णयांचा अधिक्षेप करणारा व एकूणच उच्च शिक्षणक्षेत्रामध्ये विशेषतः आंदोलनकर्त्या शिक्षकांच्या मनामध्ये कोणतेही वाजवी कारण नसतांना अकारण प्रक्षोभ निर्माण करण्यास कारणीभृत ठरलेला आहे.

- ७. केंद्राच्या समग्र योजनेतसुद्धा "रजेच्या नियमात नंतर बदल करा, सध्या नियम आहे तसे चालु द्या" अशा अर्थाच्या सूचना नव्हत्या. "शासन निर्णयातील परिच्छेद ८ (ब) मधील तिसऱ्या ओळीतील Benefits या शब्दानंतर "Including leave package" हा शब्द समाविष्ट करण्यात यावा." ह्या गोष्टीवर उभयपक्षी मतैक्य २६ ऑगस्ट २००९ रोजी झाले. त्याची नोंद मतैक्याच्या इतिवृत्ताच्या परिच्छेद ४ मध्ये अहे. ही नंतरची गोष्ट झाली. त्यापूर्वी प्रधान सचिवांनी आपल्या तिसऱ्या म्हणजे ४ ऑगस्ट २००९ च्या पत्रात^६ "(ii) रजांबाबत (Leave Package) सध्या अस्तित्वात असलेले नियम पुढील निर्णय होईपर्यंत लागू राहील." असे कळविले होते. "पुढील निर्णय होईपर्यंत" या शब्दरचनेमुळे मंत्रिमहोदयांनी दिलेली आश्वासने पायदळी तुडवून रजाविषयक नियमात सचिव आक्रमक बदल करण्याचा काही तरी कार्यक्रम आखत आहेत अशी तीव्र संतापाची भावना सर्वत्र निर्माण झाली. वस्तुतः २३ तारखेलाच मंत्रिमंडळाने निर्णय घेतला होता व त्याप्रमाणे शासननिर्णयात पुढे परिच्छेद ८ ब समाविष्ट करण्यात आला. रजाविषयक नियम हे अनुषंगिक लाभाचाच एक भाग असल्याने "पूढील निर्णय होईपर्यंत" हा ४ ऑगस्ट २००९ रोजीच्या पत्रातील उल्लेख आगीत तेल ओतणारा ठरला. तिसऱ्या पत्रातील हा उल्लेख सभागृहात दिलेल्या आश्वासनाची पायमल्ली करणारा. मंत्रिमंडळाने घेतलेल्या निर्णयाची अबहेलना करणारा. शासननिर्णयात स्पष्टपणे नमद असलेल्या निर्णयांचा अधिक्षेप करणारा व एकणच उच्च शिक्षणक्षेत्रामध्ये विशेषतः आंदोलनकर्त्या शिक्षकांच्या मनामध्ये कोणतेही वाजवी कारण नसतांना अकारण प्रक्षोभ निर्माण करण्यास कारणीभूत ठरलेला आहे.
- ८. उपरोक्त ठरावातील परिच्छेद १ ते ७ मध्ये ज्या निरनिराळ्या पत्रांचा व पत्रव्यवहाराचा उल्लेख आलेला आहे त्यातील काही पत्रे शासनातील दुय्यम अधिकाऱ्यांनी स्वाक्षरित केलेली असली तरी प्रत्यक्षात लोकशाहीप्रणालीचे धिंडवडे काढण्याची ही मोहिम प्रधान सचिव, उच्च शिक्षण यांच्याच नेतृत्वाखाली सुरु होती हे स्पष्ट आहे. महाराष्ट्र प्राध्यापक महासंघाच्या कार्यकारी मंडळाने प्रत्यक्ष अनुभवलेले दोन प्रसंग या ठिकाणी नमूद करणे आवश्यक वाटते. वेतनश्रेण्याबाबत व नेटसेटबाबत विधानपरिषद सभागृहात दिलेल्या आश्वासनाची अम्मलबजावणी करण्याच्या दृष्टीने शिक्षणमंत्र्यांशी ज्या विविध चर्चा झाल्या, त्यातील आंदोलन काळातील शेवटची चर्चा दिनांक २६ ऑगस्ट २००९ रोजी झाली. शासनातील राजकीय नेतृत्त्वाच्या प्रती एखादा अधिकारी किती उद्धटपणाने वागू शकतो याची कमाल मर्यादा प्रदर्शित करणारे उच्च शिक्षण सचिवांचे वर्तन आंदोलनाच्या त्या शेवटच्या दिवशी म्हणजे २६ ऑगस्ट २००९ ला पहायला मिळाले. त्यादिवशी ११ वाजेपासून तर ३ वाजेपर्यंत चाललेल्या चर्चेचे नेतृत्व स्वतः मा. उच्च शिक्षणमंत्री करीत होते पण या चर्चेत एकदासुद्धा, एक मिनिटासाठी सुद्धा उच्च शिक्षण सचिव उपस्थित राहीले नाहीत. सभागृहात देण्यात आलेल्या आश्वासनाविषयी व अशी आश्वासने देणाऱ्यांविषयी व एकंदरीतच सभागृहातील कामकाजाविषयी तुच्छतेची भावना मनात बाळगणाऱ्या प्रधान सचिवांचे एकुण वर्तन त्यांच्या पदाला शोभणारे नव्हते. खुद्द मा. मुख्यमंत्र्यांनी २० ऑगस्ट २००९ रोजी त्यांच्या मंत्रालयातील दालनांत महासंघाच्या कार्यकारी मंडळाला दुपारी २.०० वाजता चर्चेसाठी बोलाविले होते. मा. उच्च शिक्षण मंत्री, अर्थ व विधी विभागाचे सचिव व इतर सर्वजण वेळेवर उपस्थित होते. खुद मा. मुख्यमंत्र्यांनी मा. उच्च शिक्षण मंत्र्यासह वेळेवर चर्चेला सुरुवात केली. पण उच्च शिक्षण सचिव मात्र अनुपस्थित होते. ते काही मिनीटांच्या उशिराने सभेत आले व त्याबद्दल त्यांना सर्वासमक्ष मा. मुख्यमंत्र्याकडून 'बोलणी' ऐकावी (खावी) लागली.

सभागृहात दिलेल्या आश्वासनाची पायमल्ली करणारे, मंत्रिमंडळाने घेतलेल्या निर्णयाची अवहेलना करणारे, शासनिर्णयात स्पष्टपणे नमूद असलेल्या निर्णयांचा अधिक्षेप करणारे व एकूणच उच्च शिक्षणक्षेत्रामध्ये विशेषतः आंदोलनकर्त्या शिक्षकांच्या मनामध्ये कोणतेही वाजवी कारण नसतांना अकारण प्रक्षोभ निर्माण करण्यास कारणीभूत ठरलेले हे प्रधान सचिवाच्या नेतृत्वाखाली उच्च शिक्षण विभागातील अधिकाऱ्यांचे वर्तन अत्यंत आक्षेपाई असून लोकशाही संस्थाच्या कार्यपद्धतीचे उघडउघड धिंडवडे काढणारे आहे. याबावत उच्च स्तरीय चौकशी होऊन संबंधितांवर योग्य ती कारवाई करण्यात यावी अशी मागणी हे सभागृह करीत आहे.

In exercise of it's powers conferred under sub-section (1) of section 23 read with section 10 (i) and (v) of the All India Council for Technical Education Act, 1987 (52 of 1987) the All India Council for Technical Education makes the following Regulations:-

1. Short Title, Application and Commencement:

- · 1.1 These Regulations may be called the All India Council for Technical Education (Pay Scales, Service Conditions and Qualifications for the Teachers and other Academic Staff In Technical Institutions (Degree) Regulations, 2010.
- $\cdot~1.2$ They shall apply to technical institutions and Universities including deemed Universities imparting technical education and such other courses / Programs and areas as notified by the Council from time to time.

They shall come into force with effect from the date of their publication in the Official Gazette

General

- (i) There shall be only three designations in respect of teachers in universities and colleges, namely, Assistant Professors, Associate Professors and Professors. However, there shall be no change in the present designation in respect of Library Personnel at various levels.
- (ii) No one shall be eligible to be appointed, promoted or designated as Professor, unless he or she possesses a Ph.D. and satisfies other academic conditions, as laid down by the AICTE from time to time. This shall, however, not affect those who are already designated as 'Professor'.
- (iii) The pay of teachers and equivalent positions in Technical institutions shall be fixed according to their designations in two pay bands of Rs. 15600-39100 and Rs. 37400-67000 with appropriate "Academic Grade Pay" (AGP in short). Each Pay Band shall have different stages of Academic Grade Pay which shall ensure that teachers and other equivalent cadres covered under this Scheme, subject to other conditions of eligibility being satisfied have multiple opportunities for upward movement during their career.
- (iv) Posts of Professors shall be created in under-graduate (UG) institutions as well as in post-graduate (PG) institutions. The ratio of Professors to Associate Professors to Assistant Professors in a UG College shall be in the ratio, ordinarily of 1:2:6. The ratio of Professors to Associate Professors and or Assistant Professor in a PG College shall be in the ratio ordinarily of 1:2
- (v) Up to 10% of the posts of Professors in Technical Institutions shall be in the higher Academic Grade Pay of Rs. 12000 with eligibility conditions to be prescribed by the AICTE as applicable.

Revised Pay Scales, Service conditions and Career Advancement Scheme for teachers and equivalent positions:

The pay structure for different categories of teachers and equivalent positions shall be as indicated below:

(a) Assistant Professor/Associate Professors/Professors In Technical institutions

- (i) Persons entering the teaching profession in Technical Institutions shall be designated as Assistant Professors and shall be placed in the Pay Band of Rs. 15600-39100 with AGP of Rs.6000. Lecturers already in service in the pre-revised scale of Rs. 8000-13500, shall be re-designated as Assistant Professors with the said AGP of Rs. 6000.
- (ii) An Assistant Professor with completed service of 4 years, possessing Ph. D Degree in the relevant branch / discipline shall be eligible, for moving up to AGP of Rs. 7000.
- (iii) Assistant Professors possessing Master's degree in the relevant branch / discipline as defined for technical education shall be eligible for the AGP of Rs. 7,000 after completion of 5 years service as Assistant Professor.
- (iv) Assistant Professors who do not have Ph.D or a Master's degree in the relevant branch / discipline of a program shall be eligible for the AGP of Rs. 7,000 only after completion of 6 years' service as Assistant Professor.

- (v) The upward movement from AGP of Rs. 6000 to AGP of Rs. 7000 for all Assistant Professors shall be subject to their satisfying other conditions as laid down by AICTE.
- (vi) The pay of the incumbents to the posts of Lecturer (senior scale) (i.e. the pre-revised scale of Rs. 10,000-15200) shall be re-designated as Assistant Professor, and shall be fixed at the appropriate stage in Pay Band of Rs.15600-39100 based on their present pay, with AGP of Rs. 7000.
- (vii) Assistant Professors with completed service of 5 years at the AGP of Rs. 7000 shall be eligible, subject to other requirements laid down by the AICTE, to move up to the AGP of Rs. 8000.
- (viii) Posts of Associate Professor shall be in the Pay Band of Rs.37400-67000, with AGP of Rs.9000. Directly recruited Associate Professors shall be placed in the Pay Band ' of Rs. 37400-67000 with an AGP of Rs. 9000, at the appropriate stage in the Pay Band in terms of the conditions of appointment.
- (ix) Incumbent Lecturers (Selection Grade) who have completed 3 years in the pre-revised pay scale of Rs. 12000-18300 on 1.1.2006 shall be placed in Pay Band of Rs. 37400-67000 with AGP Pay of Rs. 9000 and shall be re-designated as Associate Professor.
- (x) Incumbent Lecturers (Selection Grade) who had not completed three years in the pay scale of Rs. 12000-18300 on 1.1.2006 shall be placed at the appropriate stage in the Pay Band of Rs. 15600-39100 with AGP of Rs. 8000 till they complete 3 years of service in the grade of Lecturer (Selection Grade), and thereafter shall be placed in the higher Pay Band of Rs.37400-67000 and accordingly re-designated as Associate Professor.
- (xi) Lecturers (Selection Grade) in service at present shall continue to be designated as Lecturer (Selection Grade), as the case may be, until they are placed In the Pay Band of Rs. 37,400-67000 and re-designated as Associate Professor in the manner described in (x) above.
- (xii) Assistant Professors completing 3 years of teaching in the AGP of Rs. 8000 shall be eligible, subject to other conditions, that may be prescribed by AICTE as applicable, to move to the Pay Band of Rs. 37400-67000 with AGP of Rs. 9000 and to be designated as Associate Professor.
- (xiii) Associate Professor completing 3 years of service in the AGP of Rs. 9000 and possessing a Ph.D. degree in the relevant discipline shall be eligible to be appointed and designated as Professor, subject to other conditions of academic performance as laid down by the AICTE. No teacher other than those with a Ph.D. shall be promoted, appointed or designated as Professor. The Pay Band for the post of Professors shall be Rs.37400-67000 with AGP of Rs. 10000.
- (xiv) The pay of a directly recruited Professor shall be fixed at a stage not below Rs. 43000 in the Pay Band of Rs. 37400-67000, with the applicable AGP of Rs. 10000.
- (xv) Ten percent of the posts of Professors in a AICTE approved Institution shall be in the higher AGP of Rs. 12000, however, teachers appointed to the posts shall continue to be designated as Professor. Eligibility for appointment as a Professor in the higher Academic Grade Pay shall be as may be laid down by the AICTE, and such eligibility conditions shall, inter alia, include publications in peer reviewed/ refereed Research Journals, and the requirement of at least 10 years of teaching as Professor and post-doctoral work of a high standard. No person appointed directly as Professor in the AGP of Rs. 12000 shall be fixed at a stage less than Rs. 48000 along with the AGP
- (xvi) For initial direct recruitment at the level of Associate Professors and Professors, the eligibility conditions in respect of academic and research requirements shall be as may be or have been prescribed by the AICTE, through Regulations and as may be laid down by the AICTE.
- (xvii) Discretionary award of advance increments for those who enter the profession as Associate Professors or Professors with higher merit, high number of research publications and experience at the appropriate level, shall be within the

(xviii) All advancements to higher grade pays in various cadres will be effected subject to completion of two AICTE approved refresher programs of not less than two weeks duration each and two one week each TEQIP sponsored programs.

Appointments to the posts of Principal in Technical Institutions shall be based on the conditions of eligibility In respect of educational qualifications and teaching/research experience laid down by AICTE from time to time, The posts of Principal shall be in the Pay Band of Rs. 37400-67000 with AGP of Rs. 10,000, plus a Special Allowance of Rs. 3000 per month. All Principals in service shall be appropriately fixed in the Pay Band with the AGP of Rs. 10000 plus a Special Allowance of Rs. 3000 per month.

- (vi) Teachers in service who have not yet enrolled for Ph.D. shall therefore derive the benefit of three non-compounded increments on award of Ph.D, while in service only if such enrolment is with a university recognized by UGC.
- (vii) Teachers who acquire M.Phil. degree or a M.Tech degree in a relevant Branch / discipline recognised by a Statutory University while in service, shall be entitled to one advance increment.
- (viii) Five non-compounded advance increments shall be admissible to Assistant Librarian/ College Librarian who are recruited at entry level with Ph.D. degree in the discipline of library science from a university complying with the process prescribed by the UGC in respect of enrolment, course-work and evaluation process for the award of Ph.D. in library science.
- (ix) Assistant Librarian/College Librarian and other Library personnel acquiring the degree of Ph.D, at any time while in service, in the discipline of library science from a university complying with the process prescribed by the UGC in respect of enrolment, course-work and evaluation shall be entitled to three non-compounded advance increments.
- (x) However, persons in posts of Assistant Librarian/College Librarian or higher positions who have been awarded Ph.D. in library science at the time of coming into force of this Scheme or having been enrolled for Ph.D. in library science have already undergone course-work, if any, as well as evaluation, and only notification in regard to the award of Ph.D. is awaited, shall also be entitled to the award of three non* compounded increments even if the university awarding such Ph.D. has not yet been notified by the UGC as having complied with the process prescribed by the Commission.
- (xi) In respect of every other case of persons in the posts of Assistant Librarian/ College Librarian or higher positions who are already enrolled for Ph.D. shall avail the benefit of three non-compounded increments only if the university awarding the Ph.D. has been notified by the UGC to have complied with the process prescribed by the UGC for the award of Ph.D, in respect of either course-work or evaluation or both, as the case may be.
- (xii) Assistant Librarian/ College Librarian and others in higher Library positions in service who have not yet enrolled for Ph.D. shall therefore derive the benefit of three noncompounded increments on award of Ph.D, while in service only if such enrolment is with a university which complies with the entire process, including that of enrolment as prescribed by the UGC.
- (xiii) Two non-compounded advance increments shall be admissible for Assistant Librarian/College Librarian with M.Phil degree in Library Science at the entry level. Assistant Librarian/College Librarian and those in higher positions acquiring M.Phil degree in Library Science at any time during the course of their service, shall be entitled to one advance increment.
- (xiv) Not withstanding anything in the foregoing clauses, those who have already availed the benefits of advance increments for possessing Ph.D / M. Tech, at the entry level under the earlier scheme shall not be entitled to the benefit of advance increments under this Scheme.
- (xv) For posts at the entry level where no such advance increments were admissible for possessing Ph.D / M. Tech, under the earlier scheme, the benefit of five advance increments for possessing Ph.D./ M. Tech, shall be available to only those appointments which have been made on or after the coming into force of this Scheme.

Other terms and conditions:

Increments:

- (i) Each annual increment shall be equivalent to 3% of the sum total of pay in the relevant Pay Band and the AGP as applicable for the stage In the Pay Band.
- (ii) Each advance increment shall also be at the rate of 3% of the sum total of pay in the relevant Pay Band and the AGP as applicable and shall be non-compoundable.
- (iii) The number of additional increment(s) on placement at each higher stage of AGP shall be as per the existing scheme

of increment on promotion from lower Pay Scale to higher Pay Scale; however, in view of the considerable ra*se In effective pay between the two Pay Bands, there shall be no additional increment on movement from the Pay Band of Rs. 15600-39100 to the Pay Band of Rs. 37400-67000.

Pay 'fixation formula':

The pay 'fixation formula' recommended by 6th Central Pay Commission as accepted by the Central Government shall be adopted for Technical teachers and equivalent positions in the Library Cadres.

Allowances:

- (i) Allowances such as Leave Travel Concession, Special Compensatory Allowances, Children's Education Allowance, Transport Allowance, House Rent Allowance, Deputation Allowance, Travelling Allowance, Dearness Allowance, area based Special Compensatory Allowance etc. as applicable to teachers and Library and Physical Education Cadres, shall be at par with those accepted by the Central Government for Central Government employees on the recommendations of 6* Central Pay Commission and shall be applicable from 1.09.2008.
- (ii) For Technical teachers in AICTE approved Institutions and equivalent positions in Library as defined by AICTE, the rates of allowances as applicable to Central Government Group 'A' employees shall be adopted.
- (iii) Technical Teachers in AICTE approved Institutions and equivalent positions in Library as defined by AICTE, with visual, orthopedic hearing *or* other disabilities under the provisions of 'Persons with Disabilities (Protection of Rights, Equal Opportunities and Full Participation) Act, 1995' .shall be entitled to twice the normal rate of transport allowance as accepted by the Central Government on the recommendations- of 6lh CPC for Central Government Employees with disabilities.

Study Leave:

AICTE shall revise its guidelines in respect of granting study leave with pay for acquiring M. Tech. and Ph.D. in the relevant branch / discipline while in service by relaxing the number of years to be put in after entry while keeping in mind the availability of vacant positions for teachers and other cadres in Technical Institutions, so that a teacher and other cadres entering service without Ph.D. or higher qualification could be encouraged to acquire these qualifications in the relevant

I am directed to refer to the UGC Regulation 2000 as amended from time to time on minimum qualification for appointment of teachers and equivalent cadres in the Universities and colleges and to say that the process of finalization of Regulation based on Sixth Central pay Commission for teachers is on and likely to be finalized shortly.

In the interim period, the Universities and colleges may go ahead with the recruitment and promotion of teachers under CAS as per UGC Regulation of 2000 as amended from time to time and instructions, guidelines and amendments issued by the Commission from time to time.

As soon as the new Regulations are notified in the Gazette of India, the same would supersede the existing Regulation and Universities would be required to follow the same. It is further clarified that the designation of Associate Professor in AGP of Rs. 9000 would not be admissible as per the Regulation, 2000 as amended from time to time.

The contents of the letter may be brought to the notice of all the affiliated Colleges/Institutions.

Sabbatical Leave for Teachers

To encourage interface between technical education and industry, the Committee recommends that a Faculty member in an Engineering College should be given a sabbatical leave for six months for working in an industry after the completion of six years of teaching. Such leave, however, shall be available to a teacher only twice in his/her teaching career.

Research Promotion Grant:

AICTE shall prescribe a scheme with appropriate guidelines for providing by way of appropriate 'start up grants' to teachers and other cadres taking up research in all disciplines including basic science research as recommended by "Prof. M.M. Sharma Committee on Strengthening of Basic Science Research'.

Age of Superannuation:

- (i) In order to meet the situation arising out of shortage of teachers in Technical Institutions and the consequent vacant positions therein, the age of superannuation for teachers in Technical Institutions has been enhanced to sixty five years, vide the Department of Higher Education letter No.F.No.l-19/2006-U.II dated 23.3.2007, for those involved in class room teaching in order to attract eligible persons to the teaching career and to retain teachers in service for a longer period.
- (ii) Subject to availability of vacant positions and fitness, teachers shall also be reemployed on contract appointment beyond the age of sixty five years up to the age of seventy years. Re-employment beyond the age of superannuation shall, however, be done selectively, for a limited period of 3 years ie the first instance and then for another further period of 2 years purely on the basis of merit, experience, area of specialization and peer group review and only against available vacant positions without affecting selection or promotion prospects of eligible teachers.
- (iii) Whereas the enhancement of the age of superannuation for teachers engaged in class room teaching is intended to attract eligible persons to a career in teaching and to meet the shortage of teachers by retaining teachers in service for a longer period, and whereas there is no shortage in the categories of Librarians, the increase in the age of superannuation from the present sixty two years shall not be available to the categories of Librarians.

Pension:

- (i) For teachers and other cadres in AICTE approved institutions in receipt of pension, the Central Government rules for pension and gratuity as applicable to Central Government employees shall be applicable.
- (ii) In view of the new pension scheme effective from 1.1.2004, no new cases of conversion to pension scheme shall be allowed.

Family Pension:

Family Pension facilities as approved by the Central Government in respect of Central Government Employees on the recommendations of Sixth CPC shall be available to teachers in Technical Institutions who are eligible for such Pension at present.

(i) Additional Quantum of Pension to senior pensioners:

The facility of additional quantum of pension accepted by the Central Government on the recommendation of 6th CPC for senior pensioners of the Central Government shall be extended to persons who are or were in teaching and other cadres on attaining the age of eighty years if they are already in pension scheme AICTE approved institutions.

- (ii) **Gratuity and Encashment of Leave:** Facilities of gratuity and encashment of leave accepted by the Central Government on the recommendation of 6tri CPC for Central Government employees shall be extended to teachers and other cadres in AICTE approved Technical institutions.
- (iii) **Ex-Gratia Compensation:** Families of teachers and other cadres who die in performance of their bona fide duties shall be compensated in the same manner as similarly placed families of Central Government Employees.

Provident Fund:

(i) In view of the present policy in regard to Contributory Provident Fund, the status quo shall continue.

Consultancy Assignments:

AICTE shall work out a suitable model, for which the models of revenue sharing between institutions and consultant-

teachers prevailing in the Indian Institutes of Technology, Indian Institutes of Management and other institutions may be taken into consideration.

Anomalies of the last PRC:

Anomalies and unimplemented recommendations of the last Pay Review Committee, If any, shall be examined by the AICTE in consultation with the Ministry of Human Resource Development.

Other recommendations of PRC and AICTE;

Recommendations made by the Pay Review Committee and the AICTE in regard to 'the various selection processes, service and working conditions, training/ refresher courses etc. shall be considered appropriately by AICTE with the approval of the Central Government, wherever required, or under the Council's Regulations in accordance with the provisions of the AICTE Act.

Grant for Professional Development

- (i) New faculty entrants may be given a one-time start up grant of Rs. 2 lakh for purchase of computers, teaching material including books, research aids and office furnishings, etc. Existing teachers may also be provided incentive grants up to Rs.2 Lakh for purchase of computer including grants for up gradation of or purchase of a new computer (especially for those who have availed such facilities on earlier occasions) teaching material including books and research aid.
- (ii) All teachers may be given a grant up to Rs.2 lakh on reimbursement basis for a period of three years towards acquiring the membership of Professional Societies and for participating in national / international conferences / workshops etc.

Applicability of the Scheme:

- (i) This Scheme shall be applicable to teachers in Technical Institutions and other equivalent cadres of Library in ail the AICTE approved institutions. The implementation of the revised scales shall be subject to the acceptance of all the conditions mentioned in this letter as well as Regulations to be framed by the AICTE in this behalf.
- (ii) This Scheme does not extend to the posts of professionals like System Analysts, Senior Analysts, Research Officers etc. who shall be treated at par with similarly qualified personnel in research/scientific organizations of the Central Government.
- (iii) This Scheme may be extended to all technical Institutions coming under the purview of State legislatures, provided State Governments wish to adopt and implement the Scheme subject to the following terms and conditions:

Financial assistance from the Central Government to State Governments opting to revise pay scales of teachers and other equivalent cadre covered under the Scheme shall be limited to the extent of 80% (eighty percent) of the additional expenditure involved in the implementation of the revision.

The State Government opting for revision of pay shall meet the remaining 20% (twenty percent) of the additional expenditure from its own sources.

Financial assistance referred to in sub-clause (a) above shall be provided for the period from 1.01.2006 to 31.03.2010.

The entire liability on account of revision of pay scales etc. of teachers of AICTE approved Institutions shall be taken over

by the State Government opting for revision of pay scales with effect from 1.04.2010.

Financial assistance from the Central Government shall be restricted to revision of pay scales in respect of only those posts which were in existence and had been filled up as on 1.01.2006.

State Governments, taking into consideration other local conditions, may also decide in their discretion, to introduce scales of pay higher than those mentioned in this Scheme, and may give effect to the revised bands/ scales of pay from a date on or after 1.01.2006; however, in such cases, the details of modifications proposed shall be furnished to the Central Government and Central assistance shall be restricted to the Pay Bands as approved by the Central Government and not to any higher scale of pay fixed by the State Government(s).

Payment of Central assistance for implementing this Scheme is also subject to the condition that the entire Scheme of revision of pay scales, together with all the conditions to be laid down by the AICTE by way of Regulations and other guidelines shall be implemented by State Governments and technical institutions coming under their jurisdiction as a composite scheme without any modification except in regard to the date of implementation and scales of pay mentioned herein above.

Date of implementation of revised pay and allowance and payment of arrears:

- (i) The revised Pay and revised rates of Dearness Allowance under this Scheme shall be effective from 1.03.2006. The revised rates of all other applicable allowances such as House Rent Allowance, Transport Allowance, Children Education Allowance etc. and the non-compounded advance increments shall take effect from 1.09.2008.
- (ii) Payment of arrears up to 40% of the total arrears shall be made during the current financial year i.e. 2009-10, after deduction of admissible income tax.
- (iii) An undertaking shall be taken from every beneficiary under this Scheme to the effect that any excess payment made on account of incorrect fixation of pay in the revised Pay Bands or grant of inappropriate Pay Band/ Academic Grade Pay or any other excess payment made shall be adjusted against the future payments due or otherwise to the beneficiary in the same manner as provided in this Ministry's O.M. No. F.23-7/2008-IFD dated 23.10.2008., read with Ministry of Finance {Department of Expenditure} O.M.NO.F.1-1/2CQ8-IC dated 30.8.2008.

The revised Pay in the relevant Pay Band and the Academic Grade Pay together with the applicable allowances including arrears of salary as mentioned above shall be paid to all eligible beneficiaries under this Scheme pending issue of Regulations by the AICTE.

This Scheme is subject to the guidelines issued by the Ministry of Finance (Department of Expenditure) vide OM No. 7-23/2008-E.III dated 30.09.2008.

Anomalies, if any, in the implementation of this Scheme may be brought to the notice of the Department of Higher Education, Ministry of Human Resource Development, for clarification/decision of the Central Government.
