घटनाक्रमाशी संबंधित मुळ कागदपत्रे व अनुषंगिक महत्त्वपूर्ण
दस्तऐवज या अंकामध्ये प्रसृत करण्यात
आले आहेत.

प्रस्ताविक

“Whereas it is expedient to establish an association of teachers in the University and in the Colleges affiliated to Nagpur University, with a view to promoting solidarity, efficiency and welfare and to improving and safeguarding their interest, we the University teachers assembled this day, the 17th of March 1963, do hereby give to ourselves this constitution.” अगदी सुरुवातीलाच उपरोक्त उद्देशपत्रिका नमुद असलेली संघटनेची घटना आमसभेने १७ मार्च १९६३ रोजी स्वीकृत केली व संघटनेची स्थापना झाली.

२. १ मे १९८७ च्या नुटा बुलेटीनच्या अंकात (पृष्ठ २०) संघटनेच्या सचिवांनी माजी पदाधिकाऱ्यांना लिहिलेल्या पत्रात असे नमूद केले होते की, “नागपूर विद्यापीठ शिक्षक संघाच्या (नुटाच्या) उपलब्ध असलेल्या घटनेमध्ये संघटनेची स्थापना दिनांक १७ मार्च १९६३ रोजी झाल्याचे नमूद करण्यात आलेले आहे. स्थापनेचा हा दिनांक लक्षात घेता नुटाच्या स्थापनेला दिनांक १७ मार्च ८८ रोजी २५ वर्षे पूर्ण होतात. त्या निमित्ताने संघटनेचा रौप्य महोत्सव १९८८ च्या मार्च महिन्यामध्ये साजरा करण्याचे नुटाच्या कार्यकारी मंडळाने ठरविले आहे. या रौप्य महोत्सवाच्या निमित्ताने नुटा बुलेटीनचा एक विशेषांक काढण्याचेही ठरविले आहे.” याच पत्राच्या शेवटी असे नमूद करण्यात आले होते की, “नुटाचे पदाधिकारी व सदस्य या नात्याने आपला संघटनेशी जवळून संबंध आलेला आहे. १९६३ ते १९७६ या कालखंडातील संघटनाविषयक माहिती उपलब्ध होण्यासाठी आपल्या सहकार्यांची अत्यंत आवश्यकता आहे. ती माहिती आपण भरून पाठवावी यासाठी एक विवरणपत्र सोबत दिले आहे. आपण ते भरून पाठविल्यास १९६३ ते १९७६ या कालखंडातील तथ्ये संकलित करण्यास फार मोठी मदत होईल. निरनिराळ्या ११ पदाधिकाऱ्यांनी त्यावेळी माहिती भरून पाठविली (ही माहिती याच अंकात पृष्ठ ५३५ वर दिलेली आहे)

३. संघटनेच्या पदाधिकाऱ्यांनी त्यावेळी अनेक माजी पदाधिकाऱ्यांच्या प्रत्यक्ष भेटी घेऊन अशी माहिती मिळविण्याचा प्रयत्न केला. त्यावेळचे संघटनेचे सहकार्यवाह व विद्यमान कार्यवाह डॉ.एकनाथ कठाळे यांनी संघटनेचे संस्थापक सचिव प्रा. र.वि.रानडे यांच्याशी याबाबत संपर्क साधला असता “तुमच्या या लहानशा प्रोफॉर्म्यामध्ये कितीशी माहिती बसणार?” अशी सुरुवात करून संघटनेच्या स्थापनेच्या कालखंडाशी संबंधित असलेल्या अस्सल व मूळ कागदपत्राचा समावेश असलेली व काळजीपूर्वक लावून ठेवलेली एक फाईलच त्यांनी प्रा. कठाळे यांच्या स्वाधीन केली. ठरलेल्या व्यवस्थेप्रमाणे प्रा. कठाळे यांनी ती फाईल त्याचवेळी तातडीने माझेकडे रवाना केली.

४. १९८७ मध्ये झालेला ५१ दिवसाचा संप व त्यानंतर १९८८ मध्ये सुरू झालेला ३७ दिवसांचा संप १९८९ वर्ष उजाडले तरी संपलेला नव्हता. १९८८ मध्ये संपाच्या निमित्ते एकामागून एक विशेष बुलेटीनचे प्रकाशन झाले. १३ डिसेंबर १९८८ ते २३ डिसेंबर १९८८ या कालखंडात (सुटीचा दिवस वगळून) दररोज नुटा बुलेटीनचा एक विशेष अंक, असे एकूण ९ विशेष अंक नागपूर येथून प्रकाशित झालेत. त्या काळात माझा मुक्कामच नागपूरला होता. एका बाजूला आंदोलनाची धावपळ व त्याचवेळी बुलेटीनचे अनेक विशेष अंक प्रसिद्ध करण्याची स्थिती टाळता येण्यासारखी नव्हती व त्यातून संघटनेच्या आर्थिक स्थितीवर आलेल्या दडपणामुळे १९८८ या वर्षात संघटनेचे रौप्य महोत्सवी वर्ष पाहिजे त्या पद्धतीने साजरे करता आले नाही. १९८८ या रौप्य महोत्सवी वर्षामध्ये त्यानिमित्त १८ मार्च १९८८ रोजी दुपारी नागपूर येथे नुटाच्या कार्यकारी मंडळासोबत संघटनेच्या माजी अध्यक्ष व सचिवांची एक संयुक्त बैठक बोलाविण्यात आली होती. या बैठकीला डॉ.एस.ए.देशपांडे, अॅड. पी.एन.चांदूरकर, प्रा. यादवराव वडसकर, प्रा.म.ना.लोही व डॉ. के.जी.देशमुख हे माजी अध्यक्ष आणि प्रा.र.वि.रानडे, प्रा.पुरुषोत्तम मेहता, प्रा.आनंदराव ब्राम्हणकर व अॅड. गुरुचरणसिंह हे माजी सचिव उपस्थित होते. रौप्य महोत्सवी वर्षानिमित्त गुरुनानक भवन, नागपूर येथे दिनांक १७ एप्रिल १९८८ रोजी नुटाची विशेष आमसभा बोलाविण्यात आली होती. नुटाचे माजी अध्यक्ष व सचिव यांचा ऋणनिर्देशात्मक सत्कार या सभेमध्ये करण्यात आला.

५. संघटनेच्या रौप्य महोत्सवानिमित्त नुटा बुलेटीनचा विशेषांक १९८८ मध्ये प्रकाशित होऊ शकला नाही व त्यामुळे रानडे सरांच्या कडून आलेली मूळ कागदपत्रांची ही फाईल ‘अति सुरक्षित फाईल’च्या खणामध्ये माझेकडेच ‘सुरक्षित’ राहिली. अत्यंत उत्सुकतेने त्या फाईलचे ‘प्रथम वाचन’ मी संपविले हे खरे असले तरी ती कागदपत्रे प्रकाशात येण्याची शक्यता बरीच पुढे सरकल्याने ‘तपशीलवार वाचनाशिवाय सुरक्षित’ असेच त्या फाईलचे स्वरूप राहिले. नाही म्हणायला प्राचार्य बी.एस.उर्फ डॅडी देशमुख यांच्या षष्ठ्यद्विपूर्तीनिमित्त मी १९९६ च्या नुटा बुलेटीनमध्ये लिहिलेल्या एका लेखामध्ये त्यातील काही संदर्भ मला वापरता आले. तेव्हा उघडलेली ती फाईल पुन्हा ‘सुरक्षित’ मध्ये गेली. नुटा बुलेटीनच्या रौप्य महोत्सवी विशेषांक मालिकेच्या निमित्ताने आज ही मूळ कागदपत्रे प्रकाशात येत आहेत याबद्दल मी माझ्या सर्व सहकाऱ्यांच्या वतीने मनापासून आनंद व्यक्त करित आहे. अत्यंत विश्वासाने रानडे सरांनी संघटनेच्या सुपूर्त केलेले हे वैचारिक धन आता योग्य बँकेत जमा झाल्यामुळे त्या ऋणातून सुटल्याचे समाधान सुद्धा यामध्ये आहेच. या मूळ कागदपत्रातून समाविष्ट असलेल्या मजकुराचे वैभव व श्रीमंती ही वाचकांनी व्यक्तीशः अनुभवावयाची आहे.

६. विशेषांकाच्या तयारीची सुरुवात केल्यानंतर व तपशीलवार वाचनानंतर ही सर्व कागदपत्रे क्रमवार लावण्यात आली. त्यांच्या जादा प्रती तयार करण्यात आल्या. सलग मुद्रिताची प्रत तयार झाल्यानंतर ती रानडे सरांकडे पाठवावी असे ठरले. योगायोगाने ५-६ महिन्यापूर्वी मुंबई-नागपूर प्रवासात त्यांची भेट झाली. इतर बरीच चर्चा झाली. विशेषतः विदर्भ साहित्य संघाबाबतचा विषय त्यांच्या मनामध्ये बराच घर करून होता. मुख्यमंत्र्यांना दिलेल्या त्याबाबतच्या त्यांच्या एका निवेदनाची प्रत त्यांनी माझ्या सुपूर्त केली. खूपच जिद्दाळ्याने ते त्या विषयावर बोलत होते. या उतार वयात सार्वजनिक संस्थांच्या संचालनाबाबतची त्यांच्या बोलण्यातून, निवेदनातून व्यक्त होणारी चिंता मनाला चटका लाऊन जाणारी होती. चर्चेमध्ये मी नुटा बुलेटीनच्या विशेषांकाचा विषय काढला व मूळ प्रत तसेच मुद्रित प्रत आपण नजरेखालून घालावी अशी त्यांना विनंती केली व ती त्यांनी आनंदाने मान्य केली. त्यानंतर काही दिवसांनी संघटनेचे सचिव डॉ.एकनाथ कठाळे यांनी रानडे सरांची प्रत्यक्ष भेट घेऊन मूळ प्रत व मुद्रित प्रत त्यांचेकडे अवलोकनार्थ सोपविली. अवलोकनोत्तर प्रत परत घेण्यासाठी डॉ.एकनाथ कठाळे त्यांच्याकडे गेले असता रानडे सरांनी त्याबाबत “एकही कागद तुम्ही वगळला नाही हे बरे केले. पण उपस्थिती पत्रकावरील स्वाक्षऱ्या किंवा पत्रावरील स्वाक्षऱ्या या बुलेटीनमध्ये कशा येवू शकतील?” अशी विचारणा केली. त्यावर “काय करता येईल ते पाहू. प्रयत्न करता येईल.” असे डॉ. कठाळे यांनी सांगितले. या निरोपासह प्रा. कठाळे यांनी मुद्रित प्रत माझेकडे परत पाठविली. एवितेवी उन्हाळ्यानंतरच बुलेटीन काढण्याचे ठरले होते. त्यामुळे मुद्रित पानांच्या पुनर्रआखणीसाठी वेळ मिळाला. प्रा. सुशील काळमेघ यांनी स्कॅनिंगच्या अद्यावत तांत्रिक कौशल्याचा वापर करून त्या फाईलमधील सर्व उपस्थितांच्या स्वाक्षऱ्या बुलेटीनमध्ये उतरविल्या. मूळ कागदपत्रावर येथे काही मथळे वगैरे टाकण्यापेक्षा मूळ कागदपत्रे जशीच्या तशी ठेवून त्या कागदपत्रांची अनुक्रमणिका तयार करून त्या अनुक्रमणिकेमध्ये त्याबाबतचे तपशील दिले आहे. कागदपत्रांना क्रमांक हे कालक्रमानुसार दिले आहेत.

७. या अंकाला रानडे सरांनी प्रस्तावना लिहावी असे प्रस्तावित होते. ५-६ दिवसापूर्वी प्रत छापून झाल्यावर व कव्हरपृष्ठ छापण्यापूर्वी या अंकाला प्रस्तावना लिहावी म्हणून डॉ.एकनाथ कठाळे यांनी संपर्क साधण्याचा प्रयत्न केला असता रानडे सर पुण्याला गेले असून तेथे त्यांचा मुक्काम यावेळी थोडा जास्त आहे, असे कळल्याने हे प्रस्तावनेचे दोन शब्द मी लिहिले आहेत. संघटनेच्या स्थापनेच्या कालखंडात उगमस्थानाजवळ उपलब्ध असलेले विचारांचे झरे, पाझर व प्रवाह नस्तिबद्ध करून ठेवल्याबद्दल व विश्वासाने ते संघटनेच्या सुपूर्त केल्याबद्दल संघटनेचे प्रथम सचिव प्रा.र.वि.रानडे यांना मी मनापासून धन्यवाद देतो, त्यांचे आभार मानतो व हे दोन शब्द संपवितो.

PROCEEDINGS OF THE NAGPUR UNIVERSITY TEACHERS' CONVENTION 30th June and 1st July, 1962.

On receipt of the request from some teachers in Nagpur University, assembled in an informal meeting on 7th January, 1962, the Nagpur University Teachers' Club at its General Body meeting on 9th March, 1962 decided to hold a convention of teachers in Nagpur University on 30th June and 1st July, 1962. The convention, it was thought would provide members of the University teaching fraternity an opportunity to come closer and help in their endeavour to evolve a working forum for University teachers. The Managing Committee of the Club appointed a Steering Committee consisting of the following members to prepare and work out the plans of the Convention.

Members : Dr. V.G. Hatvalne, Prof. G.A. Puranik, Dr. M.G. Bokare, Prof. C.V.N. Rao, Prof. Ajaya Mitra, Dr. Lall, Dr. K.R. Nanekar, Prof. (Mrs.) T. Bagaddeo, Principal Velankar, Dr. Tungar, Dr. R.K. Jain and Prof. R.V. Ranade. The Committee elected Dr. R.K. Jain as Treasurer and Prof. R.V. Ranade as Secretary of the Convention.

Prof. M.G. Vaidya, President of the University Teachers' Club was elected Chairman of the Reception Committee of the convention and members of the Managing Committee of the Club were requested to assist Prof. Vaidya in enrolling membership of the Reception Committee.

Circular letters containing agenda of the Convention were despatched to all teachers in Colleges and Departments in the University in the 3rd week of June, 1962. The steering Committee resolved to invite Shri Shantilal Shah, Minister for Education, Government of Maharashtra to inaugurate the convention. The programme was formulated as under :-

With the stipulated end in view, the members of the committee contacted teachers in various colleges and ascertained their views. The Committee then, after much deliberation, came to the conclusion that a representative body of teachers should **undertake such activities as are conducive to the all-round betterment and enrichment of the University and College teachers as a class.** This can only be done by widening the activities of the Club. The Committee felt that this could most effectively be done **if the present University Teachers' Club were transformed into an Association of University and College teachers.** Accordingly, the Committee **drafted the Articles** of the proposed Association for approval and final adoption by the general meeting of the University Teachers' Club.

We, therefore, recommend that the **draft appended herewith** may kindly be cyclostyled and circulated among all the members of the Club and other University and College Teachers. We also recommend that a general meeting of the Club be convened at an early date for the above purpose.

RESOLUTIONS.

The Convention was attended by 250 delegates from 33 colleges and Departments (**Appendix "A"**) in the University. 225 Delegates were from local Colleges and Departments and 25 from the Colleges outside Nagpur.

Total Expenditure of the Convention was Rs. 1800/- (**Appendix "B"**).

DRAFT ARTICLES OF THE ASSOCIATION

PREAMBLE

Whereas it is expedient to establish an association of Teachers in the University and Colleges affiliated to the Nagpur University with a view to improving and safeguarding their academic, professional and economic interests, we, the teachers of Nagpur University assembled this day do hereby adopt this constitution.

I. NAME: This association shall be called the Nagpur University Teachers' Association which hereinafter shall be referred to as the Association.

II. AIMS AND OBJECTS : The aims and objects of the Association shall be :

- (a) to promote and safeguard the academic, professional, and economic interests of the teachers;
(b) to promote the cause of University education;
(c) to develop a corporate life among the members of the teaching profession; and
(d) to secure for the teachers their proper place in the new social order.

III MEMBERSHIP : Membership of the Association shall be open to the teachers of colleges and institutions affiliated to, or maintained by, the Nagpur University, on payment of an annual subscription of Rs. 3/- only.

IV. ORGANS : The Association shall have the following organs :

(a) **The General Body** consisting of all the members of the Association.

(b) **The Executive Committee** consisting of the office-bearer of the Association (namely, the President, the two Vice-Presidents, the Secretary, the Joint Secretary, and the Treasurer); and five other members.

(c) **The Standing Committees :-**

- (1) The Committee on Academic Matters;
(2) The Committee on Social Activities; and
(3) The Committee on Professional Interests.

Each Standing Committee shall consist of five members of whom four shall be elected by the General Body and one nominated by the Executive Committee. Each Standing Committee shall elect one of its members as its convener.

V. FUNCTIONS AND METHOD OF WORKING :

(a) The General Body shall :

- (1) hold two meetings every year, - one in the first term and the other in the last term of the academic session :

An emergent meeting of the General Body may be called by the President upon requisition in writing, either by the Executive Committee, or by one-fourth of the membership of the Association;

(2) elect office-bearers and members of the Executive Committee and the Standing Committees;

(3) sanction the budget for the current session;

(4) discuss and adopt the reports submitted to it by the Executive Committee; and

(5) take up any other matter for discussion pertaining to the aims and objects of the Association.

(b) The Executive Committee shall; :

(1) meet at least once a month;

(2) prepare the annual budget and place it before the General Body;

(3) prepare an annual report on the working of the association and place it before the General Body;

(4) transact the business entrusted to it by the General Body and any other matter incidental to its duties and functions;

(5) consider the reports submitted to it by the Standing Committee and take such action as it deems necessary; and

(6) prepare general rules of procedure regarding administrative and financial matters subject to the approval of the General Body.

(c) The Standing Committee shall :

(1) conduct such business as may be referred to them by the Executive Committee;

(2) prepare and submit reports on their working to the Executive Committee; and

(3) organize, in consultation with the Secretary of the Association, various activities pertaining to their respective spheres.

VI. GENERAL PROCEDURE :

(a) Elections :- The office-bearers and members of the Executive Committee and the Standing Committees shall be elected by the General Body from amongst its members at its meeting in the last term of the academic session.

(b) Quorum :- (1) For the General Body meetings the quorum shall be one-fifth of the total membership of the Association; and

(2) for the Executive Committee it shall be five of whom one must be other than the office-bearers.

VII. FUNDS :

The Treasurer shall be the custodian of the funds of the Association who shall be responsible for maintaining credit and debit accounts of the Association. The funds shall be deposited with a scheduled bank at Nagpur and the account shall be operated jointly by the Secretary and the Treasurer of the Association.

Auditors :- The General Body shall appoint auditors every year.

VII. OFFICE : The office of the Association shall be located at Nagpur.

IX. DISSOLUTION :-

The Association shall be dissolved only on the decision taken by the majority of the total membership of the Association at a specially convened meeting of the General Body. The same meeting shall decide upon the disposal of the properties of the Association in accordance with law.

One clear month's notice shall be necessary for convening such a meeting.

X. AMENDMENT : (1) The proposal to amend the Constitution may come with fourteen clear days' notice either from the Executive Committee or from one-fifth of the total membership of the Association;

(b) The Constitution shall stand amended if the proposal is approved by a majority of the total membership of the Association and by a majority of not less than two-thirds of the members present and voting .

The Inaugural function was presided over by Principal S.L. Pandharipande, Prof. M.G. Vaidya, President of the University Teachers' Club welcomed the chief guest and the delegates and invited their attention to the undesirable influence operating in sphere of University Education. Prof. R.V. Ranade, Secretary of the Convention in his report dwelt on the desirability for holding the convention and mentioned some of the issues to be taken up for deliberation during the Convention. He invited Education Minister's attention to the share of Government Grants to Nagpur University in comparison with other Universities in the State of Maharashtra. **Shri Shantilal Shah while inaugurating the Convention saw nothing wrong in establishing Association of University teachers**, provided they were not reduced to the level of trade unions. He exhorted the teachers to establish their own Colleges.

Principal Pandharipande in his presidential remarks observed that the Government of Maharashtra, if they mean to do it, can easily meet some of the urgent demands of the University teachers without any heavy financial involvements. He especially referred to the dearness allowance issue.

Dr. R.K. Jain proposed vote of thanks. After the inaugural function, the chief guest joined the delegates and other invitees at tea table.

Discussions on subjects 1 to 6 were conducted simultaneously at three sectional meetings and the 7th subject was discussed at the general meeting of the delegates. In the Sectional Meetings no formal papers were submitted for discussion. The participating delegates exchanged facts, ideas and opinions on the broad points enumerated in the agenda. The meetings were conducted informally on the basis of general participation. The Sectional Presidents by making preliminary observations initiated discussions. The participants offered their view points. The facts, ideas and opinions thus were thrown into the hopper of round table discussion. The sectional meetings after discussions drafted resolutions for submission to the General Body of the Convention for consideration.

PROCEEDINGS OF THE SECTIONAL MEETINGS.

(1) Sectional Meeting on "Problems concerning organization of Teaching and Research" held on 30th June, 1962 at 6.30 p.m. Chairman : Dr. N.R. Deshpande. Rapporteur : Dr. V.G. Hatvalne.

The discussion was initiated by Dr. N.R. Deshpande. He outlined the scope of discussion and requested the participants to give concrete suggestions pertaining to teaching and research. The meeting deliberated on questions regarding library facilities, co-operative research, work load, courses in research methodology, grouping of subjects and number of students in the class.

The suggestions were formulated into resolutions for submission to the General Body.

(2) Sectional Meeting on "Norms of Conduct of University Teachers held on 30th July, 1962, at 6.30 p.m. Chairman : Dr. R.K. Jain. Rapporteur : Prof. (Mrs.) T. Bagaddeo.

The meeting discussed the issue on the points enumerated in the agenda. The consensus of opinion was that the teachers should not normally take up tuition work. He should conscientiously perform his duties in the College and render his obligations unto the Community by delivering popular lectures. The meeting did not feel it desirable to frame formal resolutions in this regard.

(3) Sectional Meeting on "Principles regarding University Examinership and other remunerative work in the University", held on 30th June, 1962 at 6.30 p.m. Chairman : Dr. D.G. Moses. Rapporteur : Prof. S.A. Deshpande.

Dear Mr. Ranade,

I did receive your copy of the new Constitution of the University Teachers' Club as modified at the General Meeting. I do thank you and your Committee for all the work they have put into this.

The Managing Committee of the U.T.C. had a meeting with the members of the Committee appointed to consider the changes in the Constitution last week and two points emerged from this discussion :-

(i) The aims & objects have to be re-stated to make it possible for Government College teachers to be members of the Club. As it stands now, a large number of Government College teachers say they cannot be members.

(ii) Pending consideration of this point, the Club will continue its activities till the General Body meeting in July when whatever is finally decided upon as the new constitution will be accepted by the Club.

You may arrange the next meeting of the Club sometime soon and it will be a final discussion on General Education. I hope you will be able to be present.

The meeting was attended by about thirty delegates. The discussions were centred round the points mentioned in the agenda. Positive recommendations pertaining to the points were made in the form of resolutions.

(4) Sectional Meeting on "service conditions of University Teachers" held on 1st July, 1962 at 8.30 a.m. Chairman : Prof. D.S. Viridi. Rapportur : Prof. V.R. Soman

The meeting was attended by about 25 delegates. The agenda was discussed point by point. The meeting also discusses service conditions of teachers in the Departments and Institutions maintained by the University. The meeting expressed concern at the fact that the service conditions provided by the University for its own teachers do not compare favourably with those prescribed for the teachers in affiliated Colleges. The meeting made certain recommendations in the form of resolutions.

(5) Sectional Meeting on "College Code" held on 1st July, 1962 at 8.30 a.m. Chairman : Principal, S.L. Pandharipande. Rapporteur : Prof. N.G.S. Kini.

The meeting was largely attended. About 50 delegates participated in the discussions. Initiating the discussion, Principal Pandharipande observed that the new College Code was an improvement over the old one. He pointed at the new features relating to (i) the definition of Foundation Society, (ii) institution of new grades (iii) retirement of Principals. Principal Pandharipande emphasised that success of the Code depends upon the Co-operation of the four parties involved in the working of Colleges viz. - the management, teachers, Principal and the University.

On the question of proper relations between the Foundation Society and Governing Body and particularly the autonomy of the latter in financial matters, Prof. Ranade drew pointed attention to the fact that instances are not lacking wherein Grants, donations, loans which are received in the name of College are transferred to the Foundation Society. That the funds of the Parent Body wax during the Local enquiry and wane soon after.

He also drew attention to the fact that many Colleges do not operate provident fund for staff on the ground that they are not appointed on a written contract.

Prof. Nagarajan made a plea that the existing representation of the staff on Governing Body is inadequate, and urged for parity of representation to the staff.

On the question of exemption from the applicability of College Code to Colleges, Prof. M.G. Vaidya made a plea for abolition of exemption to any College on any pretext. Prof. Chandurkar drew attention to the glaring differences in Pay drawn by teachers in Saugar University and in Vidarbha and he attributed this to the Non-observance of College Code.

On the question of inadequacies in the provisions of the Code, Prof. Patil submitted that the old Sr. Lecturers have not, in many cases classified as Asstt. Professors. He also urged along with many others, that under the existing circumstances, the research qualification for the post of Asstt. Professor should be deleted on the ground that it merely enabled the management not to operate the posts even when there were more qualified otherwise, as nothing in the provisions compelled the management to operate the posts.

Another inadequacy pointed out by Prof. S.A. Deshpande related to the representation of Permanent Staff on the Governing Body. Prof. Nagarajan moved a resolution on the question of the qualifications of the Principal. Making a powerful plea on this issue, Prof. Ranade urged that the qualifications of a Principal who is an academic superior should not be less than those prescribed for Professors and Asstt. Professors who are expected to work under him. The appointment of the Principal by the Foundation Society made the position primarily a political one. Dr. Deshpande who also spoke on the subject expected the Principal at least to teach.

Under the head "inadequacies" Prof. Nagarajan

demanded circulation of the budget of the College among the permanent members of the Staff.

The meeting accepted another resolution by Prof. Padhye on the scales of tutors and demonstrators.

For want of time, the meeting could not fully discuss the issue concerning periodic inspection on the implementation of College Code.

(6) Sectional meeting on "Financial problems of the Colleges and University" held on 1st July, 1962 at 8.30 a.m. Chairman : Principal P.W. Urdhwareshe, Rapporteur : Dr. M.G. Bokare.

The general features of the financial needs and the sources were initiated for discussion by the Chairman. He emphasised the need to discuss the problems in view of the needs of the new Colleges in rural areas as well as the consolidation of the academic needs of the growing University.

The State being the most important social welfare agency, the policies in respect of grants-in-aid need reorientation to suit the educational needs at the University standard. The old relationship between the parent body and the College, it was indicated, has resulted in some cases in assigning secondary role to the College governing bodies in looking after the academic and professional standards in education. In some cases, the authorities refuse to deal with parent bodies, for example University Grants Commission. While in other cases the College being a non-registered society does not constitute a legal entity. It is necessary to examine these problems and relationship within themselves and between them and outside authorities.

The members pointed out the inadequate public control exercised over the finances and the Colleges. The public institution like the College must make its account, budgets etc. conform to the needs of the public accountability. The State Government should be requested to prescribe a proforma, like that of the Indian Public Limited Companies, for the income expenditure account and statement of assets and liabilities. The need for Government annual audit of all the College accounts was pointed out. Every College should publish its annual account in the prescribed proforma in one of the local papers and the copy of the same should be made available to a guardian of the College student on a nominal fees not exceeding five rupees. The University should give an abstract of annual accounts of the constituent Colleges in its annual report submitted to the Court.

The problems of immediate importance were pointed out. First the College surplus should not be transferred to the other institution of the same parent body. Second, the Amalgamated Fund should be administered by a representative committee on the lines of the Government Colleges.

The Nagpur University has grown in size and its financial requirements need detailed study. The State Government should be approached to be liberal in the matter of annual grant, comparable to the grants to other sister universities in the State. It was also pointed out that the Nagpur University has not fully explored the University Grant Commission resources. This is evident from a comparative study of how other universities have drawn funds from University Grants Commission. The State Government was also requested to revise and publish the manual of grant-in-aid. This would eliminate the administrative delays and rationalise the financial flow of state funds.

A few formal resolutions were submitted for the approval of the general meeting.

(7) Meeting on "Reorganization of the University Teachers' Club" held on 1st July, 1962 at 10.30 a.m. Chairman : Prof. M.G. Vaidya. Rapporteur : Prof. S.A. Deshpande.

The discussion began with opening remarks by the Chairman Prof. Vaidya that there was a prevalent view that the activities of the University Teachers' Club need to be expanded.

Prof. R.V. Ranade placed before the Committee two aspects of the question. viz. (1) Enlarging the activities and sphere of the University Teachers' Club to make it a truly representative association letting the University Teachers' Club continue as it deems fit. He further pointed out that

the convention was not competent to discuss the reorganization of the University Teachers' Club. It was a matter to be taken up by the club itself. **The Convention should resolve to form a new association of Nagpur University Teachers.**

(6) BROAD POINTS OF DISCUSSIONS.

1. Problems concerning organization of teaching and research :

(i) Physical conditions - Class-rooms, number of students in a class and in the College, total accommodation, play-fields, etc. Specifications of the Educational Manual and by the University Grants Commission in these matters. The actual conditions in the Colleges in Nagpur University;

(ii) Academic requirements-teacher student ratio, laboratory and library equipments, recruitment of the teaching staff as per University regulations;

(iii) Workload to be given to the teachers at different levels of teaching;

(vi) Grouping of the subjects at undergraduate level;

(v) Criteria for the selection of students for Post-graduate studies, should there be any restriction on the size of the Post-graduate class?

(vi) Should third division be abolished ?

(vii) Sufficient incentive and encouragement to students by way of scholarships, stipends, freeships, prizes, etc.;

(viii) Library facilities to the teachers and separate cabins for them to work in the Colleges;

(ix) Programme of subsidy to be paid to the teachers to encourage them to build up their own Libraries and purchase necessary equipments;

(x) Research activity as an ingredient of University teaching, Research methodology courses for teachers and post-graduate students. Seminars and workshops. Dissertations at post-graduate studies.

(xi) Problems of teachers in conducting research-Financial-Research Scholarships, Concessions and subsidies, time and leisure, teaching load, study leave, etc. Other facilities- availability of research material and equipment, Research Bureau at the University level to direct and coordinate and to help the researchers.

(xii) Rationalization of time and procedure in adjudging the research work. - Publication of the research work, Enumeration of the fields of research in different Faculties by the University.

2. Norms of the Conduct of University Teachers :

(i) Taking up of tuition work by University teachers;

(ii) Delivering a minimum number of periods for each subject;

(iii) Delivering series of extension lectures on selected topics for the benefit of citizens;

(iv) Judicious combination of lectures, class notes and tutorials;

(v) Publishing of guides, shortcuts, etc.

(vi) Acceptance of examination work commensurate with qualification and availability of time.

3. Principles regarding University Examinership and other remunerative work in the University:

(i) Minimum experience of teaching for examinership at various levels;

(ii) Preparation of standing list of qualified examiners (Internal and External) for various examinations;

(iii) Adherence to the recommendations of the boards, faculties and the Academic Council regarding examinerships;

(iv) Necessary changes in the appointment of paper-setters and moderators --appointment of board of examiners in place of setters for separate papers, discontinuation of the appointment of moderators;

(v) Publishing names of examiners, tabulators, scrutineers and total remunerations paid to them, after the

declaration of results;

(vi) Rotation in the appointment of tabulators and scrutineers. Total period to be fixed, reappointment after the College list is exhausted;

(vii) Fixing a maximum number of consecutive appointments as examiner for a particular subject;

(viii) Prescribing a maximum annual remuneration to be paid to teachers for work connected with University Examination.

4. Service Conditions of University Teachers:

(i) Period of probation and confirmation of services;

(ii) Nature and composition of Selection Committees of different Colleges;

(iii) Provident Fund - rate of subscription, Administration of Provident Fund, recognition of Provident Fund under Income-tax Act;

(iv) Leave Rules;

(v) Triple benefit schemes - Pension, Provident Fund, Gratuity;

(vi) Lien on the permanent post during the probationary employment.

(vii) Staff quarters and medical benefits for teachers;

(viii) Rationalization of allowances.

5. College Code :

(i) Consideration of working of the College Code in different colleges;

(ii) Exemption from the applicability of the College Code to the Colleges;

(iii) Inadequacies in various provisions of the College Code;

(iv) Committees for Periodic Inspection and report on the implementation of the College Code.

6. Financial Problems of the Colleges and University:

(i) Principles regarding grants-in-aid received by the Colleges;

(ii) Financial responsibility of the parent body towards the College;

(iii) Relationship of the College with the parent body vis-a-vis grants and loans received from the Government and other sources; fees and other sources of College income, deficit and surpluses of the College, transfer of College funds to other institutions under the same parent body;

(iv) Administration of the Amalgamated fund;

(v) Budgets and balance-sheets to be filed with University;

(vi) Government audit of the College accounts;

(vii) Financial needs for expanding University Education.

7. Reorganization of the University Teachers' Club:

(i) Need for expanding activities of the University Teachers' Club. Establishments of units at mofussil Colleges, relationship of the new units with the Central Body;

(ii) Types of activities to be undertaken by the University Teachers' Club-recreational, academic, professional. Representing the University Teachers in various matters to appropriate authorities;

(iii) Hoding of annual conventions to deliberate on problems concerning University teaching fraternity;

(iv) Need for studying and changing the constitution of the University Teachers' Club in light of the above considerations.

Dr. N.R. Deshpande pointed out that the problem of association was intimately connected with the role of a teacher as an integral part of Society. He emphasised the need for starting an association but pointed out that technically the University Teachers' Club cannot be transformed into an association by passing a resolution in this Convention.

Referring to the American Association of Teachers, he told that there are three aspects of their activities - (a) Academic freedom, (b) Conditions of Service and fringe benefits and (c) Organisation of teachers as fraternity. **The teachers must assert as teachers and for that purpose an association would be a great asset.**

The discussion was very animated. Prof. B.R. Kulkarni of Yeotmal held that since this Convention cannot decide anything about the University Teachers' Club **it should resolve to form an independent association of Teachers in the Nagpur University.**

It was decided to form an adhoc Committee for (a) framing the Constitution of the proposed association and (b) adoption and execution of this Constitution. The number of members of the Committee was fixed at nine and the following persons were unanimously elected :-

(1) Dr. N.R. Deshpande (2) Prof. D.S. Virdi (3) Prof. M.G. Vaidya (4) Dr. M.G. Bokare (5) Prof. Y.W. Wadaskar (6) Dr. V.G. Hatwalne (7) Prof. A.K. Kelkar (8) Prof. Nagarajan and (9) Prof. R.V. Ranade (Convenor).

The Committee was empowered to co-opt additional members if it was felt necessary. Reports of the Sectional

(1) This Convention of the Nagpur University Teachers resolves that the management of every College shall make every year a matching contribution to a maximum of Rs. 50/- to every teacher working in the College for encouraging him to build up his own personal library in his subject. **Proposed by** Shri B.R. Kulkarni, Amolkchand College, Yeotmal. **Seconded by** Shri M.B. Varnekar, Swavalambi Education College, Wardha. The resolution was **adopted unanimously.**

(2) "Whereas research is increasingly becoming a Co-operative endeavour, this Convention opines, that whatever teachers in this University sponsor Collective research projects the University and/ or the State Government should extend some financial assistance towards the expenses for conducting and publication of the result of such Collective endeavour, subject to proper scrutiny and approval of such projects." **Mover :-** N.G.S. Kini, S.F.S. College, Nagpur. **Secunder :-** P.K. Sunderarajan, S.F.S. College, Nagpur. The resolution was **adopted unanimously.**

(3) This Convention recommends to the Nagpur University that all teachers of the Colleges affiliated to a Department maintained by the University, who have registered themselves for research may be exempted from the payment of the half-yearly retention fees, for a period of 3 years from the date of registration. **Proposer :-** G.P. Sahu, Hislop College. **Secunder :-** V. Nagarajan, Hislop College. **Adopted unanimously.**

(4) This Convention of the Nagpur University Teachers' view with great concern the over-crowding of classes in Colleges which leads to inattentiveness and indiscipline on the part of students and resolves that the maximum number of students in a class shall not exceed 64 students at undergraduate and Post-graduate levels. **Proposed by** Shri B.R. Kulkarni, Amolakchand Mahavidyalaya, Yeotmal. **Secundered by** Shri G.P. Sahu, Hislop College, Nagpur. **Adopted unanimously.**

(5) This Convention of the Nagpur University Teachers resolves that the total work load of teaching assigned to a teacher per week shall not exceed 18 periods - each period of 45 minutes duration - at the Undergraduate level and 12 periods each of 50 minutes duration at the post-graduate level inclusive of tutorials. **Proposed by :** Shri B.R. Kulkarni, Amolakchand College, Yeotmal. **Secundered by :** Shri D.S. Sahastrabudhe, Vidarbha Ayurveda College, Amravati. **Adopted unanimously.**

(6) "Whereas the abolition of III Division degree is likely to improve the Post-Graduate academic standards and also to avoid considerable disappointment to the IIIrd division post graduate students this convention resolves that III Division degree of Post-Graduate level be abolished, and only I and IIrd Division degrees be instituted with 45% minimum marks for the IIrd Division. **Mover :-** N.G.S. Kini, S.F.S. College, Nagpur. **Secunder :-** Shri D.S. Sahastrabudhe, Vidarbha Ayurveda College. **Adopted unanimously.**

(7) Resolved that the University should promote research by instituting a course in research methodology of a short duration and all applicants for Ph.D. be required to undertake this course as a pre-condition. **Proposer :-** Shri Wilkinson **Secunder :-** Shri R.P. Ayachit. **Adopted unanimously.**

(8) Resolved that Colleges should be represented on the University Court by Professors and Readers as Ex-officio members and that the elected members should get representation in a ratio of one to every twenty from amongst the staff subject to the minimum of two. **Mover :-** Dr. B.R. Kate. **Secunder :-** Dr. Tiwaskar. **Adopted by majority.**

(9) This Convention unanimously recommends to the Faculty of Arts, the grouping of subjects at under-graduate level. This would equip the students with knowledge about allied subjects. This would also shorten the duration of the University examination". **Proposed :-** S.V. Khandewale, C.P. and Berar College, Nagpur. **Secunder :-** G.P. Sahu, Hislop College, Nagpur. **Unanimously adopted.**

(10) "Be it resolved that the University Library be so expanded as to become more useful to the research students. The number of books to be issued should be raised from 6 to 10 and the time limit be extended from fifteen days to two months. **Proposed :** S.V. Khandewale, **Secundered :** B.R. Kulkarni, Amolakchand College, Yeotmal. **Unanimously adopted.**

(B) On problems on "Norms of Conduct of University Teachers."

(11) "We delegates to the Convention solemnly pledge that :-

(i) We teachers should conduct ourselves in a manner in keeping with the dignity and responsibility of our profession and not do anything which will bring disgrace or ill reputation to it;

(ii) Discharge our duties without fear or favour;

(iii) Not discriminate among our students on the ground

of religion, caste, sex or financial status;

(iv) Work hard to help our students to become experts in the subjects we teach;

(v) Try to instil the spirit of Good work, discipline, sacrifice and service among our students and help them develop into responsible citizens of India.

(vi) Deliver at least the minimum number of lectures as are necessary for proper understanding of the subject we are teaching.

(vii) Deliver extension lectures for the benefit of Citizens as and when required and thus make our services available to the public for spreading of knowledge.

(viii) Use judicious combination of lectures, class notes and tutorials in the best interest of the students;

(ix) Not write or publish or cause to be published for monetary gains, "Guides" or similar publications which, we regard, have harmful effect on the education of the students.

(x) Accept examination work commensurate with our qualification and availability of time.

It was further recommended that the Nagpur University Teachers Association should appoint a Committee to see that the above Code of conduct is strictly observed in practice by us and any breach in its observance may be publicly censured after impartial enquiry and disobedience of the warning in writing.

(C) On Problems concerning "Principles regarding University Examinership and other remunerative work in the University."

(12) **Resolved** that only teachers should be recommended as examiners. For setting a question-paper the minimum experience should be at least five years for all the examinations. For valuation of answer-books, the minimum experience should be at least three years. With regard to Post-Graduate Examinations, at least five years teaching experience of post-graduate teaching should be considered necessary for appointment as examiners.

(13) **Resolved** that a standing list of qualified examiners (Internal and External) for various examinations should be maintained, that those who are not in touch with teaching should not normally be appointed as examiners, that for Pre-University examination, as far as possible Senior Teachers in the University should be appointed as examiners. Normally no external examiners should be appointed at this examination. That B.A. and M.A. Examinations External Examiners to the maximum extent of 50% be appointed.....**Adopted unanimously.**

(14) **Recommended** that as far as possible, the recommendations of the Boards, Faculties and the Academic Council regarding examinerships, should be adhered to. Those persons whose names are not recommended by the Board of Studies, should not be appointed as examiners.....**Adopted unanimously.**

(15) **Recommended** that a Board of Examiners in place of Paper-Setters for separate papers should be appointed. The appointment of Moderators should be discontinued. This will be a good change and improvement in the examination system.....**Adopted unanimously.**

(16) **Resolved** that ordinarily a valuer should not be allowed to value more than 500 answer-books at one examination. That the names of examiners in different Faculties and subjects along with the amount of remuneration paid to them should be published every year after the declaration of results.....**Adopted unanimously.**

(17) **Recommended** that Tabulators and Scrutineers should be appointed from the Office Staff. In case, however, the present system is continued, it is strongly urged that this work should be given strictly by rotation. A person once appointed should not be appointed for more than three examinations. Teachers from Colleges outside Nagpur

should also be considered for appointment as Tabulators and Scrutineers on the same terms and conditions as are offered to Nagpur Teachers.....**Adopted unanimously.**

(18) Resolved that no person should be appointed as a setter in any paper in a subject for more than two years consecutively.....**Lost by 20 to 10 votes.**

(19) A person should not be paid an amount exceeding Rs. 1000/- during one academic year by way of University Examination remuneration.....**Adopted unanimously.**

(D) On Problems concerning "Service Conditions of University Teachers".

Resolved that there should be one year's probation for every fresh appointment in a clear vacancy in an educational institution (University or College) and confirmation at the end of that period.....**Adopted unanimously.**

(21) Resolved that the Selection Committee envisaged in Rule 39 of the latest College Code should consist of the following four members :-

1. The Chairman of the Managing Body,
2. The Head of the Department of the Subject in which the appointment is to be made.
3. The Principal of the College.
4. The Nominee of the Vice-Chancellor.....**Adopted unanimously.**

(22) Resolved that the following note be appended to clause 51(b) of the Nagpur University College Code - Ordinance No. 50-a.

The responsibility of contribution 10% of the monthly pay of the teacher rests entirely on the Managing Body of the College or the University. **Proposed by** Shri B.R. Kulkarni, Amolakchand Mahavidyalaya, Yeotmal. **Seconded by** Shri M.H. Kherkar, Amolakchand Mahavidyalaya, Yeotmal. **Unanimously adopted.**

(23) Resolved that "the teachers in the teaching departments run by the Nagpur University should get due representation on the University Court on the same basis as given to other Colleges affiliated to the privileges of the University". **Proposed by** Shri P.B. Deodhar. **Seconded by** Shri V.K. Deshmukh. **Unanimously adopted**

(24) This Convention of University Teachers resolves that a permanent teacher of the University or College should be granted study leave for a required period not exceeding 3 years and be paid at the rate of half his average pay during that period. **Proposed by** Shri V.B. Deoras. **Seconded by** Shri G.P. Sahu. **Adopted unanimously.**

(25) Resolved that - All Provident Fund accounts should be duly registered with the Income-Tax Commissioner, Maharashtra State, Poona, with retrospective effect.

Further resolved that a system of paying Gratuity to the employees of the University or College at the end of their long and meritorious service be worked out and introduced at an early date. **Proposed by** Dr. M.G. Bokare. **Seconded by** Shri M.B. Karale. **Adopted unanimously.**

(26) Resolved that lien on a permanent post should be at least for a period of 2 years.....**Adopted unanimously.**

(27) Resolved that "In College Code - Schedule A, Clause 10, the last sentence "the period..... or any part thereof" be dropped.**Adopted unanimously.**

(28) Resolved that in case of illness, the actual medical expenses incurred by a University or College teacher should be reimbursed by the employees as is done in the case of Government Teachers.....**Adopted unanimously.**

(29) Recommended that as far as possible, the University or College authorities should arrange to provide staff quarters to their teachers at reasonable rents as in the case of Government Servants.....**Adopted unanimously.**

(30) "This Convention of Nagpur University and College Teachers resolves that in view of the fact that Colleges

affiliated to the Nagpur University are no longer under the M.P. State, the Dearness Allowance should be paid to them according to the rates of the Maharashtra State and not according to the Old M.P. rates as in the case with most of the Colleges at present".**Adopted unanimously.**

(31) Resolved that "provision be made to pay City Allowance and House Rent Allowance to all University and College Teachers as per the rules for the time being in force in this behalf in the State of Maharashtra". **Proposed by** Shri B.R. Kulkarni, **Seconded by** Shri J.G. Mudaliar,**Adopted unanimously.**

(E) On Problems concerning College Code.

(32) This Convention appeals to the University that as regards the Finance of the College, clauses 6 and 17 of the College Code, may be insisted upon and ensure that the Governing Body of the College is in a position to manage and regulate all the finance, accounts and investments and the general funds of the College are not transferred to the parent body. **Adopted unanimously. Mover** : Shri R.V. Ranade. **Seconded** : Prof. V. Nagarajan.

(33) This Convention recommends that the College Code be so amended as to require the Governing Body of a College to appoint for the posts of Principal, Vice-Principal and Heads of Departments, only the teachers already on the staff of the College and such teachers shall possess the minimum qualification prescribed in the College Code. While observing the principle of seniority, in the case of a Principal of a College with Post-Graduate departments, the qualifications of the Principal shall not be lower than that laid down for a Professor under Clause 45(a) of the College Code and in case of a Principal of a College with undergraduate teaching, it shall not be lower than that laid down for an Assistant Professor under Clause 45(b) of the College Code. **Adopted unanimously. Mover** :- Prof. V. Nagarajan, Hislop College, **Seconded by** :- Prof. S.Y. Namjoshi, Hislop College,

(34) This Convention resolves that every teacher of a College shall have the right to vote, and be a member of the Governing Body of the College. The College Code may be suitably amended in this behalf. **Adopted unanimously. Mover** :- Prof. S.A. Deshpande, S.B. City College. **Seconded** :- Prof. P.D. Padhye, Post-Graduate Department.

(35) This Convention of the Nagpur University Teachers recommends that the pay scale of Tutors and Demonstrators be revised to Rs. 150-10-300. **Adopted unanimously. Mover** :- Prof. P.D. Padhye, Post-Graduate Department. **Seconded** :- Prof. N.S. Vaidya, Hislop College.

(36) This Convention recommends that the College Code be so amended as to require the Governing Body of the College to circulate the budget of the College to the permanent members of the College i.e. the Staff Council. **Adopted unanimously. Mover** :- Prof. V. Nagarajan. **Seconded** :- Prof. G.S. Kini.

(37) This meeting of the University Teachers' Convention resolves that the clause No. 3 of the College Code should be deleted and all the provisions of the College Code should be strictly adhered to. **Adopted with majority. Mover** :- Prof. M.G. Vaidya, **Seconded** :- Prof. S.A. Deshpande.

(38) Resolved that "The resolutions passed by the Governing Body shall become operative without the sanction of the Foundation Society unless it involves any financial liability for the Foundation Society. **Adopted unanimously. Mover** :- Prof. S.A. Deshpande and **Seconded** Prof. P.N. Chandurkar.

(39) This Convention of Nagpur University Teachers strongly recommends that there should be inspection of the actual working of the College Code in various Colleges at regular intervals of 3 years by the University to ensure the due fulfilment of the provisions of the said Code and suitable action be taken against the defaulting Colleges. **Adopted unanimously. Proposed by** Shri R.V. Ranade. **Seconded by** Shri Chandurkar.

(40) This Convention of the Nagpur University Teachers notices the inadequacy of the proviso under clause 3 of the Agreement with members of Staff in Affiliated Colleges in Schedule A and resolves to amend the said proviso as follows :-

Provided that if the College satisfies the Executive Council of Nagpur University that the financial condition of the College is such as to justify a reduction in the rate laid down in this Paragraph the College may pay the party of the first part, at such reduced rate, not being less than the minimum pass prescribed for that post under clause 46 of the New College Code. **Proposed by** Shri B.R. Kulkarni, Amolakchand Mahavidyalaya, Yeotmal. **Seconded by** Shri Nagarajan, Hislop College, Nagpur.**Adopted unanimously.**

(F) On Problem concerning Financial Problems of the Colleges and the University.

(41) **Resolved** that the State Government should formulate a positive liberal policy of grants in aid for the Colleges, and the University, to encourage them to discharge their responsibility in respect of University Education. In this respect of deficit formula should be applied to the higher educational institutions also.**Adopted unanimously.**

(42) **Resolved** that the State Government and the University should appoint a Committee of experts to study the heads of the developing educational institutions, their public accountability of the funds relation of the College with the parent body, and such related matters pertaining to educational institutions.**Adopted unanimously.**

(43) **Resolved** that the Amalgamated Funds should be administered by a Committee consisting of representatives of teachers and students with a view to fully utilise the funds for co-curricular activities with Colleges.....**Adopted unanimously.**

(G) On reorganization of the University Teachers Club.


Resolved that an association of teachers in Nagpur University be established. It was further resolved that an adhoc Committee consisting of the following nine members with powers to co-opt additional members be formed to frame a constitution for the proposed Nagpur University Teachers Association.

(1) Dr. N.R. Deshpande, (2) Prof. D.S. Viridi, (3) Prof. M.G. Vaidya (4) Dr. M.G. Bokare, (5) Prof. Y.W. Wadaskar, (6) Dr. V.G. Hatvalne, (7) Prof. A.K. Kelkar, (8) Prof. Nagarajan, and (9) Prof. R.V. Ranade (Chairman).....**Adopted unanimously.**

At the close of the concluding session Prof. R.V. Ranade, Secretary of the Convention thanked the President and Members of the Executive Committee of the University Teachers' Club for playing host to the first Convention of Teachers in Nagpur University. He also thanked the University authorities for the help rendered by them. Thanks were due to M/S Nagpur Electric Supply Company and M/S Agents and Distributors for supply of fans and to the President of the University Union for keeping the Union building at the Conventions disposal. The Secretary expressed his indebtedness to a number of a professors who were working round the clock and but for whom the Convention would not have been a grand success.

After attending the dinner at 8.00 p.m. the delegates to the Conventions dispersed with a satisfaction of achieving concrete results.

CONSTITUTION OF THE NAGPUR UNIVERSITY TEACHERS' ASSOCIATION

(As adopted on Sunday 17th March 1963)

Constitution of the Nagpur University Teachers' Association
(As adopted on Sunday, 17th March 1963)

Whereas it is expedient to establish an association of teachers in the University and in the Colleges affiliated to Nagpur University, with a view to promoting solidarity, efficiency and welfare and to improving and safeguarding their interest, we the University teachers assembled this day, the 17th of March 1963, do hereby give to ourselves this constitution.

ARTICLE I

Name :- The association shall be called "The Nagpur University Teachers' Association", which hereinafter shall be referred to as the Association.

ARTICLE II

Aims and objects of the Association shall be :-

- (a) To promote corporate feeling amongst members of University teaching profession.
- (b) To secure for them fair conditions of life and work, better emoluments and other rights and privileges as University Teachers.
- (c) To establish contacts with educational organisations with similar aims.
- (d) To promote higher education and research.
- (e) To arrange for travel and study tours within the country and abroad.
- (f) To do all such things as are incidental and necessary in securing for the University Teachers their proper place in the new social order and in general to increase the usefulness and advance in standards, ideals and welfare of the profession.

ARTICLE III

Membership of the Association shall be open to the teachers in the Colleges and in the Institutions maintained by Nagpur University and in the Colleges affiliated to Nagpur University, provided they agree to abide by regulations and bye-laws of the Association in force. Annual membership subscription shall be Rs. 3/-, and for life it shall be Rs. 50/- . Every member of the Association shall be entitled to attend and vote at meetings of the General Body -

ARTICLE IV

Organs of the Association shall be :-

- (a) General Body, consisting of all the members of the Association.
- (b) Executive Committee, consisting of the Office-bearers of the Association, (viz President, two Vice-Presidents, Secretary, Joint-Secretary and Treasurer) five members to be elected by the General Body and two members to be coopted by the Executive Committee.
- (c) Standing Committees, viz :-
 - (i) Committee on Academic matters.
 - (ii) Committee on Social and Recreational matters.
 - (iii) Committee of Reference. Each of the Standing Committees shall consist of seven members of whom six shall be elected by the General Body and one shall be nominated by the Executive Committee. The Committee of Reference shall include as many more members as to be fixed by the Bye-laws of the Association in this respect, representing the Local Branches of the Association and the Local Organisations affiliated to the Association. The same bye-

laws shall regulate the manner in which such members shall be elected.

Each Standing Committee shall elect one of its members as a Convenor. The President of the Association shall act as Chair-man of the Standing Committees.

ARTICLE V

General Provisions :-

- (a) Elections :- Office-bearers of the Association, members of the Executive Committee and of the Standing Committees shall be annually elected by the General Body from amongst its members at its Annual Meeting.
- (b) Local Branches of the Association :- Members of the Association in a town out side Nagpur may form a Local Branch of the Association. Organisation of the Local Branch and its relation with the Head Office shall be governed by the bye-laws of the Association in this respect.
- (c) Local Organisations :- Teacher organisations in Colleges in the jurisdiction of Nagpur University may be affiliated to the Association. Relationship between these Organisations and the Association shall be regulated by the bye-laws of the Association in this respect.
- (d) Disqualification of Membership :- If a member of the Executive Committee, of any of the Standing Committees or an Office-bearer of the Association is without permission of the President absent for three consecutive meetings of the respective Committees, he shall cease to hold office in that Committee.

(e) Quorum :-

- (i) For the General Body meeting quorum shall be one-tenth of the total membership of the Association.
- (ii) For the Executive Committee it shall be five of whom at least one must be other than the Office-bearers.
- (iii) For the Standing Committees it shall be five.

ARTICLE VI

Functions and Method of Working :-

- (a) The General Body shall :-
 - (i) Hold two meetings every year, one in the first term and the other in the last term of the academic session; the latter shall be the Annual Meeting.An emergent meeting of the General Body may be called by the President upon requisition in writing either by the Executive Committee or by one-fourth of the membership of the Association.
 - (ii) Elect Office-bearers and members of the Executive Committee and members of the Standing Committees.
 - (iii) Sanction budget for the ensuing session.
 - (iv) Consider and adopt the accounts and reports submitted to it by the Executive Committee
 - (v) Take up any other matter for its consideration pertaining to the aims and objects of the Association.
- (b) The Executive Committee shall :-
 - (i) Ordinarily meet once a month.
 - (ii) Prepare annual accounts and budget and place them before the General Body.

(iii) Prepare Annual report on the working of the Association and place it before the General Body.

(iv) Transact the business entrusted to it by the General Body.

(v) Consider the reports submitted to it by the Standing Committees and take such action as it deems necessary.

(vi) Recommend to the General Body, affiliation of the Association to wider educational associations; and affiliation of the Local Organisations of teachers in Colleges in the University to the Association.

(vii) Prepare Regulations and Bye-laws for the working of the Association subject to the approval of the General Body.

(viii) Take up any other matter for consideration pertaining to the aims and objects of the Association.

(c) The Standing Committees shall :-

(i) Conduct such business as may be referred to them by the Executive Committee.

(ii) Prepare and submit reports on their working to the Executive Committee.

NAGPUR UNIVERSITY TEACHERS' ASSOCIATION

Bye-Laws for the Local Branches and Local Organizations of the Association

(As adopted on Saturday, 24th August, 1963).

(A) LOCAL BRANCHES:

(1) Members of the Association in a town outside Nagpur may form a Local Branch consisting of all the members of the Association in that town. Minimum membership to for a local branch shall be five.

(2) Members of the Local Branch shall elect from amongst themselves a Chairman and a local Secretary every year.

(3) The Local Secretary shall be responsible for maintaining membership roll of the Local Branch and shall perform all the secretarial work.

(4) The Local Branch shall retain 50 p.c. of the membership subscription for its expenses and the balance shall be sent to the Head Office of the Association.

(5) The Local Secretary shall submit to the Head Office of the Association a report on the working of the Branch along with a statement of account one month before the first meeting of the Association in each Session.

(6) Every Local Branch shall send one representative to the Committee of Reference. The representative shall be elected annually by members of the local branch.

LOCAL ORGANISATIONS :

(1) Teacher Organizations of Colleges in the jurisdiction of the Nagpur University may be affiliated to the Association by the General Body of the Association on recommendation of the Executive Committee of the Association.

Provided that the affiliated local Organisations may be disaffiliated for non-payment of continuation fee in time, and for such activities as may be contrary to the aims and objective of the Association.

(2) Every Local Organisation affiliated to the Association shall pay to the Association -

- an affiliation fee of Rs. 10/-
- a continuation fee of Rs. 5/- per session.

(3) Every affiliated Local Organisation shall send one representative on the Committee of Reference. The representative shall be elected annually by the members of the Local Organisation.

(4) Every affiliated Local Organization shall furnish such reports, returns and information as the Executive Committee of the Association may require.

(5) The affiliated Local Organizations may send their delegates to attend the annual meetings of the Association. The delegates may participate in the proceedings of the meetings but shall not vote.

Minister, Government of Maharashtra draft proposals to consolidate and amend the Nagpur University Act. It is learnt that the Hon. Minister discussed the proposals with Executive Council in the first week of July 1963. It appears that the draft submitted by the University and the one contemplated by the Government have provided for a substantial reduction in the representation to the teachers and principals on the Court and on the Academic Council of the University.

The Nagpur University Teachers' Association appeals to the Teachers in the University to attend the Convention and discuss the changes which are likely to affect the teachers.

The following proposals are placed before the teachers for their consideration. They relate to the composition of the Court, Academic Council and the Executive Council.

Apart from the composition of these three bodies, the Convention would discuss such provisions as would determine the policy of the University with regard to Post-Graduate Teaching and research, admission of Colleges to the privileges of the University, service conditions of teachers etc. The teachers in the Colleges and Departments in the University are requested to attend the Convention.

The Report of the Convention of Teachers in the University held on Saturday, the 24th August, 1963.

The Convention was called by and held under the auspices of the "Nagpur University Teachers' Association" on 24th August, at 3.00 p.m. in the Convocation Hall, in the J.N. Tata Building on Ravindranath Tagore Road, Nagpur.

Prof. S.A. Deshpande of the University Post-Graduate Department, the newly elected President of the N.U.T. Association was in the Chair.

The Convention discussed the proposed amendment of the Nagpur University Act.

President, Prof. S.A. Deshpande, made, at the outset, a short introductory speech calling upon the delegates to enliven the discussion of problem with expressing boldly their views.

Prof. R.V. Ranade, the newly elected Secretary of the Association, thereupon, explained in broad outlines, the nature of the recommendations suggested to the State Govt. by the Academic and Executive Councils of the N.U., He also briefed the Convention on the report of the Association's Delegation's interview with Mr. Shantilal Shah, the Minister of Education of Maharashtra. The interview was not quite so satisfactory, he said.

After that the members were called upon to put forward their views regarding the proposed amendment of the Act. The discussion was confined only to the constitution of the three Chief organs of the University; namely, the Court, the Academic Council, and the Executive Council.

The Constitution of the Court was taken up first for discussion.

The interim Committee of the Association had, after careful and close study of the Act, placed certain proposals relating to the composition of three Chief organs of the University. The discussion was conducted in the light of the Interim Committee's proposals.

The Convention expressed its concern chiefly about the drastic reduction in the Teachers' representation on the University, as proposed by the Govt. and, also recommended by the University. The move was severely denounced by Prof. Kini, Prof. G.M. Kulkarni, Prof. Ranade and others.

Prof. Ranade suggested that the new Act should provide a general constituency for teachers on the lines of the Registered Graduates' constituency and the number of their representatives should be round about 50. The suggestion was supported by Dr. Bokre, Prof. M.N. Chandurkar, and Prof. Ukhalkar.

The suggestion, however, was strongly opposed by Prof. M.G. Vaidya, Dr. N.R. Deshpande, Prof. Kini, Prof. S.B. Wad, Prof. Nemawarkar, Dr. Kate, Dr. Hatwalne, Prof. G.M. Kulkarni and Prof. Shenwai.

In their opinion, the representation should be given college-wise, so that even the smaller and the junior colleges could their representatives to the Court. Dr. N.R. Deshpande cautioned the Convention to guard against the danger of dissention among the teaching fraternity resulting from the acceptance of the general constituency for teachers.

The general consensus of the House was found to be in favour of the college-wise representation to teachers on the Court.

The question then came up as to how many representatives should go to the Court from each college.

Prof. Dr. Bokre opined that the number of the representatives from each college should correspond with the number of faculties in the College.

This view however, was challenged by Mr. G.M. Kulkarni, on the ground that since the Court has little to do with the academic matter, it is not necessary to send faculty-wise representatives.

Mr. Ranade favoured the equal number, as at present, coming from each college.

Prof. M.G. Vaidya, however, upheld the plea that every college should be represented on the Court by entitling every college, however, small, to send at least one representative. In the case of the bigger colleges however, the number might vary according to the number of teachers in the college. Each thirty members will elect one representative. The total number of representatives from a single college, however, should not exceed three. The suggestion was in keeping with the recommendation of the Interim Committee, and was upheld by Prof. D.W. Deshpande and Prof. Tulpule.

The House showed favour to the Interim Committee's recommendation. It also accepted the suggestion that a minimum of two percent of the teachers' representatives should come from the University Departments.

The next item on the agenda, is the discussion of the composition of the Academic Council, was then taken up.

The Interim Committee, in its recommendations had suggested the inclusion in the Academic Council, of only 15 Principals of the affiliated colleges.

The view was supported staunchly by Prof. Kini, Prof. Ranade and Prof. G.M. Kulkarni. Mr. Band, however, insisted on the inclusion of all principals in the Academic Council on the ground that every college must be able to send its academic representative to the Academic Council. This view was upheld by Prof. B.R. Kulkarni, Prof. Sao and Prof. Joshi.

The House voted in favour of the Interim Committee's recommendations.

After that the constitution of the Executive Council was discussed.

Prof. R.V. Ranade supported the recommendations made by the Interim Committee in that regard.

Dr. Hatwalne, however, suggested a slight change. He opined that the number of the Deans going to the Executive Council should not be restricted to 5; since the respective Heads of various faculties should be present in the Executive Council. All Deans of the Faculties should be given seats in the Executive Council.

The House accepted unanimously the suggestions made by the Interim Committee with the modification suggested by Dr. Hatwalne.

After the regular agenda before the Convention was over the Chairman permitted Prof. Kukde of Dhanwate National College to table his resolution to the effect that the Convention should express its concern about the serious predicament of teachers in Sitabai Arts College, Akola. The resolution was seconded by Prof. Ukhalkar, Prof. Shelke and Prof. Gadgil of S.F.S. College.

The President, Prof. S.A. Deshpande pointed out the danger involved in the hasty action on the part of the Association, especially in the absence of any authentic information from the teachers concerned.

His view was shared even by Dr. G.M. Kulkarni.

The House accepted the resolution put up by Prof. Ranade, to the effect that the President of the Association should be authorised to contact some teacher-member from Sitabai Arts College, with a view to procure the genuine information as to the real nature of affairs. He should, after that, the resolution suggested, place his findings before the Executive Committee of the Association.

At the end, the President, Prof. S.A. Deshpande, made a concluding speech.

Dr. G.M. Kulkarni proposed the vote of thanks.

APPENDIX I-A

REPORT ON THE WORKING OF THE NAGPUR UNIVERSITY TEACHERS' ASSOCIATION DURING THE SESSION 1963-64.

About 75 University Teachers assembled on 1st July 1962 in the General Session of the Nagpur University Teachers' convention and established an Association of Teachers in Nagpur University. Draft Constitution of the Association was adopted by the General Body of the Association at its meeting on 17-3-1963.

On 24th August, 1963, the General Body meeting elected Office-bearers of the Association and Members of the various Committees of the Association for the session 1963-64.

On 24th August 1963, a Special Convention of Teachers in the Nagpur University was held to discuss the proposed changes in the Nagpur University Act. A circular containing proposals relating to the composition of the Court, Academic Council and the Executive Council of the University was issued in advance by the Interim Committee of the Association to all teachers in the University. The Convention aroused considerable interest amongst University Teachers since the new legislation meant to affect the Teachers vis-a-vis the University. The convention devoted a full session to the discussion regarding composition of the University Bodies and made certain specific recommendations in light of which the Executive Committee of the Association was directed to prepare a detailed note to be sent to the Government of Maharashtra for their consideration.

The Executive Committee of the Association at its meeting on 5-9-1963, considered the provisions of the New Nagpur University Bill and appreciated the progressive changes incorporated in the New Legislation especially with regard to special representation to Teachers on the Executive council of the University. The Committee appointed a Sub-committee of Shri R.V. Ranade, Shri P.N. Chandurkar and Shri Y.W. Wadaskar to prepare a detailed Note on the provisions of the New Act. The Note was adopted by the Executive Committee at its meeting on 12th October which was immediately forwarded to the Government of Maharashtra for consideration. The Committee authorised the Secretary to meet the Education Minister and others in the Maharashtra Legislature in connection with the New Legislation and impress on them the view point of the Association. The Executive Committee is very happy to mention here that the Note submitted by the Association was very well received by Official as well as Non-official Sections of the Maharashtra Legislature. Almost all the suggestions made by the Association have been incorporated in the Bill by the Joint Select Committee. The Association has undoubtedly played a very vital role in shaping the New Legislation relating to the Nagpur University.

The Committee on Academic matters is preparing a report on the working and evaluation of "Three Year Degree Course" in Nagpur University. The Committee is yet to finalise its report. The Committee of Reference is preparing a Note on the working of Provident Fund in various Colleges. During the enquiry it was found out that a number of Colleges in the University do not have Provident Fund Rules.

The Secretary discussed this matter with the University authorities. It is now learnt that the University has prepared model Provident Fund Rules for the Colleges. The Committee of Reference is yet to finalise its report regarding working of Provident Funds in the Colleges.

During the first year of its existence the Association has emerged as a representative body of the University Teachers. During their visits to a number of Colleges in mofussil areas, the Secretary and the President have noticed a growing awareness of need for the Association. The Executive Committee is aware that the work of the Association has not been as spectacular as some of us expected it to be. It is hoped that in the near future the Association will rise to their expectations.

Till to-day the total membership of the Association is 211 out of which 3 are life members. One of the local Organizations has applied for affiliation to the Association. It is hoped that in the ensuing year a number of local branches of the Association shall be formed at places outside Nagpur.

In view of need for a permanent office accommodation for the Association, it is desirable that a Building Fund is created for the Association. In this respect it is suggested that Government of Maharashtra may be requested to donate a piece of land to locate the Association Building.

5. The meeting considered proposals of the Executive Committee of the Association regarding constitution of the Boards of studies and of the Faculties under the new Act and adopted the following resolutions :-

(1) Boards of Studies :-

"General Body of the Nagpur University Teachers' Association resolves to recommend to the University the following composition of the Boards of studies for a subject or group of subjects to be determined by Statute in this respect to be framed under the Nagpur University Act of 1964.

The number of members of each Board of studies shall be 20, out of which -

- (i) Head of the University Department of that Subject
Ex-officio

or

A Senior Professor in the subject from affiliated Colleges by rotation in case there is no teaching department of the University in the subject concerned.

(ii) Three members to be coopted by the Board, one of whom shall be expert from outside the University and one from the recognised research Institution if any, in the subject for which the Board is constituted.

(iii) Four members to be nominated by the Faculty to which the board belongs out of which one shall be from amongst University Post-Graduate teachers and the three teachers from with not less than 10 years teaching experience in the subject in the affiliated colleges.

(iv) Twelve members with not less than five years teaching experience in the subject to be elected by the teachers in the subject in the University and in the affiliated Colleges."

(2) Faculties :

"General Body of the Nagpur University Teachers Association resolves to recommend to the University the following composition of the Faculties to be determined by Statute in this respect to be framed under the Nagpur University Act of 1964.

Each Faculty shall consist of the following Members -

(i) Heads of University Departments - Ex-officio

(ii) Chairman Boards of Studies - Ex-officio

(iii) Heads of Departments with

rank of professors in the affiliated Colleges. - Ex-officio.

(iv) Three members to be elected from amongst themselves by each Board of Studies under the Faculty concerned.

6. The meeting adopted the following resolutions duly moved and seconded -

(i) "Be it resolved that teachers in the Colleges affiliated to Nagpur University be paid C.C.L.A. and House Rent Allowance as per Maharashtra Government rules in this respect. The State Government and the College Managements are requested to take necessary steps in this matter."

(ii) "Since there is a wide disparity between scales of pay of teachers in affiliated Colleges and of teachers in the University Departments, this meeting of the General Body

of the Nagpur University Teachers Association request the University Grants Commission and the State Government to remove this disparity by providing adequate funds to the affiliated Colleges to meet the extra financial burden."

(iii) "The Nagpur University Teachers' Association views with great concern the very low percentage of passes at B.Sc. Part I Examination of the University and request the Vice-Chancellor, Nagpur University to kindly publish the Abhyankar Committee report for benefit of those concerned".

(iv) "The General Body of the Nagpur University Teachers Association views with great concern the growing tendency on the part of College Managements to bypass provisions of the College Code and request the Vice-Chancellor, Nagpur University to appoint Committees for inspection of the affiliated Colleges to enquire into the implementation of the provision of the College Code by the Colleges".

(v) "Since a Committee appointed by the Academic Council is currently studying the working of Provident funds in the affiliated Colleges, this meeting of the General Body of the Nagpur University Teachers' Association request the Vice-Chancellor to kindly withhold implementation of clause 3(7) of the Provident Fund Rules framed by the Executive Council, dated 31-8-1963, Clause 3(7) of the said Rules, in the opinion of this meeting is inconsistent with the Provident Fund Rules prescribed under the Indian Income Tax Act".

(vi) "In view of the fact that expenditures on account of premium of life insurance policies upto 5,000/-, gratuity provisions and special allowances such as House Rent allowance, conveyance allowance etc. have been prescribed as admissible items of expenditure under the grant-in-aid Code of the Government of Maharashtra for the non-government Colleges in the State, this meeting of the General Body of the Nagpur University Teachers Association requests the Management of non-government college, Nagpur University and the state Government to implement the above welfare measures immediately".

(vii) The meeting considered a proposal to appoint a Committee to study the draft College Code to be considered by the Academic Council of the University. It was decided that the Secretary of the Association after obtaining copies of the draft College Code would forward the same to the members of the Association for their consideration and suggestions.

NAGPUR UNIVERSITY TEACHERS' ASSOCIATION, NAGPUR.**MEMORANDUM****SUBMITTED**
by the Nagpur University Teachers' Association
to the Government of Maharashtra.

The Nagpur University Teachers' Association wants to place the following demands before the Government of Maharashtra for sympathetic consideration and speedy action.

1. The pay-scales for teachers in Non-Government Colleges affiliated to Nagpur University need to be revised so as to bring them on par with those in the University. The two scales are as under :-

For affiliated Non-Govt. Colleges	For University.
Professor - 400-25-700	1000-50-1500
Asstt. Professor - 300-25-600	700-40-1100
Lecturer - 200-15-320-20-500	400-30-800
(with D.A. as per rules)	(No D.A.)

2. Teachers in the Non-Government Colleges as well as in the University need to be paid Dearness Allowance, C.C. L.A. and House Rent Allowance at rates prescribed for these purposes for teachers in the Government Colleges.

At present the University Teachers do not get dearness allowance, In some of the non-Government Colleges it is not paid according to Government rates.

C.C.L.A. need to be paid to all the teachers in Nagpur due to the fact that Nagpur is the costliest city in the country.

House Rent Allowance is not paid either to the teachers in non-Government Colleges or to the teachers in the University. It need to be paid to all these teachers at the same rate it is paid to the teachers in Government Colleges.

3. As a result of the revised Grant-in-aid Code for Non-Government Colleges, the Colleges in Vidarbha are facing a financial crisis. The government should revise the formula so as to enable these Colleges to meet the deficits, which in some case are more than Rs. 50,000/-. The reason for the deficit are due to historical factors. Under the earth while C.P. and M.P. Governments the affiliated Colleges used to receive liberal grants from the Government. The fee charged to the students therefore was very much low as compared to the rates in Western Maharashtra. It has always been less by Rs. 100/- per annum per student than fee charged in Western Maharashtra. The University of Nagpur prescribed 64 as the maximum number of students in each section, whereas in Western Maharashtra, strength of a section is as high as 150 students.

With large sections and higher rates of fees, the non-Government Colleges in Western Maharashtra did not depend for their survival on the Government grants. Historically such has not been the case, with the non-government colleges in Vidarbha. Now under the new formula of the Grant-in-aid Code, these Colleges have been for the purposes of grants brought on par with Colleges in the Western Maharashtra without realising the historical factors mentioned above. It is therefore suggested that the Grant-in-aid Code should be so revised as to enable the non-Government College in Vidarbha to function smoothly and efficiently.

4. It has been observed that the financial affairs of some of the Colleges in Vidarbha are not sound. In enthusiasm for expansion of education, the managements of such Colleges utilise funds of the College to establish new

institutions with the result that the already established colleges can not consolidate their positions. To obviate these practices it is suggested that a system of annual Government audit be introduced in the case of non-Government Colleges. This will create a sense of security amongst the College teachers.

5. The Government should make uniform rules for Provident Funds in the affiliated Colleges. At present there is room for avoiding and delaying the admission of teachers to the Provident Fund of the College.

6. The Government should make provision for payment of gratuity to teachers in Non-Government Colleges and in the University on their retirement as is the case with teachers in the Government Colleges.


A scheme for giving insurance benefits may also be introduced in the case of all College and University Teachers.

7. The Nagpur University is the second oldest University in the State of Maharashtra. It is also a University which receives the lowest maintenance grant in the whole state. With the result that it has not been able to play its proper role in matters of advanced studies and research. It is therefore suggested that the maintenance grant to Nagpur University may be raised in proportion to its needs.

8. With the growth of population, housing problem has become very acute in cities like Nagpur, Amravati, Akola etc. Although there is good deal of building activity the house rent for a moderately descent accommodation are appreciably high. It is therefore suggested that the Government should take up house construction activity for providing suitable accommodation to teachers at reasonable rents. Good housing is one of the pre-conditions for creating atmosphere conducive to academic pursuits and research. It is also suggested that the Government may sell houses to the teachers on hire-purchase basis.

9. The Nagpur University Teachers' Association is a professional association of University and College Teachers in Vidarbha. It is in need of a building of its own. The first step in this respect is to secure a piece of land at a suitable site. The Government is requested to secure for the Association the land adjoining to the Hadas High School on North Ambazari Road, Nagpur. This land is a part of the agricultural land under the Agriculture College, Nagpur. On both sides of this land are located public institutions. There should be no difficulty on the part of the Agriculture Department to release this piece of land for purposes of public institutions. This land may please be given as grant to the Association.

Submitted to the Government of Maharashtra through the Minister for Education for sympathetic consideration.

Moses as President and Prof. D.B.Dabadgaon of N.M.V. as Secretary. This club used to meet twice/thrice in a session. (2) In one of its meeting the ideas of forming NUTA was sponsored mainly by Prof. R.V. Ranade, Dr. M.G. Bokare and few others and was opposed by the senior teachers. The NUTA however was born by the majority. (3) Prof. R.V. Ranade was elected as the founder Secretary and I was one of the member of the Ex.Committee. (4) I was elected as Secretary along with Prof.R.N. Chandurkar as President and Principal R.P.Aiyachit as Joint Secretary Prof. Ranade, Dr. Bokare, M.G. Vaidya, Dr. S.A.Deshpande & others members of the Ex.Committee. (5) The NUTA during this period contested election to the University Court (Senate) for the first time as candidates of NUTA. (6) I was member Ex.Committee when Prof. G.C. Singh was President & Prof. A.V. Barhate was Secretary for one year.

Referring to the American Association of Teachers, he (Dr. N.R.
