\$ A Person with basic pay Rs. 3200 on 01.01.96, may better not have his pay fixation on 01.01.96, it may be better for him to opt for pay fixation after 01.01.96 on his usual increment date (falling after 01.01.96), after availing the increment in the old scale, increasing his pay in the old scale to Rs.3300.

All other persons may opt for pay fixation on 1.1.96.

FORMULA FOR FIXATION OF PAY IN THE REVISED SCALES

- I. Pay in the revised scales should be fixed under this scheme only after :-
- a) every teacher has had opportunity to decide whether he/she will opt for the earlier scheme and
- b) the University or College concerned has made necessary changes in their statutes, ordinances, rules, regulations, etc. to incorporate the provisions of this scheme.
- II. The pay of teachers in Universities and colleges may be fixed in the revised scales of pay in the following manner:-
- (i) an amount representing 40 per cent of the basic pay in the existing scale, shall be added to the "existing emoluments"
- (ii) after the existing emolument have been so increased, the pay shall thereafter be fixed in the revised scale at the stage next above the amount thus computed, Provided that:-
- (a) if the minimum of the revised scale is more than the amount so arrived at, the pay shall be fixed at the minimum of the revised scale;
- (b) If the amount so arrived at is more than the maximum of the revised scale, the pay shall be fixed at the maximum of that scale.

Provided further that:

Where in the fixation of pay, the pay of a teacher drawing pay at more than four consecutive stages in an existing scale gets bunched, that is to say, gets fixed in the revised scale at the same stage, the pay in the revised scale of such of these teachers who are drawing pay beyond the first four consecutive stages in the existing scale shall be stepped up to the stage where such bunching occurs, as under, by the grant of increment(s) in the revised scale in the following manner, namely:-

- (a) For the teachers drawing pay from the 5 th upto the 8 th stage in the existing scale By **one** increment;
- (b) For teachers drawing pay from the 9 th upto the 12 th stage in the existing scale, if there is bunching beyond the 8 th stage By **two** increments.
- (c) For teachers drawing pay from the 13 th upto the 16 th stage in the existing scale, if there is bunching beyond the 12 th stage By **three** increments.

If by stepping up of the pay as above, the pay of a teacher gets fixed at a stage in the revised scale which is higher than the stage in the revised scale at which the pay of a teacher who was drawing pay at the next higher stage or stages in the same existing scale is fixed, the pay of the later shall also be stepped up only to the extent by which it falls short of that of the former.

Provided also that:

The fixation thus made shall ensure that every teacher will get at least one increment in the revised scale of pay for every three increments (inclusive of stagnation increment(s), if any) in the existing scale of pay.

Explanation: For the purpose of this clause "Existing emoluments" shall include:-

- (a) The basic pay in the existing scale;
- (b) Dearness allownace admissible as on 1st January 1996 on the basic pay; and
- (c) The amounts of the first and second installments of the interim relief admissible on the basic pay in the existing scale;
- Note 1: Where the increment of a teacher falls on 1st day of January 1996, he shall have option to draw the increment in the existing scale or the revised scale.
- **Note 2 -** Where a teacher is on leave on the 1st day of January 1996, he shall become entitled to pay in the revised scale of pay from the date he joins duty. In case of a teacher under suspension, he shall continue to draw subsistance allowance based on existing scale of pay and his pay in the revised scale of pay will be subject to final order on a pending disciplinary proceedings.
- **Note 3 -** Where the existing emoluments as calculated in accordance with clause II above exceed the revised emoluments in the case of any teacher, the difference shall be allowed as personal pay to be absorbed in future increases in pay.
- **Note 4 -** Where in the fixation of pay under clause II above, pay of a teacher, who, in the existing scale was drawing immediately before the 1st day of January 1996 more

pay than another employee junior to him in the same category, gets fixed in the revised scale at a stage lower than that of such junior, his pay shall be stepped up to the same stage in the revised scale as that of the junior.

- **Note 5** In cases, where a senior teacher promoted to a higher post before the 1st day of January 1996 draws less pay in the revised scale than his junior who is promoted to the higher post on or after the 1st day of January 1996, the pay of the senior teacher should be stepped up to an amount equal to the pay as fixed for his junior in that higher post. The stepping up should be done with effect from the date of promotion of the junior teacher, subject to the fulfillment of the following conditions, namely:-
- (a) both the junior and the senior teacher should belong to the same category and the posts in which they have been promoted should be identical in the same category;
- (b) the pre-revised and revised scales of pay of the lower and higher posts in which they are entitled to draw pay should be identical, and
- (c) the senior teacher at the time of promotion has been drawing equal or more pay than the Junior.
- (d) the anomaly should be directly as a result of the application of the provisions of fundamental Rule 22 or any other rules or order regulating pay fixation on such promotion in the revised scale. If even in the lower post, the junior officer was drawing more pay in the pre-revised scale than the senior by virtue of any advance increments granted to

him, provision of this Note need not be invoked to step up the pay of the senior teacher.

The order relating to refixation of the pay of the senior teacher in accordance with the above provisions should be issued under fundamental Rule 27 and the senior teacher will be entitled to the next increment on completion of his required qualifying service with effect from the date of refixation of pay.

2. Date of next increment in the revised scale: The next increment of a teacher whose pay has been fixed in the revised scale in accordance with the above procedure shall be granted on the date he would have drawn his increment had he continued in the existing scale:

Provided that in cases where the pay of a teacher is stepped up in terms of Note 4 or Note 5 above, the next increment shall be granted on the completion of the qualifying service of twelve months from the date of stepping up of the pay in the revised scale :

Provided further that in cases other than those covered by the preceding proviso, the next increment of a teacher whose pay is fixed on the 1st day of January 1996 at the same stage as the one fixed for another teacher junior to him in the same category and drawing pay at a lower stage than his in the existing scale, shall be granted on the same date as admissible to his junior, if the date of increment of the junior happens to be earlier.

Provided also that in the case of persons who had been drawing maximum of the existing scale for more than a year as on the 1st day of January 1996 the next increment in the revised scale shall be allowed on the 1st day of January 1996.

- श्री.िदलीप वळसे पाटील : (१) होय. पाचच्या वेतन आयोगाशी समकक्ष वेतनश्रेण्या विद्यापीठीय व महाविद्यालयीन शिक्षकांना महाराष्ट्र शासनाने लागू केल्यास येणाऱ्या अतिरिक्त भारापैकी मूळ वेतनावर होणाऱ्या खर्चाच्या ८० टक्के भार केंद्र शासन उचलण्यास तयार असण्याच्या प्रस्तावाची तपासणी झाली आहे.
- (२) पाचव्या वेतन आयोगाशी समकक्ष वेतनश्रेण्या विद्यापीठीय व महाविद्यालयीन शिक्षकांना महाराष्ट्र शासनाने दिनांक १.१.१९९६ पासून लागू करण्याचा निर्णय घेतला असून लवकरच याबाबतचे शासन आदेश निर्गमित करण्यात येत आहे.

श्री.दिलीप वळसे पाटील (उच्च व तंत्र शिक्षण मंत्री): सभापती महोदय, या प्रश्नाच्या उत्तरात मला आपल्या परवानगीने पुढील सुधारणा करावयाची आहे. उत्तराच्या दुसऱ्या भागातील शेवटच्या ओळीमध्ये "आदेश निर्गमित करण्यात येत आहेत" असे म्हटलेले आहे त्याऐवजी "आदेश निर्गमित करण्यात आले आहेत" असे वाचावे.

श्री.बी.टी.देशमुख: "या बाबतचे आदेश निर्गमित झालेले आहेत". असे आताच मा.मंत्री महोदयांनी सांगितलेले आहे. केंद्र शासनाची ही समग्र योजना आहे. २७ जुलै १९९८, ६ नोव्हेंबर १९९८ ची केंद्र शासनाची पत्रे आणि २४ डिसेंबर १९९८ चे यूजीसीचे नोटिफिकेशन या तीन कागद पत्रावर आधारित ही समग्र योजना आहे. माझे म्हणणे असे आहे की, केंद्र शासनाच्या २७ जुलैच्या पत्राच्या परिच्छेद ४ मध्ये असे लिहिलेले आहे की, "यामध्ये मॉडीफिकेशन न करता याची अंमलबजावणी केली तरच त्याला मान्यता देऊ." उच्च शिक्षण विभागाने काही मॉडीफिकेशन केलेले आहेत, तेव्हा या बाबतीत पुनर्विचार केला जाईल का? राज्याचे ७००-८०० कोटी रुपयाचे नुकसान होऊ नये अशी या मागची भावना आहे. म्हणून मी हा प्रश्न विचारला आहे. २७ जुलै १९९८ आणि ६ नोव्हेंबर १९९८ ही दोन पत्रे गव्हर्नमेंट ऑफ इंडियाची आहेत. २४ डिसेंबर ९८ चे नोटिफिकेशन यू.जी.सी.चे आहे. यामधील समग्र योजना तीन मॉडीफिकेशन सकट अमलात आणण्याचा निर्णय आपण घेतलेला आहे का? हा माझा प्रश्न आहे.

श्री.दिलीप वळसे पाटील : केंद्र सरकारने आपल्या केंद्रिय कर्मचाऱ्यांना पाचवा वेतन आयोग लागू करण्याचा निर्णय घेतलेला आहे. त्या प्रमाणे २७ जुलै ९८, २२ सप्टेंबर ९८ आणि ६ नोव्हेंबर ९८ रोजी पत्र पाठवून राज्य शासनास निर्णय घेण्यास कळविलेले आहे. राज्य शासनाने या तिन्ही पत्रांचा एकत्र विचार केला आहे. आपण सुचिवले आहे त्या प्रमाणे कांपोझीट स्किम करण्याचा निर्णय घेतलेला आहे. आपल्याला त्यातील दोन गोष्टीचा स्वीकार करता आला नाही. या राज्यातील कर्मचाऱ्यांचे निवृत्ती वय ६२ नसून ६० आहे. कांपोझिट स्किममध्ये ते ६२ सूचिवलेले आहे. त्याचा स्वीकार आपण केला नाही. डी.ए. च्या संदर्भात पेमेंट ऑफ ॲरीअर्स जसे इतर राज्य सरकारच्या कर्मचारी वर्गाला दिलेले आहेत तसे ते या विद्यापीठातील कर्मचाऱ्यांना लागू करण्याचा निर्णय घेतलेला आहे. यू.जी.सी.ने पत्र पाठविले आहे. त्यामध्ये गाईडलाईन्स दिलेल्या आहेत. अटी घातलेल्या आहेत की, असेच डिट्टो केले पाहिजे. आपण जी.आर. काढल्यानंतर, तो यू.जी.सी.ला सबमिट केल्यानंतर, केंद्र शासनाकडून प्रतिपूर्ती मिळणार आहे. शासनाचे घोरण असे आहे की, केंद्र शासनाने ही वाब मान्य केली तर आपल्याला याचा विचार करण्यास वेळ लागणार नाही.

SECRETARY'S REPORT ON THE WORKING OF THE ASSOCIATION FOR THE YEAR ENDING ON 31ST DECEMBER, 1999.

Prepared by the Executive Committee of NUTA under article (VI) (b) (ii) of the Constitution of NUTA and presented by Secretary on behalf of the NUTA Executive.

Dear Friends,

It gives me great pleasure to accord you all a cordial welcome on behalf of the Executive Committee of NUTA and my own behalf. It is indeed a proud privilege for me to place before this august body a brief account of our activities and achievements during the year 1999.

- (2) Right from its inception, NUTA has been committed to the cause of the welfare of the teachers' community. In keeping with this commitment, the organization took up several issues concerning teachers during the period of this report.
- (3) During the current year, the organization achieved success in getting a few of our demands fulfilled by the Government. The President of the organization, Prof. B. T. Deshmukh followed up the issues in the legislative council with his usual perseverance and got the relevant orders issued by the Government. They include a G.R. dated 1st March, 1999 regarding pay protection to the Junior college teachers if they are appointed in Senior college through selection committees, G.R.dated 1 st March, 1999 withdrawing irrational conditions regarding completion of orientation/Refresher courses imposed by G.R. dated 18th May 1998, G.R. dated 6th March, 1999 regarding students strength in Non-Government Arts/Science and Commerce Colleges and G.R. dated 25th August, 1999 regarding absorption of surplus women teachers.

(4) PARTICIPATION IN ACTION

PROGRAMME:

a) The members of NUTA participated in the various action programmes in response to the call given by AIFUCTO and MFUCTO from time to time to press for the solution of pending demands of the teaching community. You may recall that after a great struggle under the able leadership of AIFUCTO the Union Government issued its order dated 6th November, 1998 making certain modifications to the original scheme (dated 27th July 1998) of revised pay scales to the University and College teachers. However, Government of Maharashtra did not take steps to implement these pay scales in Maharashtra with effect from 1.1.1996. The MFUCTO had given call for various agitational programmes in a phased manner during the year of reporting. On the 11th January, 1999 tens of hundreds of University and Colleges teachers staged a Massive Dharna at Mantralaya to protest against the Government of Maharashtra's failure to issue G.R. bringing into effect the revised pay scales. Black Flag demonstrations at all district places against the Chief Minister and Deputy Chief Minister were organized from 11th February, 1999. Another novel agitational approach was followed by MFUCTO to mobilize public opinion against Government for not implementing the revised pay scales i.e. issuance of Advertisements in all News papers from 1st February, 1999. In the mean time AIFUCTO had given a call to hold demonstrations in the State Capitals and also at University centres on 15.03.99 demanding among others ac-

ceptance and implementation of revised scales of pay.

- b) An action programme of a token strike on 7th July, 1999 including courting arrest and an indefinite strike from 21st July, 1999 was announced by the coordination Committee comprising of MFUCTO and Maharashtra Rajya Madhyamik Shikshak Mahamandal for their common demands. However, in view of the election notification for the Lok Sabha to begin with and thereafter for the Maharashtra State Legislative Assembly, the MFUCTO Executive decided to postpone the said strike.
- c) The Executive Committee of MFUCTO which met on 26th September, 1999 unanimously resolved to recommence its suspended movement. Accordingly one-day demonstration all over the state on 20th October, 1999 and indefinite strike with effect from 8th December, 1999 was rescheduled. An action of 20th October, 1999 was a grand success all over Maharashtra. Morchas were arranged at all district places. NUTA was on the forefront in both the Universities area in all these agitational programmes.
- d) It remains a fact that because of our strength and unity the Government of Maharashtra had to invite MFUCTO Executive for discussion on 6th and 7th December, 1999 in respect of our demands. Discussion with the Education Minister of Maharashtra State on 7.12.99 proved to be fruitful and an agreement was reached with MFUCTO Executive for implementing revised scales of pay in Maharashtra with effect from 1.1.96 as a package Scheme. We should be proud of the fact that our President Prof.B.T.Deshmukh made all efforts through his parliamentary skills and succeeded in bringing the Government at the settlement table. He also proved to be instrumental in bringing about a successful agreement with the Government on 07.12.99.

- 1) All the members of the Unit will start their meeting at the date & time mentioned in the above notice in the staff room of the college. (In case staff room is not opened meeting will take place in the Varanda of the staff room or on the open ground near the staff room.)
- 2) First, members will appoint one of them as the working Chairman, who will not be a candidate for the office of the President or Secretary.
- 3) Working Chairman will then request the meeting to elect the President and Secretary unanimously, if possible.
- 4) Then working Chairman will invite the names for the post of a President and Secretary. If there is only one name (candidate) for the post of the President and only one candidate for the post of Secretary, he will declare both as elected unopposed.
- 5) If there is only one candidate for the post of the President and more than one for the post of Secretary, President will be declared elected unopposed and election will take place (as per para 7 below) only for the post of Secretary.
- 6) If there is only one candidate for the post of a Secretary and more than one for the post of the President, Secretary will be declared elected unopposed and election will take place only for the post of the President, as per para-7 below.
- 7) If there are more candidates than one for both the posts, election will take place by secret ballot by simple majority system in accordance with the following manner.

 A) Chairman will first conduct voting for the post of a President i.e. he will give one small blank paper to each member who will write name of his choice on that paper.

BYE-LAWS PROVIDING FOR COLLEGE UNIT OF NUTA

(Reproduced from page 93 of 1977 NUTA Bulletin)

- 1) These Bye-laws may be called" College Unit bye laws of NUTA."
- 2) These Bye-laws shall come into force with effect from 1st November,1977.
- 3) Each College affiliated to Nagpur University, shall have college Unit of Nagpur University Teachers' Association.
- 4) Such unit shall be known after the name of that college.
- 5) Each college Unit shall be assigned a number as per the scheme prepared by the Executive Committee of NUTA.
- 6) Each college Unit shall consist of all the members of the Association working in the college.
- 7) Members of each Unit shall elect from amongst | themselves a President and a Secretary.
- 8) In case a Unit consists of only one member, he shall act as the President, and in case a Unit consists of only two members, the Senior member of the Association shall act as the Presidebt and the other as the Secretary.
- 9) As and when the membership of the college Unit exceeds beyond two, the Unit shall elect it's President and Secretary as per provisions of para 7 above.
- 10) Names of President and Secretary of each Unit shall be published in the NUTA BULLITEN.
- 11) Any dispute regarding the election of President and/ or Secretary of college Unit may referred to the Secretary of NUTA, within a period of fifteen days from the date of such election. The Secretary of the Association shall place the same before the Executive Committee of NUTA for its consideration The Executive Committee, after making due inquiry as it may deem fit, give its decision. The decision of the Executive Committee shall be final in all such matters.
- 12) Executive Committee may make rules, not contrary to the provisions of the constitution of NUTA or these Bye-laws, for the effective functioning of the college Units.

Ord. V of 2000), is hereby published under the authority of the Governor. By order and in the name of the Governor of Maharashtra,

Maharashtra ordinance No. V of 2000
An ordinance

to provide for temporary postponement of elections to the authorities and bodies of the non agricultural, non-technological and non-medical Universities in the State of Maharashtra.

WHEREAS the Maharashtra Universities Act, 1994, (Mah. XXXV of 1994) provides for the constitution of various authorities or bodies in the Universities which include elected members among others;

AND WHEREAS the proposal to amend the Universities Act, 1994, so as to provide for representation of various sections of society including women on the various authorities and bodies of the Universities and certain other amendments to streamline the working of the Universities, is under active consideration of the Government:

AND WHEREAS the Government of Maharashtra, therefore, considers it expedient to temporarily postpone the ensuing elections to fill in the vacancies of the elected members on the authorities and other bodies of the Universities, pending carrying out of these amendments by the Government at the earliest;

AND WHEREAS both Houses of the State Legislature are not in session;

AND WHEREAS the Governor of Maharashtra is satisfied that circumstances exist which render it necessary for him to take immediate action to postpone temporarily the elections of the members of the authorities and other bodies of the Universities;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of article 213 of the Constitution of India, the Governor of Maharashtra is hereby pleased to promulgate the following cordinance, namely:-

- 1. **Short title and commencement** (1) This ordinance may be called the Maharashtra Universities (Temporary Postponement of Elections of Members of University Authorities and Other Bodies) Ordinance, 2000
- (2) It shall come into force at once.

 2. Temporary postponement of elections of members of University authorities and other bodies Not withstanding anything contained in the Maharashtra Universities Act, 1994 (Mah. xxxv of 1994) (hereinafter referred to as the "the principal Act") or any statutes or ordinances made thereunder, from the date of coming into force of this ordinance, no election for filling in vacancy of any of the elected members of any of the authorities or of other bodies of any university, caused either by expiryof their term or for any reason what-

ever, shall be held, till the expiry of a period of three months or till, such earlier date on which the amending law is enacted hereinafter referred to as "the said period".

3. Consequences of temporary postponement of elections of members of authorities and other bodies of University. Notwithstanding anything contained in the principal Act or in the statutes or ordinances made thereunder, no act or proceedings of any authority or any other body of any of the Universities constituted under the principal Act, during the said period, shall be invalid merely on the ground that the vacancies occurring in any such authority or body required to be filled in by election are not so filled in.

STATEMENT

Chapter IV of the Maharashtra Universities Act, 1994, provides for the constitution of various authorities and other bodies of the Universities which include elected members among others. The process of election of these members is due to start shortly in some of the Universities. However, the proposal to change the composition of various authorities and bodies of the Universities so as to give representation to various sections of society including women and certain other relevant amendments to streamline the functioning of such authorities and bodies of the Universities, is under active consideration of the Government. In view of this, it is felt that, if the elections of all the authorities and bodies are held now, it would not be possible to provide for the representation of the other sections, as intended and also to bring about other relevant changes by the Government, till the next elections, that is, for another five years. It is, therefore, considered expedient by the State Government to temporarily postpone the elections of the members of the authorities and bodies of the Universities, pending carrying out of the proposed amendments by the Government at the earliest. This would enable Government to constitute the authorities and bodies of the Universities as per the amended provisions.

2. As both Houses of the State Legislature are not in session and the Governor of Maharashtra is satisfied that circumstances exist which render it necessary for him to take immediate action, to promulgate an ordinance to provide for the temporary postponement of elections of members of the authorities and other bodies of the Universities, this ordinance is promulgated.

Fund" will be received by the Treasurer on 14th May 2000 at the venue of the General Body Meeting before the said item is resolved and the said payment will be treated as a payment made by the concerned teacher towards Life Membership Fee of NUTA, as if paid on or before 14th May 2000.
- (3) The Treasurer will issue receipt of such crossed Bank Draft and mention on each receipt name of the concerned teacher and the date on which such Bank Draft was issued and the name of the Bank concerned.
- (4) Any teacher can become a member of NUTA by paying the L.M.Fees of Rs. 2001/-in one instalment or in three instalments. In the case of three installments, First instalment of Rs. 1001/- must be paid by a crossed Bank Draft drawn in the name of Treasurer NUTA on or before the said item is resolved.
- (5) After paying the first instalment, the teacher shall pay the remaining amount of 1000/- in two equal instalments, within a period of one year i.e. before 14th May 2001.

- (ब) निवृत्तीवेतन, कुटुंब निवृत्तीवेतन, उपदान व अंशराशीकरणाच्या रकमांची थकबाकी निवृत्तीवेतनधारकांना तीन हप्त्यात प्रदान करावयाची असल्यामुळे या प्रत्येक बाबीच्या प्रत्येक हप्त्याची रक्कम परिगणित करून ती संबंधित मंजूरी आदेशांमध्ये स्पष्टपणे नमूद करण्यात यावी.

- (इ) शासन निर्णय, वित्त विभाग, क्रमांक निअंक-१०८६/१७७१/सेवा-४ दिनांक ३० मे १९८८ च्या तरतुर्दीनुसार सुधारित निवृत्तीवेतनाच्या अंशराशीकृत भागाचे १५ वर्षानंतर पुनःस्थापन करतांना तीन हप्त्यापैकी प्रत्येक हप्ता ज्या दिनांकापासून मासिक निवृत्तीवेतनातून कमी करण्यात आलेला असेल त्या त्या दिनांकापासून १५ वर्षानंतर पुनःस्थापीत करण्यात येईल.
- २. उपरोल्लिखित अनुक्रमांक (२) व (३) च्या आदेशांच्या संदर्भात खालील प्रमाणे खुलासा करण्यात येत आहे :-

- (इ) वरीलप्रमाणे तात्पुरत्या स्वरूपात निवृत्तीवेतनविषयक लाभ प्रदान करण्यात आलेली प्रकरणे जेव्हा महालेखापाल, मुंबई/नागपूर यांचेकडून अंतिम स्वरूपात मंजूर होतील त्यावेळी महालेखापालांकडून अंतिम सुधारित निवृत्तीवेतन प्रदान आदेश/उपदान प्रदान आदेश/निवृत्तीवेतनाचे अंशराशीकृत मूल्य प्रदान आदेश प्राप्त झाल्यानंतर विभाग प्रमुख/कार्यालय प्रमुखांनी, पूर्वी तात्पुरत्या स्वरूपात अनुज्ञेय ठरलेले लाभ प्रत्यक्षात प्रदान करण्यात आल्यासंबंधीचे प्रमाणपत्र (सविस्तर तपशिलासह) संबंधित कोषागार कार्यालयाकडे पाठविणे आवश्यक राहील. जेणेकरून सदरहू प्रमाणपत्राच्या आधारे आवश्यक ती समायोजनाची कार्यवाही संबंधित कोषागार कार्यालयास करता येईल.
- ३. शासन असाही खुलासा करीत आहे की, ज्या निवृत्तीवेतनधारक/कुटुंब निवृत्तीवेतनधारकांना असुधारित वेतनावर आधारित तात्पुरते निवृत्तीवेतन/कुटुंब निवृत्तीवेतन विषयक लाभ, यथास्थिती, महाराष्ट्र नागरी सेवा (निवृत्तीवेतन) नियम, १९८२ च्या नियम १२६, नियम १३०, नियम १४० व शासन परिपत्रक, वित्त विभाग, क्रमांक सेनिवे-१०९९/३४/सेवा-४ दिनांक २४ मार्च १९९९ च्या तरतुदीनुसार मंजूर करण्यात आलेले आहेत, त्यांचे तात्पुरते निवृत्तीवेतन/कुटुंब निवृत्तीवेतनविषयक लाभही वरील आदेशांनुसार तात्पुरत्या स्वरूपात सुधारित करण्यात यावेत.
- ४. सर्व विभाग/कार्यालय प्रमुखांनी/कोषागार अधिकाऱ्यांनी वरील सूचनांचे काटेकोरपणे पालन केले जाईल याची दक्षता घ्यावी.

शासन निर्णय, वित्त विभाग, क्रमांक सेनिवे-१०९९/३०२/सेवा-४, दिनांक १५ नोव्हेंबर १९९९ च्या परिच्छेद १० च्या तरतुदीनुसार सुधारित वेतनश्रेणीसाठी विकल्प दिलेल्या व सुधारित वेतनश्रेणी लागू झाल्याच्या दिनांकापासून १० महिन्यांच्या आत सेवानिवृत्त झालेल्या शासकीय कर्मचाऱ्यांच्या प्रकरणी निवृत्तीपूर्वीच्या १० महिन्यांच्या कालावधीसाठी सरासरी मूळ वेतन परिगणित करण्यासाठी खालीलप्रमाणे वेतन विचारात घेतले जाते.

त्यानंतर निवृत्तीपूर्वीच्या १० महिन्यांचे निवृत्तीवेतनार्ह वेतन, (अ) व (ब) यांची बेरीज करून आणि त्या बेरजेस दहाने भागून परिगणित करावे. अनुज्ञेय ठरणारे निवृत्तीवेतना हे अशारीतीने परिगणित केलेल्या निवृत्तीवेतनार्ह वेतनाच्या ५० टक्के एवढे राहील.
