The University Grants Commission hereby appoint a committee to review the scales of pay of the teachers in the Universities and Colleges. The Commission, in consultation, with the Ministry of Human Resource Development, has finalised the terms of reference of the Committee, which are as follows:

- (i) To review the **implementation of the previous decisions** of the Government/UGC under the scheme of Revision of pay scales approved for university and College Teachers, Librarians Director of Physical Education and Registrars of Universities and in the process, to evaluate the extent to which the earlier recommendations in relation to qualifications, service conditions, pay scales etc. have been implemented.
- (ii) To examine the present structure of emoluments and conditions of service of university and College Teachers, Librarians, Directors of Physical Education and Registrars of Universities taking into account the total packet of benefits available to them (such as superannuation benefits, medical, housing facilities etc.)
- (iii) To **make recommendations** on the above having regard to the need for improving the quality of education the necessity of attracting and retaining talented persons in the teaching profession and advancement opportunities to the above categories of persons.

The Committee may initiate necessary studies and analysis in regard to the terms of reference but should make its final recommendations in the light of 5th Pay Commission recommendation and its advice should be harmoniously constructed in relation to the recommendation of the Pay Commission

The Committee would consist of the following members: 1. Prof. R.P.Rastogi, Former Vice-Chancellor, Banaras Hindu University, Varanasi. Chairman 2. Prof. V.C.Kulandaiswamy Former Vice-

Chancellor, IGNOU, Member 3. Prof. D.P.Barooah Former Vice-Chancellor, Guwhati University. Member 4. Prof. (Mrs.) Kanta Ahuja, Vice-Chancellor, Ajmer University. Member 5. Representative of Deptt. of Education, Ministry of Human Resource Development, New Delhi (Not Below the Rank of Joint Secretary) Member 6. Representative of Ministry of Finance, New Delhi. (not below the rank of Joint Secretary) Member 7. Sh. Inderjit Khanna, Secretary UGC, Member Secretary.

The Commission will make necessary payment towards TA/DA and all other expenses. The terms of the Committee will be for one year w.e.f. Ist September, 1994 and which may be extended with the approval of the Commission.

### **ORDER**

### Higher & Technical Education & Employment Department,

Mantralaya Annexe, Bombay-400 032 Dated the 20th December 1994 NO. UPG 204 (260/94)/UNI-3

Whereas the Maharashtra Universities Act (Maharashtra Act xxxv) has come into force with effect from 22nd July, 1994 and whareas doubts certain/difficulties in implementing the provisions of this Act have been brought to the notice of the Government from various quarters.

Now therefore, in exercise of the powers vested under section 116 of the Maharashtra Universities Act, 1994 the Government is pleased to issue necessary clarifications and directions in respect of various points raised as under:-

### Sr.No. Points raised, Clarification

**1.** *Point*: Under section 2 (31), the **concept of school** is defined briefly. It should mean either a school of interdisciplinary studies or a group of Departments covering a number of disciplines in a particular are of study as life science, Physical Science Mathematical Sciences, Chemical Sciences, Behavioural Sciences etc.

 ${\it Clarification}$ : The Universities may frame appropriate statutes.

2. Point: The Provisions under Sections (2) read with Section 102 (1) (d) refer to development fund, This fund is termed under section 8 (2) (e) as 'development fund' whereas under section 102, it is termed as development and programme fund. Hence, the fund under section 8(2)(e) should also be termed as development and programme fund.

 ${\it Clarification:}$  The term "if any" in section 8(2)(e) includes the term development &

programme fund' under section 102(i)(d).

**3. Point:** Section 14(14)(a) read with section 90(2) is likely to create confusion. The composition of the committee under section 14(14)(a) should be the same as the composition of the committee prescribed under section 90(2)

Clarification: The Committee under section 90(2) is for periodical/routine inspection of college/department/institute etc. whereas the committee under section 14(14) (a) is for particular/specific enquiries on receipt of complaints/information.

**4.** *Point*: In section 15(a), title "Deans of Faculties" should be indicated in the margin.

**Clarification:** It is printing error The words 'Deans of Facuilties' should be read as indicated in the margin.

5. Point: Under the provision of section 16(1) is it noted that the **Director of the Board of College and University Development** shall be nominated by the Vice-Chancellor, However, it is not clearly indicated whether the Director shall be a full-time salaried officer or not, It was also noted that under provisions of section 51(8), the terms and conditions of the officer have to be prescribed by the statutes, Hence, the Statutes for the post of Director of College Development Council is already made, the same should be adopted, and where such statute is not made necessary directions be issued by the Vice-Chancellor under provision of section 14(a)

Clarification: Where there is a post of Director for the College Development Council, the same post shall be designated as the Director of Board of College and University Development. Where there is no such post, the Vice-Chancellor shall nominate a person from amongst the categories mentioned in section 16(1). He shall be a full time salaried officer for a specific period,

श्री.बी.टी.देशमुख: अध्यक्ष महाराज. या ठिकाणी मंत्री महोदयांनी जे उत्तर दिले आहे त्याला अनुलक्षून मी असे विचारू इच्छितो की, ह्या भेदभावाचे स्वरूप काय आहे आणि त्याबाबतीत आपल्या संचालकांच्या शिफारसी काय आहेत?

श्री विलास शुंगारपवार : अध्यक्ष महाराज, या संदर्भात संचालकांची शिफारस १७.१.१९९४ प्रमाणे या दोन्हीमधील तफावत काढून टाकण्याबद्दलची आहे.

**6.** *Point*: Secton 18(a) provides for the appointment of **Controller of Examinations**, the qualifications and experience for the post of controller of Examinations shall be such as may be prescribed by the statute in this regard under section 51(8). It is possible for the Vice- Chancellor to regulate the matter by issuing directions under the provisions of section 14(8)

- (३) अद्याप कारवाई केली नसल्यास, याबाबत होणाऱ्या विलंबाची कारणे काय आहेत?

- ३. अशा शिक्षकाची सलग १२ वर्षे सेवा मोजतांना सेवाखंडाचा कालावधी पदावनती /प्रतिनियुक्ती / सेवाखंड या कारणास्तव झालेला सेवाखंड वगळून नेमणुकीच्या दिनांकापासून उच्च माध्यमिक स्तरावर १२ वर्षे सेवा झाल्यानंतर त्या शिक्षकास वरिष्ठ वेतनश्रेणीसाठी पात्र ठरविणे.
- ४. तीन आठवड्याचे सेवांतर्गत प्रशिक्षण पूर्ण करणे, या अटीतून वयाची ५५ वर्षे पूर्ण करणारे शिक्षक विहित मुदतीत प्रशिक्षण पूर्ण करण्याचे हमीपत्र देणारे शिक्षक व भविष्य काळात स्वेच्छा सेवानिवृत्ती स्वीकारणारे शिक्षक अशांना प्रशिक्षणाच्या अटीतून वगळणे.
  - (३) कार्यवाही चालू असल्यामुळे प्रश्न उद्भवत नाही.

Clarification: The existing post of Controller/Deputy Registrar, In charge of Examinations, shall be redesignated as the Controller of Examinations and the post shall be of the rank of the Non-Academic Registrar.

**7.** *Point*: Under clause (1)(b) of section 20 the words 'Finance Officer' should be substituted by the words 'Finance & Accounts Officer''.

Clarification: The present post of Finance Officer shall be redesignated as Finance & Accounts Officer, It is obvious that he will be the Head of Accounts as well. The post shall be of the

rank of Non-Acacemic Registrar.

**8.** *Point*: In Section 29(2)(1) words "Joint Director of Education (Higher Education) be inserted before the words Maharashtra state" and in section 29 (2) (m) words 'Divisional Chairman of the concerned Divisional Board of Maharashtra State Board of Secondary Education' & Higher Secondary Education be added at the end.

Clarification: Wherever the word Director (Higher Education) appears in the Act it should be taken to include as Joint Director (Higher Education) similarly in section 29 (2) (m) words 'Chairman of the Maharashtra State Board of Secondary and Higher Secondary Education' should be taken to include the Divisional Chairman.

9. Point: The provisions of sections 30(2)(p) indicate that the autonomous status is to be conferred in accordance with the provisions of oridinances. However, under section 51(11) there is a provision for making of Statutes for laying down the norms for grant of autonomous status to colleges, etc. It is, therefore necessary that the provisions for autonomous status should be covered under the statutes Hence the word 'ordinances' should be replaced by the word "statutes". in the provisions of section 30(2)(p)

Clarification: Since statutes rank

10. Point: Under the provisions of section 31(3)(c), the Dean of the Faculty concerned with the Examinations is mentioned. However, it is noted that since every Dean is concerned with the examinations with respect to his Faculty, it is necessary that all the Deans of Faculties should be the members of the Board of Examinations otherwise, there will be a separate Board of Examinations for each Faculty. To remove this difficulty it is necessary that the provision of section 31(3)(c) should be substituted by the words the "Deans of Faculties."

*Clarification*: The provision in section 31(3)(c) should be read as "the Deans of Faculties". In law singular and plural are interchangable.

11. *Point*: In section 35(2)(d), in line two the 'comma' after the words University should be deleted.

Clarification: It is a printing error, Hence in section 35(2)(d) in line 2 the 'comma' after the word "University" should be deleted.

**12.** *Point*: In section 35(2)(e) in line one the word 'institution' be replaced by the word "Instruction".

**Clarification:** It is a printing error and hence in section 35(2) (e) in line one, the word "institution" should be read as instruction.

The Question of treatment of a portion of dearness allowance as "dearness pay" has been under copsideration of Government. Government is now pleased to decide that for State Government employees who retire or die on or after 16th September 1993 a portion of the dearness allowance as linked to average CPI 729.91 obtaining as on 1 March 1988 i.e.20% of basic pay shall be treated as "dearness pay" This dearness pay (i.e. 20% of basic pay) will count only for reckoning pay for the purpose of retirement gratuity Rules, 1982 and for no other purpose. However, there will be no change in the existing upper ceiling of maximum amount of gratuity i.e.16.5 times of pay or Rs. one lakh, whichever is less.

- 2. These orders come into effect from 16th September 1993 and the Death/Retirement Gratuity of persons who have already died/retired on or after 16th September 1993 shall be recalculated on the basis of these orders and arrears, if any, shall be paid.
- 3. Government is also pleased to direct that above decisions should mutatis mutandis, apply to those full time teaching and non-teaching employees of recognized and aided educational institutions, non-agricultural Universities and affiliated non-Government Colleges to whom the pension Scheme is made applicable.
- 4. In exercise of the powers conferred by the proviso to section 248 of the Maharashtra Zilla Parishads and panchayat Samities Act. 1961 (Mah.V of 1992) and of all other powers enabling it in that behalf, Government is further pleased to decide that the above decision should also be extended to the employees of zilla parishads.

Whereas the Maharashtra Universities Act (Maharashtra Act xxxv) has come into force with effect from 22nd July, 1994 and whareas doubts certain/difficulties in implementing the provisions of this Act have been brought to the notice of the Government from various quarters.

Now therefore, in exercise of the powers vested under section 116 of the Maharashtra Universities Act, 1994 the Government is pleased to issue necessary clarifications and directions in respect of various points raised as under:-

### Sr.No. Points raised, Clarification

1. Under Section 2(34) the term "teacher" means full-time approved professor, associate Professor, assistant Professor, reader, lecturer, Librarian Director or Instructor of physical education in any University department, conducted affiliated or autonomous College/ autonomous institution or department or recognised institution in the University.

(i) A Point has been raised as to whether the part-time teachers could discharge the functions of teaching, research, paper setting in the examinations evaluation of answer books, research guides, examiners and other functions of teachers assigned by the universities and colleges as hithertofore.

Clarification: As permitted under the various acts of the universities, prior to coming into force of the Maharashtra Universities Act, 1994, the part-time and honorary teachers can discharge all such functions as hither to fore.

(ii) Whether the part-time teachers and honorary teachers can take part in the elections to the various authorities and bodies of the University as contestants or voters.

Clarification: Part-time and honorary teachers connot now take part in the elections to the authorities and bodies of the Universities either as contestants or as voters.

### MEMORANDUM TO THE MINISTER OF HRD, GOVT. OF INDIA ON 24TH JANUARY, 1994

Sub: Mass deputation of University and College teachers to parliament.

Dear Sir,

Hundreds of University and college teachers from all over India will hold a mass deputation to parliament on 8th March, 1994 to press for acceptance of the most urgent and pressing demands of our profession.

Since the formation of the Fifth Central Pay Commission and an award of interim relief to all the employees under the Central Government including the staff of the Central Universities since 17.9.93, the most urgent issue for the remaining university and college teachers has been the setting up of appropriate pay-Review Committee by the U.G.C. and recipt of interim relief (I.R.) at the same rate and from the same date. While some state governments have agreed to pay I.R. at par with the Central Government, most of the state Governments unfortunately have not done anything in this matter. Besides neither the UGC nor the government of India have done anything in the matter. The least that the UGC should have done is to make recommendation for payment of I.R. to all state governments and universities at par with Central universities as they had done in the past.

We strongly demand that the government of India ask the UGC to take effective measures for payment of I.R. and set up a pay Review Committee immediately. Besides, the Govt. of India must take adequate

Kindly refer to your letter No. G-014/94 dated 24th January 1994 addressed to the Minister of Human Resource Development regarding certain demands pertaining to the university and college teachers.

### **UNIVERSITY GRANTS COMMISSION**

Minutes of the Second meeting of the Committee held on 8th July 1994 in the office of the UGC to consider and give recommendations to the Commission regarding the re-employment of superannuated teachers

The Commission appointed a committee to consider the matter regarding re-employment of University and College teachers. The Committee had its second meeting on 8th July 1994 in the UGC Office. The following were present:

1. Professor G.Ram Reddy, Chairman, UGC.
2. Dr. Bashiruddin Ahmed, Vice Chancellor, Jamia Mallias Islamia, New Delhi. 3. Prof. S.D.Karnik, Vice Chancellor, Bombay University. 4. Dr. (Ms) A.S. Desai, Director, Tata Institute of Social Sciences, Sio-Trombay, Deonar Bombay, 5. Dr. Meenakshi Gopinath, Principal, Lady Sri Ram College, New Delhi. 6. Professor S.K.Agarwala, Formar Secretary, Association of Indian Universities, New Delhi. 7. Dr. Anand Swaroop, Hon'y Editor, University Grants Commission New Delhi. 8. Dr. Mrinmoy Bhattacharya, General Secretary, AIFUCTO Calcutta. 9. Shri. R.P.Gangurde, Additional Secretary, University Grants Commission, New Delhi. 10. Shri. A.K.Dogra, Deputy Secretary, University Grants Commission, New Delhi. 11. Shri. Dilbagh Singh, Under Secretary, University Grants Commission, New Delhi.

Tutors to Lectureship and extension of benefit of career advancement.

- 14.Promotion of other Demonstrators/Tutors to senior Demonstrators/tutors in lecturers grade on completion of 18 years
- 15. Govt. of India should revise its order in compliance with the judgement of Rajasthan High Court allowing same scales to Readers and Professors promoted in accordance with Merit Promotion Scheme.
- 16. Additional increment for Ph.D/MPhil degree holders including those who joined before 1.1.86 and who attained them during service.
- 17. Senior scale for those reaching basic pay of Rs. 2800/- irrespective of the number of years of service rendered.
- 18. D.Sc., D.Lit, M.L. M.D. should be considered for additional increments and service with D.Phil/M.Phil.
- 19. Bunching benifit should be extended to all teachers irrespective of their grades.
- 20. Dy/Asstt., D.P.Es and Dy/ Asstt. Librarians with comparable qualification and responsibility should get the benefit of scales available to Librarians and DPEs.
- 21. Cartographers should be given the same scales as those enjoyed by Demonstrators and Tutors.
- 22. Relaxation of condition of 55% for teachers who are already in service in degree or plus two level.
- 23. Counting of service at plus two level and Junior Colleges for career advancement.
- 24. Solution of problems of plus two college teachers on the basis of common scales for plus two and degree college teachers.

In his opening remarks, the Chairman, UGC informed the members that the issue of reemployment of superannuated teachers in the College as well as Universities is not in a satisfactory state. There are difficulties as well as criticism with regard to modalities being adopted for re-employment of teachers. After deliberations the following emerged as consensus.

- 1. The Committee agreed that there is no uniformity among the various universities and Colleges in different states all over the India regarding age of superannuation. It was observed that in some states even 55 years is the age of retirement, as such it was strongly recommended that UGC may vigorously try to implement the recommendations of Mehrotra Committee. as regards the uniform age of retirement (60 years) in all states in the country.
- 2. It was informed that in some States. benefit of pension is not available for university as well as college teachers. The UGC must ensure that at least all the States adopt the provision of pension scheme to all university/College teachers.
- 3. It was suggested that the mobility of teachers from one state to another and from one institution to other institution be encouraged.
- It was pointed out that the services rendered by the teachers in one state or institution is not counted for the purposes of superanuation benefit. The Commission may issue guidelines in this regard. The Chairman informed the members that the Commission at its last meeting held on 28th June 1994 has approved guidelines on the subject and the same will be issued to universities/Colleges shortly.
- 4. The Committee agreed that the age of superannuation of teachers in all the states be made 60 years and adequate waiver be provided upto 5 years so that the teachers get full retirement benefit which is available for serving 33 years.
- 5. The Committee was of the view that in no case teachers will be re-employed after 60 years of age but with an exception to this be, part-time teachers/guests lecturers etc.
- 6. The Committee suggested to create a pool of retired teachers administered centrally by the UGC. The teachers who wish to offer themselves for reemployment may apply and there will be a mechanism, developed for selection. Then the colleges/universities who required the services of such teachers will be provided the same from this pool.
- 7. A suggestion was made that the service rendered prior to taking up teaching post in university/College as pre-requisite for the post be counted for retirement benefits.

The Chairman, informed the members that the recommendations of the committee will be placed before the pay committee of teachers, which Commission is going to announce shortly. This will be one of the term of reference of the proposed pay committee. The meeting ended with vote of thanks to the Chair.
