- (2) As per the decision in this meeting a Writ Petition consisting of 56 paras has been filed in the High Court of Judicature at Bombay, Nagpur Bench on 19-03-2016. The Stamp Number of the petition is 6576/16. The petition has been filed on behalf of NUTA and 110 petitioners.
  - (3) The prayers in the petition are as below-

"It is therefore, most humbly and respectfully prayed that this Hon'ble Court may kindly be pleased to issue suitable writ, order or direction and be pleased to.......

- (a) Command the respondent no. 2 State of Maharashtra to extend the pensionary benefits to the petitioners as per the Government of India's Scheme dated 31.12.08 (Annexure-E) as adopted through Government Resolution dated 12.08.09;
- (b) Hold and declare that the impugned Government Resolution dated 05.05.2009 (Annexure-K) is not applicable to the class of Petitioners in this petition in particular and Teachers working in the Universities and the Colleges in the State of Maharashtra in general;
- (c) Hold and declare that the Superannuated Lecturers retired in the Selection Grade/Readers Scale after completing 3 years of service in the Selection Grade prior to 01.01.2006 are entitled for the fixation of pension that will be subject to the provision that the revised pension, in no case, shall be lower than fifty percent of the sum of the minimum of the pay in the pay band and the grade pay thereon corresponding to the pre-revised pay scale from which the pensioner had retired w. e. f. 01.06.2006 as a result of 6th Pay and further direct the respondent State to take immediate action for fixation of pay and pensions of the petitioners accordingly and release the same alongwith interest within a stipulated period;
- (d) Hold and declare that recommendation of Hakeem Committee are not applicable for deciding pensionary benefits of the teachers working in the Universities and the Colleges in the Maharashtra;
- (e) Grant any other relief, which this Hon'ble Court may deem fit and proper in the facts and circumstances of the case in the interest of justice and equity.""

# SECRETARY'S REPORT ON THE WORKING OF THE ASSOCIATION FOR THE YEAR ENDING ON 31 st DECEMBER, 2015

Prepared by the Executive Committee of NUTA under article (VI)(b)(ii)of the Constitution of NUTA and presented by Secretary on behalf of the NUTA Executive Committee

#### Dear Friends,

- (1) It gives me immense pleasure to extend very warm welcome to you on behalf of the Executive Committee of NUTA and on my own behalf. It is indeed a proud privilege for me to place before this august body a brief account of our activities and achievements during the year 2015.
- (2) Right from its inception, NUTA has been committed to the cause of welfare of the teaching community and their professional betterment. In keeping with this commitment, the Association took up several issues concerning the teachers during the period of this report which witnessed significant developments and had major achievements. This particular year was again the year of continuous struggle for major issues.

#### ISSUE OF NET-SET AFFECTED TEACHERS

- (3) This year the main focus obviously remained on the issue of net-set affected teachers. The govt. however, remained callous. It preferred not to implement several decisions in Writ Petitions decided in favour of the teachers on the basis of Supreme Court interim order of 18 Nov. 2013. As a matter of fact, the ongoing agitation in the state was unilaterally withdrawn by the MFUCTO following a tweet by the Minister for Higher and Technical Education shri Vinod Tawade on 8 December, 2014 "One day CL of college teachers for their demands. I am positive for them would appeal them to give us some time for, We hardly have completed a month!"
- (4) Interestingly, the Department of Higher Education had sought an explanation through a communication dated 11 November, 2014 from the Director of Education, Pune and the Joint Directors of Aurangabad, Nanded and Jalgaon as to why implementation of orders in W. P. nos. 3448/2014, 3552/2014, 1704/2014, 394/2014, and 4173/2014 was not done when it was mandatory to implement the orders subject to supreme court judgement and instead why did they submit proposals to the Director for guidance who instead of taking a proper decision submitted them to the Mantralaya. It was obvious that this exercise was a mere show and the High Court Orders were never sought to be implemented.
- (5) At the Supreme Court level, the MFUCTO and NUTA had filed intervention applications in the matter of Special Leave Petition filed by the State Government against the decision in respect of Asha Ramdas Bidkar & others and had also sought to make submissions to strengthen the ongoing battle. The Supreme Court passed a significant order on 25-03-2015 in respect of intervention applications while dealing with Civil Appeal No. 10759/2013 with C. A. No. 10760/2013 changing the course of battle at the apex court. The following is the extract from the Order:
- "1) On the taking up of Civil Appeal No. 10760 of 2013 we have come to learn that several Respondents as well as other Lecturers /Assistant Professors similarly placed who are vitally affected by the core issue which has now been canvassed before us have neither been impleaded nor have been heard by the High Court of Judicature at Bombay. We are further informed that as on date there are over hundred Writ Petitions pending in the Principal Bench and the Benches at Nagpur and Aurangabad of the

- High Court of Judicature at Bombay. It has been pointed out by the Learned Senior Counsel that Maharashtra Federation of University & College Teachers Organisation, (MFUCTO), Respondent in Civil Appeal No. 10759/2013, had filed a Writ Petition which is pending before the Principal Bench. This Association is also seeking to be heard in the proceedings before us.
- 2) In these circumstances the course which commends itself to us is to stay the operation of the Impugned Order without, in any manner, causing any disadvantage to any of the parties who are the beneficiaries to the impugned Judgement.
- 3) Accordingly, we request Hon'ble the Chief Justice of the High Court of Judicature at Bombay to constitute or nominate a Bench at the Principal Bench, to which all pending Writ Petitions should be transferred, and which Bench should forthwith take up the matters, in expedition and decide all the Writ Petitions preferably within a period of six months from today.
- 6) Mr. B. H. Marlapalle learned Senior Counsel for the State of Maharashtra assures the Court that no adverse action shall be taken against the Respondents in the Appeal before us.
- 7) Liberty is also granted to affected persons to seek in the High Court of Judicature at Bombay ad interim orders which may place them on parity with other Lecturers/Assistant Professors similarly placed."
- (6) According to the Supreme Court Order all the Writ Petitions including Contempt matters at Principal seat and other Benches falling within the purview of this order were transferred to Bombay where a special Bench comprising Hon'ble Justice Anoop Mohata and Hon'ble Justice A. A. Sayyad was constituted.
- (7) The hearing at the Special Bench started on 16th July, 2015. MFUCTO engaged the services of Senior Lawyer Adv. Mihir Desai who ably presented the case of NET-SET affected teachers. NUTA also engaged Senior Lawyer Adv. Firdos Mirza who argued on behalf of the petitioners from this region. He also submitted Notes of Arguments based on legal positions and documents aptly replying the questions raised during the course of hearing. Unfortunately, in a complete turnaround, the State Government took a hostile position conveniently forgetting that it had accepted on the floor of the House that the Net-Set qualification was never prescribed through a lawful instrument during the period in question, and had agreed on affidavit to act once the UGC informed about the date from which to count service for the purpose of CAS which the UGC had done.
- (8) Contrary to expectations, in a sudden development Hon'ble Court delivered its Judgement on 23 December, 2015 dismissing the petitions and upholding the Government resolution of 27 June, 2013 which was shocking and disappointing for the teaching fraternity in the state. MFUCTO examined and analysed the Court Order and has identified several issues which need to be pointed out to the Hon'ble Supreme Court along with documentary evidences. It has been decided by MFUCTO that 3 Special Leave Petitions would be filed. The first will be filed by MFUCTO on the basis of W. P. No. 2082 of 2013, another

will be filed by NUTA based on W. P. No. 8026 of 2015 and the third to be filed on the basis of one of the petitions filed by PUCTO & SUTA. The teachers do hope that justice will prevail in Supreme Court.

(9) The Association had held two meetings of Net-Set affected teachers on 8 February, 2015 and on 26 April, 2015 to ensure their participation in the Writ Petitions filed in the Court seeking benefit as per the Supreme Court Interim order of 18 November, 2013. A meeting of those Net-Set affected teachers who were appointed as Principals was also held on 24 January, 2015. Curiously, after the 25 March, 2015 Supreme Court Order, in as many as 9 petitions the orders were obtained in favour of these teachers. We are now looking forward to the Supreme Court to deliver justice.

#### **OTHER COURT MATTERS:**

- (10) A meeting of those teachers who retired before 1 January, 1996 after completing 5 years service in Selection Grade was held on 25 January, 2015. As decided in the meeting Writ Petition nos. 5647 of 2015 and 6516 of 2015 with 11 petitioners seeking the benefit of pension fixation on the basis of 14940/-for such teachers were filed which are in progress.
- (11) In a meeting of those teachers who retired before 1 January, 2006 after 3 years or more service in Selection Grade which was held on 20 September, 2015, it was decided to file Writ Petition in this matter because denial of pension less than 50% of the minimum of the revised pay band introduced by the pay commission for the post last held by the employee at the time of his retirement amounted to discriminatory treatment. In Writ Petition No. 4292 of 2013 filed at Aurangabad Bench the Hon'ble Court on 8-5-2015 had directed the Respondent State

Government to reconsider the entire issue keeping in view all the relevant documents and take the fresh decision within four months which the government failed to do. As such, a Writ Petition with 110 petitioners has been filed.

(12) Another section of pensioners who were subjected to discriminatory treatment were those who retired between 1 January, 2006 and 27 February,2009 after putting in 3 years or more service in Selection Grade. After their meeting on 4 October, 2015 a Writ Petition is being filed at the High Court of Judicature at Bombay, Nagpur Bench.

## APATHETIC ATTITUDE OF THE STATE GOVERNMENT

(13) The State Government all along continued with its apathetic attitude towards the issues faced by the teachers. There was no discussion with MFUCTO after 19 November, 2014 when Shri Vinod Tawade met the Association with no action following up. In the matter of Net-Set Court Orders the Joint Director of Jalgaon region had also to tender an unconditional apology in an affidavit filed on 10-06-2015 in Contempt Petition No. 266 of 2014 in W. P. No. 642 of 2014 for not complying with the Court Order. Nevertheless, the Government continued with its policy of non-compliance of Court Orders in utter disregard to the Court of Law and the interests of teachers.

## ISSUES OF SOCIAL WORK COLLEGE TEACHERS

(14) Although 100% arrears on account of sixth pay revision were disbursed to the teachers under the Department of Higher Education by the end of 2013, there was no development in respect of the payment of arrears

to the teachers of Social Work colleges under the Department of Social Justice. Consequently the present Secretary of NUTA & 37 other teachers in R. T. M. Nagpur University area had filed a Writ Petition No.4377 of 2013 in the High Court of Judicature at Bombay Nagpur Bench after which the arrears for the period 01-04-2010 to 31-03-2012 were released sometime in the month of April 2014; but no assurance was forthcoming on the release of arrears for the period 01-01-2006 to 31-03-2010. And hence the petition at the Court was pursued further. After arm-twisting by the Court the Department of Social justice was required to deposit 25% of the arrears in the Court which were released in favour of the petitioners on 20-07-2015 after due formalities and remaining 75% amount was credited to the accounts of the respective petitioners by 5 October, 2015 after an undertaking was elicited by the court on 2 July, 2015 when the petition was disposed off.

(15) As far as pension to the teachers of Social work colleges was concerned, it may be stated that although the G. R. was issued on 29th October, 2014 following a contempt petition, the follow-up action was not taken up in right earnest by the Department and the process continued at a slow pace. As a result, the pension cases kept oscillating between A. G. office and the Department and they were at the stage of final approval only by the end of this year. Now it is learnt that the pension amount has begun to be credited to the accounts of respective

#### ISSUES OF AYURVED COLLEGE TEACHERS

(16) Although it was a common Court Order of 10 June, 2013 directing the State Government to extend the benefit of pension scheme to Social Work as well as Ayurved college teachers, the Department of Medical Education and Drugs brought out a Government Resolution extending this benefit on 17 January, 2015 only after the filing of Contempt Petition no. 102 of 2014. The Government Order extended the benefit of pension cum Gratuity scheme with effect from 21-11-2011 to the teachers of four petitioner Ayurved colleges. The Assistant Director of Ayurved Nagpur also issued a circular dated 13-03-2015 regarding implementation of the G. R. However, subsequently the Department indulged in hostile interpretation of the provisions of G.R. forcing the teachers to once again approach the Court of Law which has delayed the benefit of pension scheme to this segment of teachers.

#### **COLLEGE UNIT ELECTIONS**

(17) The college unit elections of NUTA were held on 9 February, 2015 simultaneously at all the colleges under the jurisdiction of Rashtrasant Tukdoji Maharaj Nagpur University, Sant Gadge Baba Amravati University and Gondwana University, Gadchiroli.

## SPECIAL ISSUE ON KELKAR COMMITTEE REPORT

(18) In discharge of its commitment and duty towards the society at large, the Association brought out a special issue titled 'Kelkari Karasthan Visheshank' which is an in-depth study and analysis of the report of the committee under the chairmanship of Dr. Vijay Kelkar appointed by the State Government to assess the state of backlog in the state. It is a compilation of the articles authored by Prof. B. T. Deshmukh, former Member of the Legislative Council which were published in Daily 'Hindusthan' between 18 January, 2015 and 7 June, 2015. Now it has been published as a special issue of NUTA Bulletin bearing page nos.157 to 208 of 2015. The issue has been widely appreciated for its content, rare insight and reference value.

#### AIFUCTO ACTIVITIES

(19) The attitude of the Central Government towards the issues of the teachers has been equally apathetic and strange. The H. R. D. ministry has not granted a single meeting to the All India Federation of University & College Teachers' Organisations (AIFUCTO) ever since the new government came to power. This is in sharp contrast with the earlier government which used to have regular dialogue with the Association. Being left with no other choice the AIFUCTO had to resort to a Massive Demonstration and Court Arrest Programme at Jantar Mantar New Delhi on 13 March, 2015. The demands were (a) Immediate MHRD approval of UGC decisions on 3rd amendment of UGC Regulations, 2010 and Ph. D. Regulations (b)HRM appointment to AIFUCTO to discuss the long standing professional demands (c) Allocate 6 percent GDP to education in the budget of 2015-2016 (d)Immediately

constitute VII pay revision Committee. (e) Strengthen public funded education (f) Regulate private sector institution (g) Ensure regular pension scheme & reject pension scheme-2004 (h) Consult teachers' organization on education policies including RUSA.

- (20) Since there was no response AIFUCTO launched an 'All India Signature Campaign'. Lakhs of teachers all over the country sent communications addressed to Minister HRD with a copy to PMO Office reiterating the demands and stressing the need for their solution through dialogue. In the next phase of agitation, AIFUCTO organized demonstrations at UGC office on 19th June 2015. As per its call to hold action at State capital, MFUCTO also organized demonstrations at Azad Maidan, Mumbai on 5th October, 2015.
- (21) With no response forthcoming from HRD, AIFUCTO in association with FEDCUTA once again organized a 'Jail Bharo Programme' on 24 November, 2015. At the statutory conference of AIFUCTO held at Ambaji in Gujarat from 18 to 20 December, 2015, AIFUCTO has given a call to the teachers in the country to get prepared for a nationwide cease work which will be inevitable if the government fails to wake up from its deep slumber and initiate measures to address the issues through dialogue in accordance with democratic practices.

#### PARTICIPATION IN ACTION PROGRAMMES

(22) I am happy to inform this August body that the teachers from Rashtrasant Tukdoji Maharaj Nagpur University, Sant Gadge Baba Amravati University and Gondwana University participated in large numbers in all the programmes of agitation launched by NUTA, MFUCTO and AIFUCTO and made them successful. Nevertheless, the struggle has not ended. The Association is keeping a vigilant eye on the developments at all levels leaving nothing to chance. I have absolutely no doubt that the success will come our way since our demands are lawful and are based on strong legal footing.

#### TASKS AHEAD

(23) Friends, it is true that some of our demands are nearing fulfillment because of the struggle of NUTA under the able leadership of MFUCTO. However, some of the old issues have remained to be resolved and in the meantime new issues have been thrown up which the teachers have to face such as introduction of The Maharashtra Universities Act giving more thrust on nominations in the Authorities of the Universities at the cost of democratic functioning and practices and doing away with better service conditions, contractual appointments, commercialization of education, starting of self-financing courses and institutions and exploitation of teachers and non-teaching staff in the system. You are aware that NUTA is committed to taking up the problems of every section of the teaching community irrespective of their number and strength in the organization. NUTA has therefore several tasks ahead viz.

- c) To ensure immediate and faithful implementation of the Government Resolution dated 17 January, 2015 extending the benefit of pension-cum-Gratuity scheme to the teachers of Ayurved colleges and subsequent Court orders
- d) Payment of sixth pay arrears to the teachers in colleges of Physical Education
- e) Issuance of GR implementing sixth pay revision for the teachers in unaided colleges of Engineering in the state.
- f) Stopping arbitrary functioning at the office of the Joint Directors.
- g) Compelling the government to withdraw orders on contractual appointments and till such withdrawal to pay them the salary on par with their counterparts in Government colleges.
- h) To take up the problems of engineering college teachers including the issue of withdrawal of their arrears for 55 months from 1-1-1996 to 31-7-2000.
  - i) Fight against anti-teacher attitude of the Government.
- j) Enactment of suitable legislation for providing penalties for non-compliance of the university Grievance committee recommendations.
- k) Oppose the move of the Central Government towards privatization of Pension and Gratuity and demand of extending old triple benefit scheme to those appointed after 1-1-2004 as recommended by UGC.
- 1) Making SET examination more transparent including unambiguous minimum percentage of marks.
- m) Ensure that all the benefits which teachers are given under the central orders are extended to Librarians and Directors of Physical Education.
- n) Faithful implementation of the central sixth pay revision 'package scheme'.
- o) To take all the ongoing cases in the Courts to their logical end

#### MEMBERSHIP OF NUTA

- (24) The NUTA membership has reached 5485 by the end of the year. This year the increase in membership is 26. I am glad to announce that NUTA Bulletin has completed 40th year of its purposeful existence. This year we have circulated 208 pages of NUTA Bulletin. On going through the pages of the NUTA Bulletin one finds that the Executive Committee has made an attempt to include relevant developments and documents and keep the members updated about the issues concerning their professional life.
- (25) I am grateful to the media and their representatives from Nagpur, Amravati and Gadchiroli areas for wide coverage of various events, programmes and the press-notes issued from time to time. This report shall not be complete unless I acknowledge the active cooperation and support of all the members of NUTA and other colleagues as well as the members of teaching profession at different levels to the activities of the Association and response given by them to various calls given by NUTA from time to time.

UPON hearing counsel the Court made the following

#### **ORDER**

This batch of appeals is before us at the instance of the State of Madhya Pradesh. They have called in question the common judgment and order passed by the High Court of Madhya Pradesh in Writ Petition No.1104 of 2000 etc., dated 11.01.2002, whereby and whereunder the High Court, after a detailed consideration of the arguments advanced by both the parties has come to the conclusion that the Madhya Pradesh Ashaskiya Shikshan Sanstha Adhiniyam, 1978 (for short 'the Act') as amended by Madhya Pradesh Ashaskiya Shikshan Sanstha

(Adhyapakon Tatha Anya Karmcharyon Ke Vetno Ka Sandaya) Sanshodhan Adhiniyam, 2000 (Amendment Act No.26 of 2000) is ultra vires being hit by Articles 14 and 21 of the Constitution of India and issued certain directions in respect of grant of pay scale as per the norms of the University Grants Commission.

On the last date of hearing, keeping in view the plight of the teachers/lecturers/non-teaching staff working in private aided educational institutions in the State of Madhya Pradesh, we had requested Mr.Tankha, learned senior counsel, to get appropriate instructions and file an appropriate affidavit before this Court. Though two or three adjournments were taken by Mr.Tankha to seek appropriate instructions for filing an appropriate affidavit, today, has filed two affidavits duly sworn in by Mr. Alok Khare,S/o.Shri J.P. Khare, Assistant Director, Department of Public Instructions, Government of Madhya Pradesh and by Dr. S.K. Pare, S/o.Shri K.C. Pare, Officer on Special Duty, Department of Higher Education, Government of Madhya Pradesh.

The said affidavits of the aforesaid officers are taken on record. In conclusion, in the affidavits so filed, it is stated as under:

- "A. The State Government proposes to pay the arrears at the existing approved scale from the next financial year i.e. April 2014 onwards;
- **B.** The arrears shall be paid after adjusting the tuition fee charged by private schools and colleges as per Circular dated 31.1.2000. The State Government shall ascertain the tuition fee charged by each school or college within 6 months;
- (i) After following the procedure in Clause B, in case of employees (teachers and other staff) who have expired, the State Government proposes to pay 100% arrears to their nominee at lump sum;
- (ii) After following the procedure in Clause B, in case of employees (teachers and other staff) who have retired but are alive, the State Government proposes to pay arrears in at least three equal annual installments;
- (iii) After following the procedure in Clause B, in case of employees (teachers and other staff) who are still in service, the State Government proposes to pay arrears in at least five equal annual installments;
- C. The State Government proposes to give grant in aid to the employees (teachers and other staff) who are still in service at the existing approved scale till their superannuation."

Clause A is not objected to by the respondentsteachers/lecturers/non-teaching staff. Insofar as Clause B is concerned, the learned counsel appearing for the respondents-teachers/lecturers/non-teaching staff, though have some reservations, have not expressed the same before this Court.

In so far as Clause C is concerned, Shri Shanti

It is further clarified that the Amended Act is applicable to those Teachers/Lecturers/
Non-Teaching staff, who are appointed by the private aided educational institutions in the State of Madhya
Pradesh, after promulgation of the amended Act.

(See Para 7 of the Supreme Court Order dated 07.01.2014 on Page 77 of 2016 NUTA Bulletin)

Bhushan, learned senior counsel, is of the view that the State Government has not placed the respondents-teachers/lecturers/non-teaching staff to the existing approved scales till their age of superannuation. Further according to the learned senior counsel, the pay scales that are being adopted for the teaching and non-teaching staff employed in government schools/colleges, should be extended to the teaching and non-teaching staff employed in the private aided schools/colleges as well. In our view, the submission of the learned senior counsel appears to be reasonable. Therefore, we now once again request Mr. Tankha to seek appropriate instructions on the aforesaid submissions made by Shri Bhushan.

We place on record our deep appreciation for the efforts made by Mr.Tankha and adjourn the matter to 7th January, 2014 at 3.30 p.m. as part-heard.

#### O R D E R C.A. No. 6362 of 2004 NEW DELHI: JANUARY 07, 2014.

- 1. This order is in continuation of our earlier order dated 12.12.2013. Both the orders should be read together.
- 2. By order dated 12.12.2013 we had requested Shri Tankha, learned senior counsel to get appropriate instructions/clarification from the State Government insofar as Clause 'C' of the affidavit dated 26.11.2013.
- 3. Today learned senior counsel, Shri Tankha has filed an affidavit on behalf of the State of Madhya Pradesh. In the said affidavit they have pleaded their inability to extend the 6th Pay Commission Scales to the Teachers/Lecturers/non-teaching staff working in private aided educational institutions in the State of Madhya Pradesh though their appointment is approved by the State Government.
- 4. After hearing Shri Tankha, Shri Shanti Bhushan and Dr. Rajeev Dhawan and other learned counsel appearing for the parties, we are of the opinion that the request of Shri Shanti Bhushan for extending the 6th Pay commission scales to the Teachers/

Lecturers/non-teaching staff working in the private aided educational institutions should be accepted and granted. We are also of the view that whatever amount that is being paid pursuant to the orders passed by this court on 12.12.2013 and 07.01.2014 shall not be recovered from the Teachers/Lecturers/Non-Teaching staff working in the private aided educational institutions.

- 5. Accordingly, while setting aside the judgment and order passed by the High Court, we direct that the 6th Pay commission scales shall be given to the Teachers/Lecturers/non-teaching staff working in the private aided educational institutions in the State of Madhya Pradesh. We further direct that the amount that is already paid pursuant to the orders passed by this Court on 12.12.2013 and 07.01.2014 shall not be recovered from the Teachers/Lecturers/non-teaching staff working in the private aided educational institutions in the State of Madhya Pradesh.
- 6. It is clarified that the Madhya Pradesh Ashaskiya Shikshan Sanstha Adhiniyam, 1978, as amended by Madhya Pradesh Ashaskiya Shikshan Sanstha (Adhyapakon Tatha Anya Karmcharyon Ke Vetno Ka Sandaya) Sanshodhan Adhiniyam, 2000 (for short "the Amended Act") shall not be made applicable to the respondents and other similarly situated persons.
- 7. It is further clarified that the Amended Act is applicable to those Teachers/Lecturers/Non-Teaching staff, who are appointed by the private aided educational institutions in the State of Madhya Pradesh, after promulgation of the amended Act.

Ordered accordingly.

In rest of the matters.

All the matters are disposed of in the same terms, observations and directions as in Civil Appeal No. 6362 of 2004.

demanded earliest resolution of the demands raised by AIFUCTO & FEDCUTA.

Speakers from various states and central universities highlighted the plight of teachers languishing without regular appointment, promotions & pensions for many years and violation of thelong established principle of parity with All India services by not fixing proper salary of teachers in various grades and denying upward mobility. The catastrophic role played by the unacademic API (Academic Performance Indicator), that weighs quantity rather than quality,in destroying in teaching learning and research was repeatedly emphasized. The sorry state of infrastructure, not the least of which is the filling up of teaching and nonteaching posts, is further exacerbated by the continuous reduction in funding due to decreasing budgetary allocation. Increasing privatization and profit mongering in the higher education sector has resulted in the denial of access to affordable, quality education for the vast majority of Indians. This has led to severe frustration, depression and an alarming suicide rate among the young, especially from marginalized sections. The attack on the autonomy of universities through continuous interference of the Govt. in the matter of courses, examination & evaluation system, has also led to a steep decline in the quality of education imparted , and emotional elienation of both students & teachers from the entire educational process. The meek surrender of successive governments to the diktats of WTO-GATS for reduction of subsidy to higher education has also severely eroded the sovereignty of the country in formulating its own education policy in keeping with the needs of vast majority of people.

Addressing the gathering leaders also cited the recent incidents in Hyderabad Central University, Jawaharlal Nehru University, Allahabad Uniersity as the examples of a concerted attackon the democratic student movement in the country that has been highlighting the above concerns through a sustained country wide struggle. The gathering decried the attempts to crush the democratic space for dialogue and discussion that is essential for the promotion of critical & creative thinking and is the essence of university and college education. Leaders appealed to the teachers to beware of attempts to raise divisive issues that could weaken the united teachers' movement & polarize society. Teachers reaffirmed their commitment to core constitutional values of secularism, pluralism, equlity. social justice, libertyand unity integrity of the country.

The historical Dharna was addressed and supported by leaders of various political parties, such as-Dr Thokchom meinya, MP(INC), Dr Dharamveer Gandhi, MP (AAP),Com. D Raja, MP(CPI), Com. Nilotpal Basu, Ex-MP (CPM), Com. Aziz Pasha, Ex-MP (CPM), Shri Ali Anwar, MP(JDU), Prof. Kiran Walia, Ex- minister, Delhi Govt., Com Amarjeet kaur (CPI), Com Biswajeet (AISF), Shri prabhakar Arde,National leader of Elementary teachers, Prof. V K Tiwari(FISE) who promised their whole hearted support to teachers. We have not only to carry over the great traditions of our organisation but also to maintain the historical role of AIFUCTO in the field of higher education across the country. You know well the education system in India, specially the higher education is passing through a crucial phase. Teachers in higher education sector are very much concern with the grave situations developing in this field and the fast changing scenario at central and states level are compelling teachers across the country to be ready and prepare themselves not only to face the challenges but also to protest for saving public funded education system in the country.

Friends, first meeting of new elected NEC was held on 28th Jan'2016 at Gandhi Peace Foundation, New Delhi with grand success. The new NEC of AIFUCTO expressed hearty thanks to all the members for their active support in holding NEC. A large number of state leaders/representatives with many former leaders were also present in the meeting. The meeting was presided by Prof. Kesav Bhattacharya, President, AIFUCTO.

The meeting first condoled the forced suicide of Rohith Vemula, a JRF research scholar in the university of Hyderabad exposes the sad discriminative condition that prevailing the campuses of higher education in India. The NEC also condemned the terrorist attack in Basha Khan University which claimed the lives of a teacher and no. of students in that university. Meeting expressed concerned over three women students of a private medical college in TamilNadu who committed suicide recently. NEC paid homage and respect to all of them by holding one minute silence.

#### **Action / Movement Programme**

- 3.Ensure meeting of the Minister-HRD with AIFUCTO-FEDCUTA to discuss and resolve the long standing professional demands and fix an appointment for the same.
  - 4. Scrap API.
  - 5. Withdraw CBCS and Central University Bill, 2013.
- 6. Expedite promotions and filling of lakhs of vacant posts as per the GOI Reservation Policy for SC/ST/OBC/PWD to ensure access of inclusive quality higher education.
- 7. Resolve CPF-GPF issue and grant pension to all appointed before 1.1.1986 as per the GOI Policy. Withdraw New Pension Scheme-2004 and ensure regular pension to all

- 8. Extend Dates for RC and OC Up to Dec 2015.
- 9. Grant UGC pay scales to all categories of teachers, librarians, DPEs & other academic staff
- 10. Resolve anomalies of VIth Pay Commission and ensure stepping -up.
- 11. Consult AIFUCTO-FEDCUTA and Other Teachers' Organizations on educational policies.
- 12. Stop commercialization of Higher Education& stop opening Higher Education to private foreign and domestic capital as per WTO/GATTS.

The action programmes are :-

- 1. All the affiliates shall organise one day programme at University level in the third/ fourth week of Feb'2016 in the form of Protest March or Massive Dharna. Each and every college/university unit must be made aware of anti-teacher and undemocratic attitudes of the govt. towards the education sector in general and higher education in particular.
- 2. State Level one day massive protest program on 29 Feb'2016 across the country exposing autocratic and apathetic attitude of the govt. - 3. Regional Meeting and Seminars for involving grass root teachers. It is awareness program to our demands.
