**SECRETARY'S REPORT ON THE WORKING OF THE ASSOCIATION  
FOR THE YEAR ENDING ON  
31 ST DECEMBER, 2016**

*Prepared by the Executive Committee of NUTA under article (VI)(b)(ii) of the  
Constitution of NUTA and presented by Secretary on  
behalf of the NUTA Executive Committee*

Dear Friends,

(1) It gives me immense pleasure to extend very warm welcome to you on behalf of the Executive Committee of NUTA and on my own behalf. It is indeed a proud privilege for me to place before this august body a brief account of our activities and achievements during the year 2016.

(2) Right from its inception, NUTA has been committed to the cause of welfare of the teaching community and its professional betterment. In keeping with this commitment, the Association took up several issues concerning teaching community during the period of this report which witnessed significant developments and had major achievements. While continuing the struggle for major issues, the Association was compelled to approach the Court of Law for their resolution.

**ISSUE OF NET-SET AFFECTED TEACHERS**

(3) After the petitions at the special Bench constituted at the High Court of Judicature at Bombay at the instance of Supreme Court were dismissed on 23<sup>rd</sup> December, 2015, the scene once again shifted to Supreme Court of India. As per the decision of the MFUCTO in its meeting held at Mumbai on 7 February, 2016, the first petition was filed by MFUCTO on the basis of W. P. no. 2082 of 2013. And on behalf of NUTA 4 Special Leave Petitions were filed on 28-3-2016. The General Body has already been informed that there are total 742 petitioners in 55 Writ Petitions in which order has been challenged. (P85NB2016) The MFUCTO has made all preparations to contest the matter in right earnest at the Supreme Court and NUTA has also engaged a Senior Counsel with other able lawyers to forcefully fight the case leaving nothing to chance. The matters have been in progress at Supreme Court level. And we have every reason to believe that justice will come our way at the Apex Court since our cause is right and is supported by settled law and many recent judgements.

4) As decided at the meeting of MFUCTO Executive Committee held at Mumbai on 7 February, 2016, the Association held the meetings of Net-Set affected teachers at Amravati and Nagpur on 5-3-2016 and 6-3-2016 respectively to apprise them of the resolution adopted by MFUCTO in regard to further course of action, the order passed by Bombay High Court and the measures proposed to be taken to strengthen the battle at supreme court level.

**BENEFIT OF PENSION FIXATION ON THE BASIS OF 14940/- ON 1 JANUARY 1996 TO THOSE WHO RETIRED BEFORE 1 JANUARY, 1996 AFTER COMPLETING 5 YEARS SERVICE IN SELECTION GRADE**

(5) Following the decision at the meeting of those teachers who retired before 1 January, 1996 after completing 5 years service in Selection Grade, Writ Petition nos. 5647 of 2015 seeking the benefit of pension fixation on the basis of 14940/- for such teachers was filed by the Association at The High Court of Judicature at Bombay, Nagpur Bench. Subsequently, another Writ Petition no. 6516 of 2015 also came to be filed under the guidance of the Association. Both the petitions were decided on 25th July 2016 (P115NB2016) in favour of the petitioners with the following order:

*“4. In this situation, as controversy is already covered by the adjudications and entitlement of lecturers like petitioners to fixation at Rs. 14940/- after completion of 5 years in selection cadre is already accepted, we direct the respondent nos. 4 and 5 to undertake necessary exercise and to find out the relevant date for that purpose in case of each petitioner. This exercise shall be subject to further orders of the Hon'ble Supreme Court in SLP, after it is restored.*

*5. The directions be complied within a period of four months from today.*

*6. If any amount is thereafter found payable to the petitioners, the same shall be made over to them within next four months, subject to further orders of the Hon'ble Supreme Court in the matter.*

*7. We find that at Bombay interest @ 8% p. a. has been ordered to be paid. Petitioners here are also entitled to said interest from 08.09.2015 (date of filing of petition), till it is actually received by them.”*

(6) The Association had submitted a copy of the said order to the Joint Director of Nagpur and Amravati region vide its letter dated 16 August, 2016 with a request to implement the order in respect of the petitioners and the similarly situated teachers. (P138NB2016) Now in Nagpur region, the Joint Director has initiated the process of implementation of the order vide its letter dated 27-12-2016 addressed to the concerned colleges and the University in respect of the petitioners.

**BENEFIT OF 50% PENSION TO THOSE TEACHERS WHO RETIRED BEFORE 1 JANUARY, 2006 AFTER 3 YEARS OR MORE SERVICE IN SELECTION GRADE**

(7) As per the decision in the meeting of the concerned teachers, a Writ Petition no.3052 of 2016 seeking the fixation

of pension that will be subject to the provision that the revised pension, in no case, shall be lower than fifty percent of the sum of the minimum of the pay in the pay band and grade pay thereon corresponding to the pre-revised pay scale from which the pensioner had retired w.e.f. 01-01-2006 has been filed on behalf of NUTA and 110 petitioners and the same is in progress. (P85NB2016)

**BENEFIT OF BENEFICIAL PENSION TO THOSE TEACHERS WHO RETIRED AFTER 1 JANUARY, 2006 AND BEFORE 27 FEBRUARY, 2009 AFTER 3 YEARS OR MORE SERVICE IN SELECTION GRADE**

(8) Following the decision in the meeting of the concerned teachers, a Writ Petition no. 4908 of 2016 was filed in the High Court of Judicature at Bombay, Nagpur Bench on 5-8-2016 by NUTA with 26 petitioners when the representation dated 26-04-2016 addressed to the concerned was not responded to. (P91NB2016) The Petition sought the benefit of fixation of beneficial pension by undertaking the exercise of computing pensions of those teachers who retired after 1 January, 2006 and before 27 February, 2009 after 3 years or more service in Selection Grade by considering their 50% of the average salary of last 10 months or 50% of the last month's salary. The matter has been in progress at the Court before which it has been decided to bring to its notice the order of Aurangabad Bench in W. P. no. 8985 of 2011 decided on 9 May 2014 and other subsequent orders.

(9) In the meantime we have been officially informed by

our lawyer that the State Government had filed a SLP(Petitions(s) for Special Leave to Appeal (C)...../2015 CC No(s). 6186-6191/2015) in the matter of order of Aurangabad Bench in W. P. no.8985 of 2011 delivered on 9 May, 2014 and when the matter came up for hearing on 24 April, 2015, the Supreme Court passed the order "Delay condoned. Issue notice. Till the next of hearing, the operation of the Impugned Judgement shall remain stayed." At Supreme Court, this matter (Petition(s) for Special Leave to Appeal (C ) Nos. 13140-13151/2015) is pending hearing.

**NEW FEATURE ADDED TO NUTA WEBSITE**

(12) As you know, the Association has launched a website [www.nuta.in](http://www.nuta.in) which has proved to be an effective medium

to reach the members. It is observed that more than 10 thousand persons have visited the site during the last few months which proves that it has turned out to be an excellent medium for the members and non-members to access required information. 'NUTA Bulletin' has already been in place and over a period of time it has turned out an effective medium to keep the members informed. However, the bulletin has to be posted on the 1<sup>st</sup> or the 15<sup>th</sup> of the month due to postal restrictions. And hence with a view to be able to establish contact with the members or convey urgent information in between if the situation so warrants, it was decided to add a feature called "Urgent Communications" to NUTA website from the current year. This year 4 such communications were uploaded and subsequently printed in NUTA bulletins and as per the decision of the General Body an 'Index to Urgent Communications 2016' has also been published.

**SUBMISSION TO PAY REVIEW COMMITTEE**

(13) As you know, because of the pressure built up by AIFUCTO the Seventh Pay Review committee was constituted by UGC on 9 June 2016. After mounting further pressure, the committee was forced to announce the schedule of regional consultative meetings starting with Southern region meeting at Chennai on 19 August, 2016. Meeting for Western region was held at Pune on 20 October, 2016. The MFUCTO made a detailed submission to the Committee on the issues covered under the Committee's Terms of Reference. Prof. B. T. Deshmukh, Ex MLC and Dr. P. B. Raghuvanshi, President NUTA who were also the members of five member MFUCTO delegation submitted a Note titled 'Let the Love Letter Era come to an end' incorporating justification on a particular submission included in the "Submission on the issue of pay revision and other related matters" by AIFUCTO to the Committee. (P169NB2016)

**TALUKA UNITS OF NUTA; BYE-LAWS - 1999**

**PROVIDING FOR THE ESTABLISHMENT OF TALUKA UNITS OF NAGPUR UNIVERSITY TEACHERS' ASSOCIATION**

WHEREAS it is expedient to frame bye-laws providing for the establishment and functioning of the Taluka units of the association;

**HOSTILE ATTITUDE AND ARBITRARY FUNCTIONING OF THE DEPARTMENT OF HIGHER EDUCATION OF THE STATE GOVERNMENT**

(14) The Department of Higher Education continued its hostile attitude towards teachers. One such instance was the hasty acceptance of University Grants Commission 2nd amendment of the Regulations of 13 June, 2016 which contained many adverse provisions and issuance of G. R. dated 15 October, 2016. (P194NB2016) MFUCTO immediately addressed an appeal dated 15 November, 2016 to the Department to revoke the Government Resolution of 15th October, 2016 pointing out that the promulgation of the said GR was unlawful as it sought to implement provisions that were superseded by the UGC Regulations (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) (4th Amendment) 2016, dated 11-07-2016. (P193NB2016)

(15) The office of the Joint Director, Nagpur region addressed a communication dated 26 December, 2016 to the Registrars of the Universities in the region and the Principals of affiliated colleges directing them to record the participation of teachers in the 'strike' between February, 4 and May 10, 2013 in response to the call given by MFUCTO. The communication had also sought the list of teachers who had retired or would retire between February, 2013 and March, 2017 whose superannuation cases were either approved or were going to be approved since the entry of their participation in the 'strike' was not recorded in their service book. (P04NB2017)

(16) The Association immediately wrote to the Joint Director, Nagpur region through a communication dated 30 December, 2016 conveying the fact that the teachers in the state of Maharashtra had participated in the agitation of 'non-cooperation with all examination-related work' during the said period and were not on 'strike' as claimed in her communication. Most importantly, it was also mentioned that the MFUCTO had challenged the Circular letter dated 6th March, 2013 containing directions not to release the salaries to the teachers who had participated in the agitation during the said period in the Court of law through Writ Petition. And since the matter was pending adjudication, the

action of issuing above direction was uncalled for and lacked propriety. (P03NB2017) The same day the Joint Director, Nagpur sent another communication dated 30 December, 2016 to the affiliated colleges stating that she was under instructions from the office of the Director, Higher Education, Pune not to pursue the said directions. (P05NB2017)

(17) The Joint Director, Amravati region had also issued a communication dated 29 December, 2016 containing similar direction to the Principals of affiliated colleges in Amravati region. However, she also issued a communication on 30 December, 2016 cancelling her earlier communication since the matter was 'subjudice'. The whole episode demonstrates how the Department of Higher education is indulging in hostile and arbitrary functioning.

#### ISSUES OF AYURVED COLLEGE TEACHERS

(18) In the last year's report it was reported that the benefit of pension cum gratuity scheme was delayed to the Ayurved college teachers although a G.R. was issued on 17 January, 2015 because of the hostile attitude of the bureaucracy of the state government. Consequently a series of petitions and contempt petitions followed, the last being the order passed on 28-9-2015 "Hence, for the reasons recorded in the judgments dated 10.6.2013 and 9.2.2015 in Writ Petition Nos. 5771/2011 and 5155/2014 respectively, the present writ petitions are allowed. It is hereby held that the petitioners appointed on or before 31.10.2005 would be entitled to the benefit of gratuity-cum-pension scheme as per the Government Resolution dated 21.7.1983 and those appointed on or after 1.11.2005 shall be governed by the new defined contribution pension scheme. The petitioners would be entitled to such benefits from the date of filing of the writ petitions. The Government should process the cases of the petitioners within a period of six months." Later on the Special Leave Petition challenging order in W. P. no. 1480/2015 was also dismissed by the Supreme Court on 29-09-2016. This should now pave way for the extension of the benefit of pension to this segment of teachers.

#### AIFUCTO ACTIVITIES

(19) Since there were not significant developments in terms of the resolution of issues at the All India level despite continuous action programmes undertaken by AIFUCTO during the year 2015, AIFUCTO gave a call of protest across the country by college and university teachers in the month of February 2016 and state level protest programme on 29<sup>th</sup> February 2016 which culminated in a massive Dharna at Jantar Mantar, New Delhi on 14<sup>th</sup> March, 2016 to press for the demands of immediate constitution of VII UGC Pay Review Committee, scrapping of API, amendment of Ph. D. regulations to end the distinction between pre-2009 regulations and post-2009 regulations Ph. D. degrees, expedite filling up thousand of vacancies on regular basis as per Govt. reservation policy, resolution of anomalies of Sixth Pay Commission, and dialogue with elected leaders of AIFUCTO and FEDCUTA on professional demands of university & college teachers of the country.

(20) The strong demonstrations at New Delhi finally succeeded in breaking the ice. On 14th March in early hours a deputation of AIFUCTO was invited for a meeting by the Minister of State for HRD which was followed by an invitation to the delegation for a meeting on the same evening with Smt. Smriti Irani, Minister for HRD to whom a memorandum of demands was submitted. Nevertheless, the solutions of major demands were not forthcoming.

(21) Surprisingly, the UGC issued U.G.C. Regulations (3rd Amendment) 2016 notified by Government of India in its Gazette on May 4, 2016 which sought to make undue increase in the workload of university and college teachers. After the AIFUCTO staged demonstrations at New Delhi, The Press Information Bureau of Government of India issued a Pres Note on 26 May, 2016 clarifying that "There will be

no increase in the workload of teachers, after the amendments, in comparison with the workload prescribed earlier”.

(22) The battle had to be continued at the all India level, since there was no development particularly in respect of the constitution of UGC Pay Review Committee even when the VII Central Pay Committee Report was already submitted and decision on the same was also taken. And therefore the AIFUCTO was required to stage demonstrations at the UGC office on 6th June, 2016. Consequently, the UGC issued a notification on 9 June, 2016 constituting the Pay Review Committee under the chairmanship of Dr. V. S. Chavhan.

(23) However, other demands remained unaddressed. And hence the AIFUCTO gave a call to the teachers throughout the country to observe a “Demand Day” on 14th July, 2016 on which day the teachers wore ‘Demands Badges’ and sent letters to UGC Chairman demanding early fulfillment of demands. This action was followed by ‘March

to Parliament’ on 5th August, 2016 which was attended by a large number of teachers which resulted in a meeting with Shri Prakash Jawadekar, Honb’le Minister for HRD who had recently assumed charge.

(24) The action, however, was required to be continued with a call of AIFUCTO to observe ‘All India Mass Casual Leave’ on the 5th October, 2016 on the eve of ‘International Teachers’ Day’ and sit on *Dharna* at the respective University Headquarters on the same day. The Pay Review Committee initially took time to start its functioning, but subsequently announced a schedule of Regional Consultative meetings throughout the country. AIFUCTO has made a detailed submission on the issue of Pay revision and other related matters to the committee on 21-09-2016. However, it remains a fact that although the committee was mandated to submit its report within 6 months of its constitution, it has failed to do so although 6 months have gone past. The AIFUCTO took a serious note of this during its 30th Academic conference held at Guwahati from 7 to 9

### PRESS RELEASE

The university and college teachers across the country are seething with discontent that the **Seventh Pay Review Committee Recommendations have not been yet made public**. It was submitted to MHRD on February 22, 2017. In the most unprecedented manner, both UGC and MHRD are not ready to share a copy of the Recommendations to AIFUCTO or FEDCUTA for review of the recommendations and changes to be effected thereafter. Such action clearly smacks off transparency in the activities of the present MHRD in giving due recognition to AIFUCTO in matters that most seriously affect the future and service conditions of the teachers. What is more alarming **while the entire Report remains unpublished bits and portions of the Recommendations are coming out at regular intervals in newspapers, clearly indicating that the confidentiality of the Report is being compromised**. This is a dangerous precedence and AIFUCTO strongly condemns the irresponsible and insensitive manner in which the entire subject has been dealt. AIFUCTO leadership also fails to understand the reasons of MHRD Minister’s apathy towards giving it an appointment despite repeatedly seeking one.

AIFUCTO expresses its serious concern on the non-release of 7th Pay Review Committee Report by the MHRD. Despite several requests of the leadership and their visits to UGC and MHRD office nothing has come out officially yet. **The entire teaching community throughout the country is desperately waiting the decision of the central government regarding the recommendations of the Pay Committee**. But unfortunately they are not being shared with the largest college and university teachers’ organization of the country, **that is AIFUCTO nor with FEDUCTA keeping the entire community in complete dark**. This would have paved the way for corrections of major anomalies in the report, if any. This is the most undemocratic attitude shown by any central government in the history of Independent India. We have repeatedly stressed in our struggles and statements that an attractive salary package and service conditions for the university and college teachers is very much necessary to attract young talents to the profession of teaching to maintain standards in quality. Again the teaching profession must

remain equivalent to other professions in terms of pay packages. On the one hand the present government is talking of global standards in higher education in the country; on the other hand it is weakening it through adhocism and neglect of the teachers. The teachers are the bedrock of any system of higher education in any country. If India wants to achieve parity with global standards in higher education, it must ensure a better service condition for its teachers.

**Despite our several requests the honourable MHRD minister has no time for a discussion on our urgent demands including the issues of the 7th Pay Review Committee Report**. This is a gross injustice to the teaching community as well as to the public-funded education system in the country. The formation of the Pay Review Committee was not a mercy on us. Rather it was the result of the continuous and consistent struggle of the university and college teachers of the country. The government is rather imposing another movement on us by not heeding to us on our genuine and legitimate demands. The President Prof. Kesab Bhattacharya and the General Secretary Prof. Arun Kumar in a press release strongly condemned the approach of the MHRD towards the problem of the college and University teachers of the country. Both the leaders cautioned the government that the teachers will be compelled to go for a nationwide movement if the approach of neglect and carelessness continues with the government. He hoped that the hon’ble minister will intervene and ensure a discussion with AIFUCTO and also the earliest release of the 7th Pay Review Committee Report.

It is to note that **National Executive Committee(NEC) meeting of AIFUCTO is scheduled to be held on 18th & 19th March,2017 at Periyar University ,Salem in Tamil Nadu, where teachers of the country will review the situations prevailing and will also decide the future course of actions**.

December, 2016 and adopted a movement resolution which states that if the 7th PRC report was not submitted by 31st January, 2017, a nation-wide agitation programme may be chalked out. The Annual Conference of AIFUCTO also held a Seminar on the topic '*Higher Education in New Education Policy*'. The Conference was attended by NUTA Secretary, the Vice-President and two other members.

#### PARTICIPATION IN ACTION PROGRAMMES

(25) In response to the call of AIFUCTO, NUTA members observed 14th July 2016 as 'Demand Day' and sent letters to UGC Chairman demanding early settlement of the problems. Then as per the call of AIFUCTO, the university and college teachers in the jurisdiction of all the three universities proceeded on 'mass casual leave' on 5th October, 2016 and sat on Dharna at the respective University headquarters between 3.00 and 5.00 making the all India action a grand success.

(26) I am happy to inform this August body that the teachers from Rashtrasant Tukdoji Maharaj Nagpur University, Sant Gadge Baba Amravati University and Gondwana University participated in large numbers in all the programmes of agitation launched by NUTA, MFUCTO and AIFUCTO and made them successful. Nevertheless, the struggle has not ended. The Association is keeping a

vigilant eye on the developments at all levels leaving nothing to chance. I have absolutely no doubt that the days to come will witness more achievements since our demands are lawful and are based on strong legal footing.

#### TASKSAHEAD

(27) Friends, it is true that some of our demands are nearing fulfillment because of the struggle of NUTA under the able leadership of MFUCTO. However, some of the old issues have remained to be resolved and in the meantime new issues have been thrown up which the teachers have to face such as introduction and approval by Legislature of 'The Maharashtra Public Universities Bill 2016' giving more thrust on nominations in the Authorities of the Universities at the cost of democratic functioning and practices and doing away with better service conditions; contractual appointments, commercialization of education, starting of self-financing courses and institutions and exploitation of teachers and non-teaching staff in the system. You are aware that NUTA is committed to taking up the problems of every section of the teaching community irrespective of their number and strength in the organization. NUTA has therefore several tasks ahead viz.

a) To secure a teacher-friendly report of the Pay Review

## PROFESSOR MOHAN SWAROOP MAHESHWARI

Prof.K.K. Thekedath

**In the passing away of Prof Mohan Swaroop Maheshwari on November 18, we have lost an all India leader of college and university teachers** who was one of the most versatile intellectuals of the leadership of the AIFUCTO. He was an enlightened, sensitive and socially committed leader with a flair for literature, the performing arts and the medium of cinema. His devotion to the cause of teachers was unflinching, and even in the worst of times, as on the occasion of the withdrawal of the 34 days long victorious all India strike of the AIFUCTO in 1987, when a section of the press and some interested parties were denigrating the leadership, **Prof Maheshwari stood the ground, and brought the entire Rajasthan unit into the AIFUCTO stream, defending the agreement.**

Prof Maheshwari had an excellent academic record, winning a gold medal at the B.Sc. in physics and again a gold medal from Pilani at the M.Sc. examination. Although he passed the joint entrance examination for the Indian Naval-Airforce officers, he did not join. Instead **he joined as a lecturer in physics at the Jaswant College, Jodhpur. He rose in the academic world from a brilliant teacher to a leader of the teachers, a member of the Senate and Executive Council of the University.** He was the President of the Rajasthan University Teachers' Association, and a Vice President of the AIFUCTO. It was here that I got to work with him and have him as a close comrade for over thirty years.

He was a strong socialist by commitment, and his interests ranged from social work, work on the front of literary groups, musicians' associations, film societies, to the trade union movements of all sections of workers. I remember that when I visited Jodhpur for his retirement function, some youth leaders from the DYFI met me in the hall and narrated to me how he had guided them and consistently helped them. **At this retirement function I heard intellectuals like Namwar Singh speak about work and his close interest in literature.** Prof Maheshwari was the President of the Rajasthan Film Society, and Vice President of the All India Film Society. His interest in films was based on an understanding of how the medium of the film could be used for social advance. An article that he wrote on films and the social issues, which we had printed in

the journal, Teachers of the World, is being reproduced in this issue of Teachers' Movement. This detailed essay shows his socialist commitment, depth and sensitivity.

**I close this brief account with a mention of an intimate gesture shown towards me by Prof Maheshwari.** After I resigned as President of the AIFUCTO in 1999, I was asked to restart and head the Editorial Board of the FISE journal '**Teachers of the World**', which had ceased publication for twelve years. We had to start from scratch. Professor Mrinmoy Bhattacharyya handed over to me a sum of Rs 10,000 and asked me to do my best. We were short of cash, since the subscription fee was only Rs 50. All of us in Mumbai working on this front were trying our best to increase the enrolment and raise some funds. One day I received a cheque for Rs 2500 from Prof Maheshwari with a brief message that this was to help me with the journal.

Prof Asok Barman, former General Secretary of the AIFUCTO also narrates a similar experience. When he became the General Secretary he took up the task of collecting funds for an AIFUCTO office in Delhi. When Prof Maheshwari came to learn about this he not only sent his own contribution but saw to it that over sixty of his colleagues in Jodhpur also sent their contributions for the AIFUCTO office. The present leaders invited him to AIFUCTO programs, but his health did not permit him to participate. He always loved to be in touch with AIFUCTO. **The present generation of teachers who draw the attractive scales of pay starting with the pay scales of IAS officers will scarcely realize that it is because of the work of leaders like Prof Maheshwari that they enjoy their present economic and academic status.**

Prof Maheshwari passed away in Mumbai where he was staying for the past few years. My wife and I visited his family immediately on hearing about this. We met his wife Dr Kaushalya, daughter Abhilasha and his brother Laxman Swaroop and conveyed to them our respect and condolences. Personally, **I gave thanks to the family on behalf of the entire teaching community, and condolences on behalf of the AIFUCTO as a former President.**

Committee and get it implemented simultaneously throughout the country with 100 percent central assistance.

b) Full and faithful implementation of the decisions of the Supreme Court and different benches of Bombay High Court in respect of several issues pertaining to working and retired teachers.

c) To ensure the release of salary for the period of 'non-cooperation in exam-related work' agitation in 2013 unlawfully withheld by the State Government.

d) To ensure immediate and faithful implementation of the Government Resolution dated 17 January, 2015 extending the benefit of pension-cum-Gratuity scheme to the teachers of Ayurved colleges and subsequent Court orders

e) Issuance of GR implementing sixth pay revision for the teachers in unaided colleges of Engineering in the state.

f) Stopping arbitrary functioning at the office of the Joint Directors.

g) Compelling the government to withdraw orders on contractual appointments and till such withdrawal to pay them the salary on par with their counterparts in Government colleges.

h) To take up the problems of engineering college teachers including the issue of withdrawal of their arrears for 55 months from 1-1-1996 to 31-7-2000.

i) Fight against anti-teacher attitude of the Government.

j) Enactment of suitable legislation for providing penalties for non-compliance of the university Grievance committee recommendations.

k) Oppose the move of the Central Government towards privatization of Pension and Gratuity and demand extending old triple benefit scheme to those appointed after 1-1-2004 as recommended by UGC.

l) Ensure that all the benefits which teachers are given under the central orders are extended to Librarians and Directors of Physical Education.

m) Faithful implementation of the central sixth pay revision 'package scheme'.

n) To take all the ongoing cases in the Courts to their logical end

**MEMBERSHIP OF NUTA**

(28) The NUTA membership has reached 5506 by the end of the year. This year the increase in membership is 21. I am glad to announce that NUTA Bulletin has completed 41st year of its purposeful existence. This year we have circulated 200 pages of NUTA Bulletin. On going through the pages of the NUTA Bulletin one finds that the Executive Committee has made an attempt to include relevant developments and documents in the Bulletin and keep the members updated about the issues concerning their professional life.

(29) I am grateful to the media and their representatives from Nagpur, Amravati and Gadchiroli areas for wide coverage of various events, programmes and the press-notes issued from time to time. This report shall not be complete unless I acknowledge the active cooperation and support of all the members of NUTA and other colleagues as well as the members of teaching profession at different levels to the activities of the Association and response given by them to various calls given by NUTA from time to time.
