**Sub:** Regarding Seventh UGC Pay Review committee Report and other educational matters concerning higher education.

**Esteemed Sir,**  
**Greetings !**

We are grateful to you for granting us this meeting to discuss the matters relating to the Seventh UGC Pay Review committee Report for university and college teachers and other connected issues concerning higher education.

In brief, we would like to draw your kind attention to the following points:

**1. Request to Share V.S. Chauhan Committee Report:** We request you to make the report of Seventh UGC Pay Review committee (Prof. V.S. Chauhan Committee) Report public and share it with AIFUCTO. We would like to inform you that the 6th & 5th UGC pay review committee (Prof. Chadha Committee & Prof. Rastogi Committee) reports were made public and discussed with AIFUCTO before finalising the recommendations by MHRD . We wish that V.S. Chauhan Committee report should be made public and AIFUCTO be given an opportunity to make its submissions if any. It will minimize the area of differences in the interest of tranquillity on campuses.

**2. 100% Central Assistance:** We request you to

**sanction 100% central assistance to the state governments for implementing the 7th PRC report so that it is implemented simultaneously and uniformly throughout the country.**

**3. Scrapping of API:** It is almost an acknowledged fact that the API has created numerous problems in the performance appraisal. As demanded earlier, the same be scrapped altogether.

**4. Addressing Anomalies of Previous Pay Scales:** It is a well established practice that after every pay scale revision, an anomaly committee is appointed to address the anomalies which are noticed in the process of implementation. Following this practice, at the time of the last UGC pay revision, anomaly committees were appointed and reports were submitted. But no implementation took place. It becomes absolutely essential that these anomalies be addressed and removed before the implementation of the 7th UGC Pay Scales.

**5. Attracting Talent to Teaching Profession:** Attracting talent to teaching profession has been a serious concern of the Government of India during last four decades. Without talented teachers, there cannot be an improvement in the quality of education. As things stand today, the quality of higher education has been severely compromised due to contractual/ad hoc appointments. Exploitative working conditions in the vast segment of the sector have further created problems. **There is an urgent need to comply with the existing UGC regulations without any further delay and ensuring that the prescribed UGC Pay Scales be made a right of each and every teacher working in the university system.**

**6. New Education Policy:** We understand that the government has decided to have a fresh look at the

education policy after the submission of the Subramanian Report. For an appropriate education policy, participation of all the stakeholders is essential. We request you to initiate an appropriate consultation process with all the stakeholders including AIFUCTO.

**7. Autonomous Colleges:** Understandably, the government intends to give a push for more autonomous colleges. Our observation is that the failed cases of this endeavour outnumber the success stories. The NAAC accreditation process has also raised many questions about the exercise. Even those colleges which are not complying with the minimum standards for the award of different degrees are getting A or A+ grade, and they are being granted autonomy which will only lead to further compromising the quality of education.

**8. Choice Based Credit System:** The concept per se seems alluring, however our system, for various reasons, is not in a position to shift to CBCS. Strangely enough the structure proposed by the UGC in CBCS does not meet even the minimum standards prescribed by *UGC (Minimum Standards of Instruction for the Grant of the First Degree through Formal Education) Regulations, 2003*. The government needs to implement the aforesaid regulation in letter and spirit to maintain the much needed improvement in the quality of higher education without which CBCS becomes a farce.

**9. Pension Scheme:** It is unfortunate that while pension scheme exists for the teachers working in aided colleges in almost all the states, some states like Punjab, Chandigarh, Himachal Pradesh, Meghalaya, Jammu & Kashmir and some sections of Madhya Pradesh stand as exceptions. We seek your intervention so that all Teachers in all states get the benefit of pension by granting 100%

additional central financial assistance to the states for revising pension. Further, subsequent to the UGC Pay Scales Revision, UGC must take steps so that pension also gets revised. Since the revised 7th CPC pension has already been implemented, also 7th pay revision for the existing teachers is under consideration, UGC must announce pension schemes for all the retired teachers in all states.

**10. Comprehensive and Affordable Health Scheme:** It is a well known fact that medical expenses in the event of serious illness is exorbitantly high. At times it goes beyond the means of the teachers. Under these circumstances we demand a **comprehensive and affordable health scheme** be implemented for the in service as well as retired teachers as early as possible all over the country.

**11. Filling up of Vacant Posts:** In order to maintain the proper quality and standard of higher education, it is necessary that all the vacant teaching posts in colleges and universities must be filled up by permanent teachers. Also the teacher - student ratio as stipulated by UGC has to be maintained in all colleges and universities. These two matters must be dealt with on priority basis.

**12. Need for Regular Interaction:** We feel that regular interaction with yourself and the Ministry is essential for improvement in the higher education system for the benefit of our next generation.

We request you to look into all these issues.

2. At the outset, it has been stated by the learned counsel for the petitioners that the question involved in this petition has already been **considered and decided vide order dated 9.5.2014 by Aurangabad Bench of this Court in the case of Smt. Savitribai Narsayya Guddapa Versus State of Maharashtra and Others in WP No.8985 of 2011** and other connected writ petitions. He submits that in the said judgment, the Division Bench has held that the cut off date i.e. **27.2.2009 prescribed in the GR dated 30.10.2009** for payment of revised pension under Maharashtra Civil Services (Pension) Rules, 1982 making it applicable to those employees who retired from 27.02.2009 and not to those employees who retired in between 1st January, 2006 to 26th February, 2009, **as unconstitutional**. In view of the aforesaid, according to the learned counsel for the petitioner, the petition seeking the very same relief regarding declaration of the said resolution dated 20.10.2009 to the extent of fixing of the cut off date, be allowed. He further prayed that the respondents be directed to re-fix petitioner's pension in accordance with Hakim Committee report.

3. We have heard learned AGP in this regard. **Learned AGP submits that the fixing of the cut off date in the said GR has since been held to be unconstitutional, the petition may be disposed of in terms of the order passed by the Division Bench in the case of Smt. Savitribai Narsayya Guddapa (supra).**

4. In view of the aforesaid, we dispose of this petition by observing that the petitioner's pension be re-fixed keeping in view the judgment passed by the Division Bench of this Court in the case of Smt.Savitribai Narsayya Guddapa (supra) and also keeping in view the Hakim Committee's report. **Let this be done within four months from the date of receipt of copy of this order.**

5. Writ Petition stands disposed of accordingly.

2. The petitioners have challenged the decision of the Managing Council of Amravati University by which recommendations of the Grievance Committee on complaint made by the respondents/employees are accepted. **The Grievance Committee directed the petitioners to pay difference of salary by calculating the salary of the respondents/employees as per Sixth Pay Commission.**

3. The Managing Council passed a resolution on 30th August, 2015 to the effect that if the Management (present petitioners) fail to implement the recommendations of the Grievance Committee, **the college should be transferred either to the teachers of the college or to any other society which is willing to administer the college.**

4. The contention of the petitioner is that it is not possible for it to run the college and pay salary of the employees as per the Sixth Pay Commission recommendations.

5. **Though the Grievance Committee of the University has made recommendations and the Management Council has accepted them, there is complete inaction on the part of the respondent No.1-University to take further steps** in the matter and the effect is that the respondent/employees who have worked in the college for more than two decades are in a lurch. There is no explanation from the respondent No.1-University why consequential steps as per the recommendations of the Grievance Committee and the resolution of the Management Council are not taken. The insensitivity of the

authorities/ officers of the respondent No.1-University and the plight of the respondent/ employees because of the inaction in the matter cannot be overlooked.

In the circumstances, following interim order is passed:

(i) **The Management i.e. Satchikatsa Prasarak Mandal, Yavatmal shall deposit an amount equivalent to the amount of arrears of salary of the respondent/ employees calculating it as per Fifth Pay Commission recommendations from the date the salary is not paid till 31st August, 2015 with the Registry of this Court till 15th June, 2017.**

(ii) **If the amount is not deposited by the Management till 15th June, 2017** the President of Satchikatsa Prasarak Mandal, Yavatmal and all the office bearers of the management shall remain present before this Court on the next date.

(iii) **The respondent No.1-University is directed to pay an amount of Rs.50,000/- (Rs. Fifty Thousand) to each of the respondent/employee** in these petitions as an interim arrangement with understanding that if steps are not taken by it as per the recommendations of the Grievance Committee and the resolution of the Management Council further orders may be passed saddling the liability on the respondent No.1-University. This amount shall be paid by the respondent No.1-University within two months.

### NOTIFICATION

### MAHARASHTRA PUBLIC UNIVERSITIES ACT, 2016.

No. MNS-2016/(347/16)/Ue-3. — Whereas section 27 of the Maharashtra Public Universities Act, 2016 empowers the State Government to specify, in consultation with the Chancellor, eligibility conditions for being elected, nominated or co-opted as member of any Authority of University ;

Now, therefore, in exercise of the powers conferred by the said section 27, the Government of Maharashtra hereby specifies that,—

1. The eligibility conditions for being **elected as a member of the Authority** specified in column 2 of the Schedule I appended hereto shall be such as is specified against the said Authority in Column 3 of that Schedule.

2. The eligibility conditions for being **nominated or co-opted as a member of the Authority** of the university specified in column 2 of Schedule II appended hereto shall be such as are specified against each of them in column 3 of that Schedule.

### SCHEDULE I

(1) Sr. No. (2) Authority and Section (3) Eligibility conditions for **being elected as member of the Authority**

#### 1. SENATE (Section 28)

##### (i) Section 28(2)(o) – **PRINCIPALS**

Elected by the Collegium of Principals from amongst themselves -

(a) Shall possess Ph.D. degree, unless appointed as a Principal before 13.10.2000.

(b) Shall be a Principal of a College which has valid Certification of Accreditation by National Assessment and Accreditation Council or National Board of Accreditation as the case may be and period of validity of such Certificate is unexpired.

(c) Shall have undertaken university examination related work for at least five years in aggregate.

##### (ii) Section 28(2)(p)- **REPRESENTATIVES OF MANAGEMENT**

Elected by the Collegium of Management Representatives of the Affiliated colleges or Institutions from amongst themselves -

(a) Shall possess Bachelors Degree,

(b) Shall be a member of Governing Body/ Management Committee of the Management for at least two years,

(c) Shall have at least one College or Institution run by such Management having valid Certification of Accreditation by National Assessment and Accreditation Council or National Board of Accreditation, as the case may be and period of validity of such Certificate is unexpired.

**RESOLUTION**

Government is pleased to decide that the rate of dearness relief with effect from 1st July, 2016 to the State Government pensioners/family pensioners on their Basic Pension/Family Pension and Dearness pension/Dearness family pension(if any) will be enhanced from 125% to 132%. The amount of Dearness relief have been paid in cash.

2. It will be the responsibility of the Pension Disbursing Authority, i.e. Pay and Accounts Officer, Mumbai/ Treasury Officers, as the case may be, to calculate the quantum of dearness relief payable in each individual case.

3. Government is also pleased to direct that above decision should, mutatis mutandis, apply to those employees including family pensioners of Recognized and Aided Educational Institutions, Non-Agricultural Universities and Affiliated Non-Government Colleges and Agricultural Universities to whom the pension scheme is made applicable.

4. In exercise of the powers conferred by the proviso to Section 248 of the Maharashtra Zilla Parishads and Panchayat Samities Act, 1961 (Mah. V of 1962) and of all the other powers enabling it in that behalf, Government is further pleased to decide that the above decision shall apply to the pensioners including family pensioners of Zilla Parishads.

5. State Government Employees who had drawn lump sum payment on absorption in a PSU/Autonomous body/ Local Bodies and have become entitled to restoration of 1/3rd commuted portion of pension as well as revision of the restored amount in terms of Government Resolution, Finance Department, No. COP1099/306/SER-4, dated 15th November 1999 will also be entitled to the payment of dearness relief on full pension as per the provisions of Government Resolution, Finance Department, No. COP-1001/50/SER-4, dated 9th April 2001, at the prescribed rate and from the date, prescribed in paragraph 1 above.

6. The expenditure on this account should be debited to the Budget Heads to which the retirement benefits of the employees mentioned in the above paras are debited and should be met from the grants sanctioned thereunder.

7. All orders in force in regard to the payment of relief on pension sanctioned by Government from time to time will, mutatis mutandis, apply to the dearness relief now sanctioned.
