विद्यापीठ अनुदान आयोगाने नेमलेल्या सातव्या वेतन पूर्नार्वलोकन समितीचा अहवाल व त्यावर विद्यापीठ अनुदान आयोगाच्या शिफारशी विचारात घेवून केंद्रीय मंत्रिमंडळाने विद्यापीठीय व महाविद्यालयीन शिक्षकांच्या संदर्भात सातव्या वेतन आयोगाशी समकक्ष वेतनश्रेण्यांच्या सुधारणेवाबतचे / पूर्नरचनेवाबतचे निर्णय घेतले असून दिनांक ११ ऑक्टोबर २०१७ रोजी केंद्रीय मानव संसाधन मंत्र्यांनी ते एका अधिकृत निवेदनाद्वारे जाहीर केलेले आहेत. केंद्र शासनाचे हे अधिकृत निवेदन "Press Information Bureau: Government of India: Ministry of Human Resource Development: Cabinet approves revised pay scales of teachers and equivalent academic staff in Universities/Colleges & centrallyfunded technical institutions" अशा मथळ्याचे असून खुद्द शिक्षणमंत्र्यांनी ११ ऑक्टोबर २०१७ रोजी सायंकाळी १९.४४ वाजता हे निर्णय अधिकृत निवेदनाद्वारे जाहीर केलेले आहेत.

- (१) विलंबाने का होईना पण याबाबतची अनिश्चितता संपुष्टात आली असून वेतनसुधारणेचे प्रस्ताव १ जानेवारी २०१६ पासून लागू होतील हे नि:संदिग्धपणे घोषित करण्यात आलेले आहे. ही समाधानाची बाब आहे.
- (२) वेतनसुधारणेच्या प्रस्तावामुळे राज्यशासनावर येणाऱ्या अतिरिक्त भाराबावत केंद्रशासनाने करावयाच्या आर्थिक भारवहनाबाबतची अनिश्चितता पूर्णपणे संपुष्टात आली ही सुद्धा अत्यंत समाधानाची बाब म्हणावी लागेल. या निवेदनाच्या शेवटच्या परिच्छेदात "The Central Government will bear the additional burden of the States on account of revision of

pay scales." असे निःसंदिग्धपणे घोषित करण्यात आले असून या वाक्यरचनेतील कोणत्याही शब्दांचे दोन अर्थ काढता येत नाहीत हे नमूद करण्यात येत आहे.

- (३) केंद्रशासनाकडून अनुदानित १०६ विद्यापीठे व महाविद्यालये तसेच राज्यशासनाकडून अनुदानित ३२९ विद्यापीठे व १२९१२ शासकीय किंवा शासन अनुदानित महाविद्यालये यातील ७.५८ लक्ष शिक्षकांना या निर्णयाचा लाभ होईल हे केंद्र शासनाच्या या अधिकृत निवेदनाच्या परिच्छेद २ मध्ये घोषित करण्यात आलेले आहे ही सुद्धा समाधानाचीच बाब आहे.
- (४) अधिकृत निवेदनातील "For the State Govt. funded institutions, the revised pay scales will require adoption by the respective State Governments." हा उल्लेख अत्यंत खेदजनक आहे. या उल्लेखामुळे या संदर्भात केंद्रशासनावर घटनेने व विद्यापीठ अनुदान आयोगावर १९५६ च्या कायद्यान्वये टाकलेली जबाबदारी केंद्र शासनाने संपूर्णपणे झटकून टाकलेली आहे. याबाबतीत बंधनकारक व्यवस्था अंमलात आणण्याचे संपूर्ण अधिकार घटनेने व कायद्याने केंद्रशासनाला दिलेले आहेत. या कायदेशीर व घटनात्मक जबाबदारीकडे केंद्रशासन दुर्लक्ष करू शकत नाही.

"Co-ordination and determination of standards in institutions for higher education or research and scientific and technical institutions." हा विषय या देशाच्या घटनेने केंद्रशासनाकडे सोपविलेला विषय आहे कारण तो घटनेच्या ७ व्या परिशिष्टातील केंद्र सूचीमध्ये ६६ व्या क्रमांकावर नमूद आहे. (Entry 66 in the Union List i.e. List I of Seventh Schedule of the Constitution of India.)

"Education, including technical education, medical education and universities," हा विषय राज्यसूचीतून काढून घटनादुरुस्तीच्या माध्यमाने समवर्ती सूचीमध्ये समाविष्ट करण्यात आलेला असल्याने यावाबतसुद्धा प्रशासनाचे व विधिविधानाचे तसेच "वंधनकारक व्यवस्था" अंमलात आणण्याचे अधिकार या देशाच्या घटनेने केंद्रशासनाकडेच सोपविलेले असतांना

- (५) आणखी एका गोष्टीचा स्पष्टपणे उल्लेख करणे आवश्यक वाटते. केंद्रीय मंत्रिमंडळाने घेतलेल्या निर्णयातील "Additional Burden" या शब्दाचा अर्थ तपशीलवार सूचना निर्गमित करतांना "80% of the Additional Burden" किंवा "50% of the Additional Burden" असा लावण्याचा प्रयत्न केंद्रीय मंत्रालयातील किंवा विद्यापीठ अनुदान आयोगातील अधिकारी करणार नाहीत याची काळजी घेणे आवश्यक आहे. तसा प्रयत्न झाल्यास देशभरातील विद्यापीठीय व महाविद्यालयीन शिक्षकांमध्ये तीव्र असंतोष निर्माण होण्यास तो कारणीभूत ठरेल. त्यामुळेच "मंत्रिमंडळाने घेतलेल्या निर्णयामध्ये अधिकाऱ्यांना बदल करता येणार नाही" हे नमूद करण्यात येत आहे. केंद्रीय मंत्रिमंडळाने घेतलेल्या निर्णयामध्ये नंतर अधिकाऱ्यांनी प्रतिकूल बदल केल्याची अनेक उदाहरणे उपलब्ध आहेत. ती सर्व नमूद करण्याची आवश्यकता नाही.
- (६) सहाव्या वेतन आयोगाशी समकक्ष वेतनश्रेण्यांबावतचे केंद्रशासनाचे निर्णय हे तत्कालीन मानव संसाधन मंत्र्यांनी दिनांक १६ डिसेंबर २००८ रोजी लोकसभेत जाहीर केले होते. त्याच्या ३ महिने अगोदर दिनांक ३ ऑक्टोबर २००८ रोजी "Report of the Committee to Review the Pay Scales and Service Conditions of University and College Teachers, 2008" हा जाहीर करण्यात आला होता. सातव्या PRC चा अहवाल अजूनही जाहीर केला जात नाही, ही अत्यंत खेदजनक बाब आहे.

Friends, Greetings.

I feel glad that the central government announced and decided that it would implement the recommendations of the Seventh UGC Pay Scales with effect from January 1, 2016, thereby benefitting more than eight lakh university and college teachers of the country. So much for the time being and nothing more has been revealed from the government side. We wait anxiously to go through the entire content of the Prof. Chouhan Committee recommendations and cabinet decisions. I take the opportunity to congratulate all the teachers of the country who stood firmly with AIFUCTO in the past months in its various programmes at state and national level to voice their resentment and unhappiness on the delay and implementation of the 7PRC. In these difficult times teachers'solidarity reached unprecedented heights and it is because of the unrelenting yet peaceful and democratic agitations that the government finally came out with its decision. We are indeed thankful to the Minister, HRD for keeping his promise about the publication and implementation of the Report, albeit rather delayed.it is no doubt a moment of great victory for the teachers' movement.

At the same time we cannot allow self-satisfaction **to set in.** We are yet to know about the recommendations of the Prof. Chouhan Committee Report, which as you are aware even after repeated requests MHRD has not made public or shared its content with AIFUCTO or any teachers' body, an action that actually broke all earlier **precedence.** Such deliberate move to keep the content of the Report under covers is not a healthy signal and AIFUCTO has apprehensions that the government is trying to negotiate the recommendations as per its conveniences. It is therefore extremely important we remain restraint and not carried away by the euphoria of a pay scale revision. Our emotions are to be held in check because a pay hike under severely compromised situation is not what we are demanding. We cannot allow the dignity of our profession to be defamed and make public funded higher education of India a victim of heinous designs of the central government. It is our earnest appeal to our teacher friends that they should wait patiently for some days to evaluate the recommendations and to what extent the government is willing to cooperate. We must see if the government has decided concretely on the service conditions, pay scale and other facilities for the ad hoc, part time and contractual teachers. We hope that complete notification from MHRD will be made available after Diwali and other festivals, following which AIFUCTO if necessary will convene a meeting to discuss the same.

#### **NEC MEETING OCTOBER 8, 2017:**

Meanwhile an important meeting of National Executive Committee (NEC) of AIFUCTO was held on October 8, 2017 at Hindi Bhawan, New Delhi.Before NEC secretariat met to discuss the issues to be taken in NEC. Most of the state teacher leaders, national secretaries, office bearers and many veteran leaders of AIFUCTO attended the NEC meeting and expressed their opinions on the future course of actions. Prof.Kesab Battacharya, President, AIFUCTO presided over the meeting. Dr. Arun Kumar, General Secretary, AIFUCTO appraised the members of continuous agitation programs under taken by AIFUCTO in the preceding months. The NEC, AIFUCTO expressed deep resentment about the indifferent and undemocratic attitude of HRD ministry and Central Government towards the needs of the teachers. The NEC felt that the Government is compelling the teaching community of India to resort to agitation to get their rightful demands fulfilled. After prolonged discussion, NEC unanimously took the following decisions:

1.Oneweek non-cooperation by teachers at unit level (From 13th to 18th November,2017): Teachers in colleges and universities will not cooperate with the administration. On November15, teachers of every college and university unit will sit in Dharna and they will also observe Pen down/Chalk down programme (No teaching or any other type of work). If any urgent examination work, teachers will wear black badges to exhibit their protest during their examination duty.

Cabinet approves revised pay scales of teachers and equivalent academic staff in Universities/ Colleges & centrallyfunded technical institutions

The Union Cabinet chaired by the Prime Minister Narendra Modi has given its approval for revision of pay scales for about 8 lakh teachers and other equivalent academic staff in higher educational institutions under the purview of the University Grants Commission (UGC) and in Centrally Funded Technical Institutions, following implementation of the recommendations of the 7th Central Pay Commission for Central Government employees.

The decision will benefit 7.58 lakh teachers and equivalent academic staff in the 106 Universities / Colleges which are funded by the UGC/MHRD and also 329 Universities which are funded by State Governments and 12,912 Govt. and private aided colleges affiliated to State Public Universities.

In addition, the revised pay package will cover teachers of 119 Centrally Funded Technical Institutions viz. IITs, IISc, IIMs, IISERs, IIITs, NITIE. etc.

The approved pay scales would be applicable from 1.1.2016. The annual Central financial liability on account of this measure would be about Rs. 9,800 crore.

The implementation of this pay revision will enhance the teachers' pay in the range of Rs. 10,400 and Rs. 49,800 as against the extant entry pay due to the implementation of the 6th Central Pay Commission for the pay of teachers. This revision would register an entry pay growth in the range of 22% to 28%.

For the State Govt. funded institutions, the revised pay scales will require adoption by the respective State Governments. The Central Government will bear the additional burden of the States on account of revision of pay scales. The measures proposed in the revised pay structure are expected to improve quality of higher education and also attract and retain talent.

- 2. On November 30, 2017 university and college teachers will demonstrate mass Dharna and stage protest programme at every university head quarter across the country. Teacher leaders will submit a memorandum to the Vice-chancellor.
- 3. On December 11,2017 a one-day Cease Work programme along with a protest Dharna at every state capital will be observed.

After Diwali and Chhath festivals, getting full notification and going thoroughly ,AIFUCTO will convene a meeting of its office bearers and NEC members for final consent.

In the event of Government inaction towards fulfilling our demands, AIFUCTO will decide on the future course of action including indefinite strike. This decision will be finalised in AIFUCTO Statutory Conference scheduled to be held from 18-20th Dec,2017 at Shridi in Maharashtra.

Read - 1. Government Resolution No.: DRP-2017/C.R 59/SER-4, Date 24.04.2017

#### RESOLUTION

Government is pleased to decide that the rate of dearness relief with effect from 1st January, 2017 will be enhanced from 132% to 136% to the State Government pensioners /family pensioners on their Basic Pension/Family Pension and Dearness pension/Dearness family pension (if any). And dearness relief will be payable in cash from 1st August, 2017.

- 2. It will be the responsibility of the Pension Disbursing Authority, i.e. Pay and accounts Officer, Mumbai/Treasury Officers, as the case may be, to calculate the quantum of dearness relief payable in each individual case.
- 3. Government is also pleased to direct that above decision should mutatis mutandis, apply to those pensioners including family pensioners of Recognised and Aided Educational Institutions, Non-Agricultural Universities and Affiliated Non Government colleges and Agricultural Universities to whom the pension scheme is made applicable.
- 4. In exercise of the powers conferred by the proviso to Section 248 of the Maharashtra Zilla Parishads and Panchayat Samities Act, 1961 (Mah.V of 1962) and of all the other powers enabling it in that behalf, Government is further pleased to decide that the above decision shall apply to the pensioners including family pensioners of Zilla Parishads.
- 5. State Government Employees who had drawn lumpsum payment on absorption in a PSU/Autonomous body/local Bodies and have become entitled to restoration of 1/3rd commuted portion of pension as well as revision of the restored amount in terms of Government Resolution, Finance Department, No.COP1099/306/SER-4, dated 9th April 2001, at the prescribed rate and from the date, prescribed in paragraph 1 above.
- 6. The expenditure on this account should be debited to the Budget Heads to which the retirement benefits of the employees mentioned in the above paras are debited and should be met form the grants sanctioned thereunder.
- 7. All orders in force in regard to the payment of relief on pension sanctioned by Government form time to time will, mutatis mutandis, apply to the dearness relief now sanctioned.
