एक: रजत जयंती विशेषांक मालिकेमध्ये त्या २५ वर्षात उपलब्ध असलेली माहिती प्रकाशित करण्यात आलेली होती. ती माहिती अद्ययावत करण्यासाठीचे विशेषांक हा सुवर्ण महोत्सवी विशेषांक मालिकेचा एक महत्त्वाचा भाग असेल. उदा. 'नुटा बुलेटीन अनुक्रमणिका विशेषांक' (Index to the Contents of NUTA Bulletin 1976-2000) या मथळ्याखाली प्रकाशित करण्यात आलेल्या विशेषांकाला अद्ययावत करणारा विशेषांक (किंवा वार्षिक अहवालाचे एकत्रित संकलन - "Our Secretary's Reports" पृष्ठ १५३ ते २०४ (२०१३)) त्या २५ वर्षातील माहिती त्या विशेषांकातून प्रकाशित करण्यात आली होती. अशा प्रकारची माहिती पन्नासाव्या वर्षापर्यंत अद्ययावत करणारे हे विशेषांक असतील.

दोन: व्यावसायिक जीवनाशी संबंधित प्रश्नांवरील विशेषांक: विद्यापीठीय व महाविद्यालयीन शिक्षकांच्या व्यावसायिक जीवनाशी संबंधित असलेल्या अनेक प्रश्नांच्या वावतीत नुटा बुलेटीनचे विशेषांक यापूर्वी प्रकाशित करण्यात आलेले आहेत. उदा. तीन: विधिमय मार्गाने प्रश्न सुटू शकतात यांची माहिती देणारे विशेषांक : गेल्या काही वर्षामध्ये असे आढळून आलेले आहे की, संचालक, सहसंचालक उच्च शिक्षण विभाग व खुह उच्च शिक्षण विभाग यामध्ये लाचलुचपतीची प्रकरणे फार मोठ्या प्रमाणात वाढलेली आहेत. प्रत्यक्ष लाचलुचपत करतांना भ्रष्टाचार प्रतिबंधक विभागाने पकडलेल्या अधिकाऱ्यांची संख्या ही डोळ्यात भरण्यासारखी असली तरी न पकडल्या गेलेल्या अधिकाऱ्यांची संख्या सुद्धा वरीच मोठी आहे. अशा परिस्थितीमध्ये भ्रष्टाचारी मार्गाचा वापर न करता निर्धारपूर्वक विधिमय मार्गानेच आपला प्रश्न सुटला पाहिजे यासाठी कष्टपूर्वक प्रयत्न करणाऱ्या शिक्षकांची संख्या सुद्धा आज अभिमान वाटावा अशी आहे. संघटनेने सुद्धा याबाबतीत ठामपणे धोरणात्मक निर्णय घेतले असून त्याची दृढतापूर्वक अंमलबजावणी करण्यात येत आहे. विधिमय मार्गाने सुटलेल्या अशा प्रश्नांविषयीचे विशेषांक प्रकाशित करणे हा नुटा बुलेटीन सुवर्ण महोत्सवी विशेषांक मालिकेचा एक महत्त्वाचा भाग असेल.

चार : न्यायालयीन संघर्षातून सुटलेले प्रश्न : विधिमय मार्गाने प्रश्न सोडविण्याचा निर्धार केलेल्या संघटनांसाठी व शिक्षकांसाठी न्यायालयीन संघर्ष हा एक या देशाच्या घटनेने उपलब्ध करून दिलेला विधिमय मार्ग होय. या मार्गाने सुद्धा अनेक प्रश्न सुटल्याचे, सुटत असल्याचे आपल्याला दिसून येते.

अशा प्रकारच्या विषयाचे विशेषांक प्रकाशित करणे हा सुवर्ण महोत्सवी विशेषांक मालिकेचा एक महत्त्वाचा भाग असेल.

पाच : लोकांच्या प्रश्नांसाठी संघटनेने केलेल्या प्रयत्नांबाबतचे विशेषांक : शिक्षकांच्या कोणत्याही प्रश्नाकडे अजिबात दुर्लक्ष होणार नाही याची काळजी घेत संघटनेन व संघटनेच्या प्रतिनिधींनी लोकांचे प्रश्न सोडविण्यासाठी सभागृहात व संघटनेने सभागृहाच्या बाहेर केलेली कामिगरी हा संघटनेच्या कामाचा फार मोठा भाग राहिलेला आहे. पाणी पुरवठचाचे प्रश्न, सिंचन प्रकल्पाचे प्रश्न, तसेच अनुशेष निर्मूलनासाठीचे प्रयत्न, याबाबतीत अनेक विशेषांक यापूर्वी संघटनेने काढलेले आहेत व तत्सम प्रश्नांचे विशेषांक या सुवर्ण महोत्सवी विशेषांक मालिकेचा एक महत्त्वाचा भाग असावा असे ठरविण्यात येत आहे.

सहा : कार्यकारी मंडळ किंवा अध्यक्ष व सचिव निर्णय घेतील अशा विषयावरील विशेषांक.

५. विशेषांक मालिकेच्या प्रकाशनासाठीच्या अर्थबळ उभारणीचा प्रश्न : अशा प्रकारच्या विशेषांक मालिकेच्या प्रकाशनामध्ये फार मोठ्या अर्थबळाची गरज असते.

- (i) रजत जयंती महोत्सवी विशेषांक मालिकेच्या प्रकाशनाच्यावेळी प्रत्येक शिक्षकाने आपला अल्पसा स्वेच्छाधीन सहभाग त्यावेळेला या कामासाठी उपलब्ध करून दिला होता. त्यासाठी संघटनेच्या पदाधिकाऱ्यांनी प्रत्येक तालुक्याच्या ठिकाणी दौऱ्यांचे आयोजन केले होते व अशा स्वेच्छाधीन सहभागाची विनंती करून अर्थवळ उभे केले होते. असा स्वेच्छाधीन सहभाग देणाऱ्या शिक्षकांची नावे त्यावेळेला नुटा बुलेटीनमध्ये प्रकाशित करण्यात आली होती. सुवर्ण महोत्सवी विशेषांक मालिकेसाठी सुद्धा किमान दोन हजार रुपयांचा (२०००/- रूपये) स्वेच्छाधीन सहभाग शिक्षकांनी द्यावा अशी विनंती करण्याचा निर्णय घेण्यात रोज आहे
- (ii) विधिमय मार्गाचा वापर करून ज्या व्यक्तींचे प्रश्न सुटलेले आहेत त्यांनी असा विशेषांक प्रकाशित करण्यासाठीच्या अर्थबळ उभारणीमध्ये स्वेच्छाधीन सहभाग द्यावा अशी विनंती करण्याचा निर्णय सुद्धा घेण्यात येत आहे.
- (iii) पाणी पुरवठ्याचे प्रश्न, सिंचन प्रकल्पांचे प्रश्न व अनुशेष निर्मूलनासाठीचे प्रश्न याबावतीत विशेषांक काढण्यासाठी त्या त्या वेळेला जाहिरातीच्या माध्यमातून अर्थबळ उभे करण्यात आलेले होते. आता यावेळी सुवर्ण महोत्सवी विशेष मालिकेच्या प्रकाशनासाठीसुद्धा जाहिरातीच्या माध्यमातून निधी गोळा करण्याचा प्रयत्न करण्याचा निर्णय घेण्यात येत आहे.
- **६**. प्रत्येक कॅलेंडर वर्षाच्या पहिल्या दिवसापासून तर शेवटच्या दिवसापर्यंत प्रकाशित करण्यात आलेल्या नुटा बुलेटीनच्या पृष्ठांना एकामागून एकचे पृष्ठ क्रमांक देण्याची व त्या वर्षाच्या शेवटी त्याची अनुक्रमणिका प्रसिद्ध करण्याची पद्धती अगदी पहिल्या वर्षापासून स्वीकारण्यात आली असून आजपर्यंत या पद्धतीचे काटेकोरपणे पालन करण्यात येत आहे. सन २०१५-२०१६ च्या दरम्यान याबावतीत उत्साह वाढविणारा एक महत्त्वाचा टप्पा म्हणजे www.nuta.in या संकेतस्थळाची स्थापना होय. या संकेतस्थळामुळे नुटा बुलेटीनमधील मजकुराची संदर्भ सुलभता वाढली असून सबंध महाराष्ट्रभर कोठेही क्षणार्धात संदर्भ मजकूर उपलब्ध होणे सुलभ झाले आहे. या संकेतस्थळाची स्थापना करण्यात अध्यक्ष डॉ.प्रवीण रघुवंशी व विद्यमान कार्यकारी मंडळाने जो पुढाकार घेतला त्यावद्दल हे सभागृह मनापासून समाधान व्यक्त करीत आहे व सुवर्ण महोत्सवी वर्षाच्या निमित्ताने या संकेतस्थळाची मजबुतीने जोपासना करण्याचा निर्धार व्यक्त करीत आहे.

SECRETARY'S REPORT OF THE WORKING OF THE ASSOCIATION FOR THE YEAR ENDING ON 31st DECEMBER 2023

Prepared by the Executive Committee of NUTA under Article VI (b) (ii) of the Constitution of NUTA and Presented by the Secretary on behalf of the NUTA Executive Committee

Dear friends.

- 1. It gives me great pleasure to extend warm welcome to you on behalf of the Executive Committee of NUTA and on my personal behalf too. It is indeed a proud privilege to place before this august body a brief account of the activities and achievements during the year 2023.
- 2. Right from its commencement, NUTA has been committed to the welfare of the teaching community and their professional betterment. In keeping with the commitment, the association took up several issues concerning the teaching community during the period of this report which witnessed significant developments and had some major achievements. This particular year was again the year of continuous struggle for major issues.

3. Sad Demise of Prof. Mrinmay Bhattacharyya.

I am pained to mention here that the Godfather of University/ College teachers in the country, AIFUCTO former General Secretary Prof. Mrinmay Bhattacharyya passed away on 21 st November 2023. In the history of AIFUCTO, he was the only person to work as a General Secretary of AIFUCTO for a record break period of almost 20 years, i.e. from 1980 to 1999. He was a great leader, for he strived very hard to streamline the working of AIFUCTO by roaming throughout the nation to make the organisation strong. He started the AIFUCTO bulletin "Teachers Movement" for which he appealed the teachers to subscribe it and become a member of AIFUCTO, through which he raised the funds to run the organisation. I feel very proud about him that he led two nationwide agitation programs for 4 th & 5 th pay revision. He had very tactfully used his political relations for the organisation, but he never imposed his political ideology on the organisation. His life, from his very childhood was full of struggles and hardships. This made him a seasoned leader and a great visionary, which benefitted the organisation. He was bestowed by the "Friends of Liberation War Honour Award" on 24 th March 2013, by the Republic of Bangladesh, for his contribution along with other Indians for the liberation of Bangladesh. The sad demise of Prof. Mrinmay Bhattacharyya is a great loss for the whole teacher's fraternity. I would like to pay homage to Prof. Mrinmay Bhattacharyya by quoting his own lines from his autobiography 'Never Give Up': "A window opens up when all doors are closed".

4. "Consistency of Indecent Act of the Secretary Higher Education and Director Higher Education towards the decision of the Hon'ble High Court and Supreme Court in the year 2023 too".

It is well settled position of Law that if any decision given by

- 1. Any proposal before the meeting may be amended
 - (a) by leaving out a word or words or
- **(b)** by leaving out a word or words in order to add or insert a word or words or
- (c) by adding or inserting a word or | words.
 - 2. An amendment to be in order shall:
- (a) not constitute a direct negative to the original resolution:
- **(b)** be relevent to and within the scope of the resolution to which it is moved.

the Hon'ble High Court or Hon'ble Supreme Court is not challenged in upper court then it becomes the Law. But these two officers of Higher Education are not ready to understand the court order and issued the orders which differ from the court order.

5. CAS for M.Phil. degree holders: "Before July 2009, the teachers who have acquired the M.Phil. degree, such teachers has to be given all other benefits along with the CAS from the first day of his appointment". Such orders were passed by the Hon'ble High Court and the same decision was upheld by the Hon'ble Supreme Court. The Director, Higher Education in meeting with the MFUCTO delegation on 20 th October 2023, was apprised with the above court orders, which he understood positively. He issued an order: "The teachers who acquired M.Phil. degree in service, are entitled for the benefit of promotion under CAS from the date of holding the said qualification. The Deputy Secretary Higher Education was of the view that the Director Higher Education has made a mistake in the above said order. In order to correct the orders issued by the Director, the Deputy Secretary Higher Education ministry issued fresh order on 30 th November 2023 in which it was mentioned "If the teacher has acquired M.Phil. degree in service, then taking into consideration the exemption given by the UGC, he will be entitled for the benefit of promotion under CAS, from the date on which the concerned teacher was exempted from passing the NET/SET examination".

Now, while issuing these orders, the Director Higher Education and the Deputy Secretary Higher Education both had categorically ignored the exact sense of the order of the Hon'ble High Court and Supreme Court and again issued improper orders.

6. Composite scheme of UGC Regulations 2018:

The Hon'ble Supreme Court has recently passed an order regarding the violations of the UGC Regulations 2018 by the State Government of Gujarat regarding the appointments of the Vice Chancellor and Pro-Vice Chancellor. In para 15 of the Hon'ble Supreme Court order it has been mentioned that, "UGC Regulations becomes part of the Act. In case of any conflict between State Legislation and Central Legislation, Central Legislation shall prevail by applying the rule/principle of repugnancy as enunciated in Article 254 of the Constitution as the subject 'education' is in the Concurent List (List III) of the Seventh Schedule of the Constitution." The Hon'ble Supreme Court has also held that the eligibility criteria and appointment of Vice Chancellor shall always be as per the relevant UGC Regulations and the State Act if not on a par with the UGC Regulations must be amended to bring it on a par with the applicable UGC Regulations and until then it is the applicable UGC Regulations that shall prevail. In accordance with the above orders of the Hon'ble Supreme Court, Vice Chancellors from the state of Gujrat and Kerala were removed by their respective Governors. In accordance with the above orders of the Hon'ble Supreme Court, the Governor of the State Maharashtra had issued the Ordinance regarding the appointments of the Vice Chancellor and Pro-Vice Chancellor in the State of Maharashtra,

which is also published in the Maharashtra Government Gazette on 11 th January 2023. (Maharashtra Act No. VI of 2023). The Government Resolutions issued by the Department of Higher and Technical Education, Maharashtra Government on 8 th March 2019, for implementing the UGC Regulations 2018 are in contradiction with the provisions made in UGC Regulations 2018. Only two provisions of the UGC Regulations were accepted by the Maharashtra Government by changing University Act. When the provisions of the UGC Regulations were not fully accepted, then the Government Resolution dated 8 th March 2019 cannot be at par with the UGC Regulations and hence needs to be corrected. This responsibility of correction in GR lies with the Secretary Higher Education and Director Higher Education. But the same has not been done yet. These two cases (Para 5& 6) have been cited here only as examples of indecent acts of the government officers.

7. Status of High Court/Supreme Court Cases

Special Leave Petition (SLP) and Interim Application (I.A.) in Supreme Court about NET/SET-affected Teachers

The non-NET/SET teachers appointed between 1992 and 2000 are in the Supreme Court. The SLPs have been filed to get CAS benefits from the date of appointment and an Interim Application has been filed seeking implementation of the Supreme Court Interim Order issued in Asha Bidkar and others case, to this group of teachers. The compliance of the Supreme Court Registrar was made in respect of application filed by the

group of organizations and AORs were informed for mentioning of the matters and the matter was listed and heard on 27 th April 2022 and the court granted four weeks time to the Government of Maharashtra to submit reply/written notes of arguments. After that the matter was not listed for hearing in the year 2022. These matter were called up on hearing on 01.02.2023 and learned counsel for the parties were ordered to submit joint compilation Mr. Amol N. Suryawanshi, Ms. Aparna Bhat, learned Advocateon record and the standing counsel for state will be the nodal counsels for completion of the house keeping task. Matter was listed for direction on 01.03.2023 but it was heard on 18.08.2023 and next date was given for direction on 18.09.2023. Matter was heard on 18.09.2023 and order was passed: "Despite nodal counsels being appointed for completion of the house keeping task, the issue as to what should be the compilation has still not been resolved. When both the parties sign the memo that the compilation is ready, then Registry will list the matter for directions in 'miscellaneous matter'. Till the end of year 2023, single compilation was not submitted as per record of our

8. VII Pay Revision to Teachers in Social Work Colleges

A meeting of Social Work College teachers was organized at Shikshak Bhawan, Amravati on 3rd January 2021 wherein it was unanimously decided to approach the Hon'ble High Court with a prayer clause to issue directions to the State Government to issue a GR regarding VII Pay Revision for Social Work College teachers. Accordingly, WP No. 2229 of 2021 was filed in the

High Court at Nagpur Bench. The hearing was conducted through video conferencing. Notice was issued to the Government authorities for explanation. As the Government of Maharashtra had nothing to defend, it issued a GR No. Sakam 2019/C.R.81/Samasu dated 22 nd October 2021 making applicable VII Pay Revision to the teaching and non-teaching staff of Social Work Colleges. But this GR too has certain anomalies. As the Government of Maharashtra has not filed any reply till date, the case is still pending in the High Court at Nagpur Bench.

9. One Notional Increment for the Pensionary Benefit if the Retirement was on 30 th June

The CAT decision challenged in Madras High Court in WP No. 15732/2017 came to be decided on 15 th September 2017 thus: "the petitioner shall be given one notional increment for the period from 01.07.2012 to 30.06.2013 as he has completed one full year service though his increment fell on 01.07.2013 for the purpose of pensionary benefits and not for any other purpose". The Central Government had filed an SLP in Supreme Court (SLP No. Civil) Diary No. 22283/2018 on 23 rd July 2018. The said SLP came to be dismissed. Further, the Central Government went on to file a Review Petition 1713/2019 in SLP (C) No. 22008/2018 which also was dismissed on merits.

10. Accordingly an employee retiring on 30 th June is entitled for one notional increment for pensionary benefit. On 8 th March 2020, twenty-one teachers of NUTA came together to file WP vide Stamp. No. 5586/2020 in the High Court Bench at Nagpur. On 14 th October 2021, the Hon'ble High Court directed the Advocate on Record to issue notices to the parties concerned regarding their stand and explanation within four weeks of time. Final hearing in this matter (WP.NO.1537/2021) was held on 22 nd September 2022 and the order was passed in favor of petitioners as per the prayer clause. But department of Higher Education Maharashtra state did not implement the High court order. Hence, notice was issued by the advocate on 4th January 2023. Finally Department of Higher Education, Maharashtra State issued order on 16 th January 2023 and accordingly Director/Joint Director, Higher Education, issued the order of

implementation on 17 th and 19 th January 2023 respectively.

11. Ph.D./M.Phil. Increments Case WP No. 4618 of 2021

Nagpur University Teachers Association have filed a civil WP No. 4618 of 2021 seeking incentive in the form of advance increments for teachers with M. Phil./Ph.D. as per the UGC notification dated 18.07.2018 from the date of appointment/award. The case came for hearing before the Hon'ble Judges Sunil B. Shukre and Anil I. Pansare on 18 th November 2021 wherein the Hon'ble Court issued notices to the parties concerned demanding explanation. Reply from the Government of Maharashtra was received on 19 December 2022. UGC reply is awaited, matter has not come on circulation in the year 2023 even after our counsel mentioning it two times.

12. WP No. 3052 of 2016 (Regarding teachers who retired before 01.01.2006)

This WP No. 3052 of 2016 was filed on 19 th March 2016 regarding the fixation of the pay of the lecturers in the Selection Grade/ Readers scale prior to 01.01.2006 who were entitled for revised pension; in no case shall be lower than fifty percent of the sum in the pay band and grade pay. Nine similar cases came to be clubbed together and few hearings have taken place. The last hearing took place on 22 nd July 2021. Due to the outbreak of Covid-19, physical hearings could not take place in the matter. The matter came for hearing before the Hon'ble Judges Anil I. Pansare and Rohit Dev. After continuous hearing, the matter was closed for judgment on 30 th August 2022, but now treated as not-part heard on 16.10.2023 State Government has sought time to engage senior counsel.

13. WP No. 3817 (Contempt Petition 71 Days' Salary)

NUTA filed a contempt petition at the Nagpur Bench of Bombay High Court (WP.No.3817) as per MFUCTO resolution on 8 th May 2022. On 13 th July 2022 the matter was kept for hearing and notices were issued to respondent Nos. 1 to 3 returnable in four weeks. Reply has not been submitted by respondents till date.

- (c) To ensure faithful implementation of UGC Regulations 2018 published in the Gazette of India on 18th July 2018 as a composite scheme in the State of Maharashtra.
- (d) To bring awareness among all the stakeholders about the National Education Policy 2020.
- (e) To fight for filling up all the vacancies of Teaching and Non-teaching posts on regular basis.
- (f) To make the State Government frame a well-regulated salary scheme for disbursement of salary to employees in professional institutes as per the Supreme Court judgment dated January 5, 2017.
- (g) To take initiatives to protect the democratic functioning of the universities and to fight for issuing ordinance so as to reduce nominations on authorities in order to protect the autonomy of the universities in the State
- **(h)** To work for stopping arbitrary functioning at the offices of the Joint Director and Director of Higher Education.
- (i) To compel the State Government to withdraw orders on contractual appointments, and till such withdrawal, to pay them the salary on par with their counterparts in Government colleges.
- (j) To ensure enactment of suitable legislation for providing penalties for noncompliance of the University Grievance Committee given recommendations.
- (k) To ensure all the benefits given to teachers under the central orders are extended to Librarians and Directors of Physical Education.
- (I) To work for urgent lifting of financial blockade in the matter of granting research projects and Faculty Development Programs.

19. Membership of NUTA

The membership of NUTA has reached 6306 by the end of the year 2023. This year the increase in membership is 57. I am glad to announce that NUTA Bulletin has completed 48th year of purposeful existence. This year we have circulated 188 pages NUTA Bulletin.

20. I am very much thankful to media and their representatives from Nagpur, Amravati and Gadchiroli areas for wide coverage of various events, programs and press notes issued from time to time. This report shall not be complete unless I acknowledge the active co-operation and the support of all members of NUTA and other colleagues as well as other members of the teaching profession at different levels to the activities of the Association, and the response given by them to various calls given by NUTA from time to time.

IN THE HIGH COURT OF JUDICATURE AT BOMBAY: NAGPUR BENCH: NAGPUR WRIT PETITION NO. 814 OF 2023

(VANMALA WD/O GAUTAM SHAMBHARKAR AND OTHERS VS. THE STATE OF MAHARASHTRA, THROUGH, SECRETARY, HIGHER AND TECHNICAL EDUCATION DEPARTMENT, MANTRALAYA, MUMBAI AND OTHERS) Shri Naquid Z. Mirza, Advocate for Petitioners. Shri A.M. Ghogre, A.G.P. for Respondent Nos. 1 & 2/State.

- 1. This writ petition takes exception to the denial of family pension in favour of the petitioners in view of the Government Resolution dated 29/10/2021.
- 2. It is the case of the petitioners that the husband of the petitioner No. 1 and father of the petitioner Nos. 2 and 3 was a full time approved Lecturer appointed by following due selection process at respondent No.3 and he died on 30/05/2021.
- 3. Thereupon, the petitioners claimed family pension which came to be denied on the ground that firstly, he was not possessing the required education qualification and the another ground that the appointment was made on 02/08/2000 and not between 23/10/1992 to 03/04/2000, as stipulated in Clause 16 of the Government Resolution dated 27/06/2013.
- 4. The learned Counsel for the petitioners has pointed out that the present case is covered by the judgment dated 05/02/2024, passed in Writ Petition No. 10170/2021 of the Co-ordinate Bench of this Court in similar matter, whereby it is directed to the Authorities to sanction the family pension and other retirement benefits.
- 5. In the said matter before the Coordinate Bench, the deceased was appointed on 09/03/2002 i.e. beyond the cut-off date i.e. 03/04/2000 and in that matter also the objection was raised to the initial appointment of the deceased. This Court while dealing with the said submissions has observed thus:
- "6. At the outset we would like to say that the decisions which have been relied on by the learned Advocate for the petitioner contended different set of facts. In those petitions the appointment of the petitioners therein was prior to 23rd October 1992 and therefore, it was held that they were covered by University Grants Commission Resolution dated 19th September 1991 which came to be implemented in the State on 30th October 1992. here the facts are already stated, however to recapture, it can be said that the appointment of

- the deceased was on 9th March 2002. The approval was granted by the University on 24th August 2006 which was subject to passing of NET/SET Examination and it was temporary approval. The deceased completed his M.Phil on 3rd August 2009 and he was awarded Ph.D. on 14th October 2017. Thereafter the institute wherein the deceased was serving i.e. respondent No.6 had forwarded proposal to grant permanency to the deceased, which came to be approved by the University on 13th December 2017. Entry was taken in his service book to that effect. Now, it is to be noted that there is a presumption that when University grants approval to the permanency then it has considered all the requirements /rules /regulations. The said approval granted by the University was never challenged by anybody. Unfortunately, the deceased expired on 26th May 2021. Now the petitioners cannot be asked to answer the deficiencies.
- 8. At the cost of repetition, we are saying that it is since the University has granted approval, who was required to consider whether the appointment was proper or not and the Government cannot raise objection to that effect at a later stage; we are constrained allowed the petition, Accordingly, the Writ Petition is allowed."
- 6. Since we are agreeable with the view taken by the Co-ordinate Bench in the above referred matter, we pass the following order .

The writ petition is disposed of and it is held that petitioner No.1 would be entitled for pension and pensionary benefits. The respondents shall consider the case of the petitioners for pensionary benefits and shall not refuse to grant pensionary benefits to them on the ground that the deceased had not possessed the necessary qualification. Therefore, we set aside the order dated 09/ 06/2022 issued by respondent No.2. Respondent Nos.1 to 3 to process and sanction the family pension and other retirement benefits to petitioners in consonance with the rules regulations, expeditiously and preferably within a period of FOUR MONTHS from the date of this order. It should also include the arrears, if any.
